**An Act Concerning Implementation Of The Approved Settlement Agreement In The Connecticut Hospital Association Et Al. V. Connecticut Department Of Social Services Et Al. And Making Appropriations Therefor**

Good afternoon. My name is Jennifer Jackson, and I am the President and CEO of the Connecticut Hospital Association. Thank you for having me here today to discuss the hospital settlement agreement and its implementation language in **An Act Concerning Implementation of the Approved Settlement Agreement in the Connecticut Hospital Association et al. V. Connecticut Department of Social Services et al.**

I want to begin by thanking bipartisan legislative leaders and legislators for your ongoing commitment to hospitals and healthcare in Connecticut.
