



## Incumbent Worker Training by the Numbers

In 2011-12 the five state Workforce Investment Boards provided Incumbent Worker Training to **2,011** employees in partnership with **98** employers. The WIBs allocated a combined total of **\$524,421** for the program which was supplemented by **\$1,152,835** in total employer contributions.

**North Central region:** Capital Workforce Partners' allocation was \$156,914. The contributions made by the 21 employers totaled \$156,914 and, with that, 479 employees were trained.

**Northwest region:** Northwest Regional Investment Board allocation was \$120,312. The contributions made by the 15 employers totaled \$231,066 and, with that, 521 employees were trained.

**Southwest region:** The WorkPlace, Inc.'s allocation was \$82,835. The contributions made by the 6 employers totaled \$332,394 and, with that, 386 employees were trained.

**South Central region:** Workforce Alliance's allocation was \$88,360. The contributions made by the 7 employers totaled \$96,000 and, with that, 67 employees were trained.

Employer partners were: Futire Industries, Harco Labs, East Shore Adult Day Care, Pennsylvania Globe, Masonicare, Milford Fabricating, and Ulbrich.

**Eastern region:** Eastern CT Workforce Investment Boards' allocation was \$76,000. The contributions made by the 49 employers totaled \$336,461 and, with that 558 employees were trained.
