# Channel Codes for Relayless Networks with General Message Access Structure

## Abstract

Channel codes for relayless networks with the general message access structure is introduced. It is shown that the multi-letter characterized capacity region of this network is achievable with this code. The capacity region is characterized in terms of entropy functions and provides an alternative to the regions introduced by [Somekh-Baruch and Verdú, ISIT2006][Muramatsu and Miyake, ISITA2018].

### I. Introduction




Fig. 1. Multi-terminal Channel Coding

This paper investigates the problem of multi-terminal channel coding for relayless networks with the general message access structure shown in Fig. 1. Multi-terminal channels include broadcast channels [6] [14] [20] [23] [25] [26], multiple-access channels [1] [2] [12] [15] [16] [24] [37] [38], and interference channels [2] [4] [18] [21] [29].

The contribution of this paper is the introduction of codes for this type of network by using constrained-random-number generators, which are the basic building blocks for the construction of the both encoders and decoders. Sparse matrices (with logarithmic column degree) are available for code construction. The construction includes the case when all messages are private [35] and the case when all encoders have access to all common messages [29]. It should be noted that there is an unsupported case in which previous constructions [29] [35] cannot be applied directly.

It is shown that the multi-letter characterized capacity region of this network is achievable with this code. This capacity region is specified in terms of entropy functions and provides an alternative to the region derived in [35] [39]. It should be noted that, when random variables are assumed to be stationary and memoryless, our region provides the best known single-letter characterized achievable regions for general stationary memoryless channels, where the rate-splitting technique is unnecessary [26] [29].

Throughout this paper, we use the following definitions and notations. When  $\mathcal{U}$  is a set and  $\mathcal{V}_u$  is also a set for each  $u \in \mathcal{U}$ , we use the notation  $\mathcal{V}_{\mathcal{U}} \equiv \times_{u \in \mathcal{U}} \mathcal{V}_u$ . We use the notation  $v_{\mathcal{U}} \equiv \{v_u\}_{u \in \mathcal{U}} \in \mathcal{V}_{\mathcal{U}}$  to represent the sequence of elements (e.g. sequences, random variables, functions)  $v_u$  with index  $u \in \mathcal{U}$ . We use the notation  $|\mathcal{U}|$  to represent the cardinality of  $\mathcal{U}$ . Let  $2^{\mathcal{U}}$  be the power set of  $\mathcal{U}$ .

Let  $\mathcal I$  be the index set of channel inputs, and  $\mathcal J$  be the index set of channel outputs. Then, a general channel is characterized by sequence  $\{\mu_{Y^n_{\mathcal J}|X^n_{\mathcal I}}\}_{n=1}^\infty$  of conditional distributions, where  $n\in\mathbb N$  is the block length of the channel input,  $X^n_{\mathcal I}\equiv\{X^n_i\}_{i\in\mathcal I}$  is the set of random variables of multiple channel inputs, and  $Y^n_{\mathcal J}\equiv\{Y^n_j\}_{j\in\mathcal J}$  is the set of random variables of multiple channel outputs.

For each  $i \in \mathcal{I}$  and  $n \in \mathbb{N}$ , let  $\mathcal{X}_i^n$  be the alphabet of random variable  $X_i^n \equiv (X_{i,1},\ldots,X_{i,n})$ , where we assume that  $\mathcal{X}_i^n$  is the n-dimensional Cartesian product of finite set  $\mathcal{X}_i$  and  $X_{i,k} \in \mathcal{X}_i$  for all  $k \in \{1,\ldots,n\}$ . For each  $j \in \mathcal{J}$  and  $n \in \mathbb{N}$ , let  $\mathcal{Y}_j^n$  be the alphabet of random variable  $Y_j^n$ . It should be noted that  $\mathcal{Y}_j^n$  is allowed to be an infinite/continuous set and it is unnecessary to assume that  $\mathcal{Y}_j^n$  is the n-dimensional Cartesian product of  $\mathcal{Y}_j$ . For example, we can assume that  $\mathcal{Y}_j^n \equiv \bigcup_{n=0}^{\infty} \mathcal{X}_i^n$ , which is the set of all finite length sequences with alphabet  $\mathcal{X}_i$ , to describe insertion-deletion-substitution channels. We use notations  $Y_i^n$  and  $\mathcal{Y}_j^n$  to consider the stationary memoryless case.

Let S be the index set of multiple messages. For each  $s \in S$  and  $n \in \mathbb{N}$ , let  $M_s^{(n)}$  be a random variable of Message s corresponding to the uniform distribution on alphabet  $\mathcal{M}_s^{(n)}$ . We assume that  $\{M_s^{(n)}\}_{s\in S}$  are mutually independent. We consider the situation that each encoder has access to some of the messages in  $\{M_s^{(n)}\}_{s\in S}$ , where some messages are common to some encoders. The definition of the general message access structure between messages and encoders is introduced in Section II.

### II. MESSAGE ACCESS STRUCTURE

This section introduces the message access structure.

(Message) access structure  $\mathcal{A}$  is a subset of  $\mathcal{S} \times \mathcal{I}$ , where member  $(s,i) \in \mathcal{A}$  indicates that Encoder i has access to Message s. It should be noted that  $(\mathcal{S}, \mathcal{I}, \mathcal{A})$  forms a directed bipartite graph, where  $(s,i) \in \mathcal{A}$  corresponds to the arc (directed edge)  $s \to i$ . For each  $s \in \mathcal{S}$ , let  $\mathcal{I}(s)$  be the set of all indices of encoders that have access to Message s, where  $\mathcal{I}(s)$  is defined as

$$\mathcal{I}(s) \equiv \{i \in \mathcal{I} : (s, i) \in \mathcal{A}\}.$$

For each  $i \in \mathcal{I}$ , let  $\mathcal{S}(i)$  be the set of all indices of the messages to which Encoder i has access, where  $\mathcal{S}(i)$  is defined as

$$\mathcal{S}(i) \equiv \{ s \in \mathcal{S} : (s, i) \in \mathcal{A} \}.$$

We have the fact that  $i \in \mathcal{I}(s)$  is equivalent to  $s \in \mathcal{S}(i)$ .

For a given  $\mathcal{I}' \in 2^{\mathcal{I}}$ , we refer to the set of encoders whose index belongs to  $\mathcal{I}'$  as *Encoders*  $\mathcal{I}'$ . Let  $\mathcal{S}(\mathcal{I}')$  be the index set of messages common to Encoders  $\mathcal{I}'$ , where  $\mathcal{S}(\mathcal{I}')$  is defined as

$$S(\mathcal{I}') \equiv \{ s \in S : \mathcal{I}(s) = \mathcal{I}' \}. \tag{1}$$

We define I as

$$\mathfrak{I} \equiv \{ \mathcal{I}' \in 2^{\mathcal{I}} : \mathcal{S}(\mathcal{I}') \neq \emptyset \}.$$

Here, let us introduce a few examples.




Fig. 2. Access Structure of Example 1

Example 1 (Broadcast channel with a common message): The access structure of a broadcast channel with a common message (Fig. 2) can be written as

$$S \equiv \{1, 2, 12\}$$
 $I \equiv \{1\}$ 
 $A \equiv \{(1, 1), (2, 1), (12, 1)\},$ 

where Encoder 1 has access to Messages 1, 2, and 12, Message 12 is reproduced by Decoders 1 and 2, and Message i is reproduced by Decoder i for each  $i \in \{1, 2\}$ . We have

$$S(1) \equiv \{1, 2, 12\}$$

$$I(1) \equiv \{1\}$$

$$I(2) \equiv \{1\}$$

$$I(12) \equiv \{1\}$$

$$I(12) \equiv \{1\}$$

$$I(12) \equiv \{1\}$$

$$I(12) \equiv \{1, 2, 12\}$$




Fig. 3. Access Structure of Example 2

Example 2 (Two-input multiple access channel with a common message): The access structure of a two-input multiple-access channel with a common message (Fig. 3) can be written as

$$S \equiv \{1, 2, 12\}$$

$$I \equiv \{1, 2\}$$

$$A \equiv \{(1, 1), (2, 2), (12, 1), (12, 2)\},$$

where Message 12 is a common message for Encoders 1 and 2, and Message i is a private message for Encoder i for each  $i \in \{1, 2\}$ . In other words, Encoder i has access to Messages i and 12 for each  $i \in \{1, 2\}$ . This access structure is the same as that of the two-user interference channel with a common message [21], where Decoder i reproduces Messages i and 12 for each  $i \in \{1, 2\}$ . We have

$$S(1) \equiv \{1, 12\}$$

$$S(2) \equiv \{2, 12\}$$

$$I(1) \equiv \{1\}$$

$$I(2) \equiv \{2\}$$

$$I(12) \equiv \{1, 2\}$$

$$I(12) \equiv \{1\}$$

$$I(12) \equiv \{2\}$$




Fig. 4. Access Structure of Example 3

Example 3: Here, we introduce an access structure of a multiple-access channel with three inputs (Fig. 4); it is written as

$$\begin{split} \mathcal{S} &\equiv \{1, 3, 12, 23, 123\} \\ \mathcal{I} &\equiv \{1, 2, 3\} \\ \mathcal{A} &\equiv \begin{cases} (1, 1), (3, 3), \\ (12, 1), (12, 2), (23, 2), (23, 3), \\ (123, 1), (123, 2), (123, 3) \end{cases}, \end{split}$$

where Message i is a private message for Encoder i for each  $i \in \{1,3\}$ , Message ij is a common message to Encoders i and j for each two-digit indexes  $ij \in \{12,23\}$ , and Message 123 is a common message to Encoders 1, 2, and 3. In other words, Encoder 1 has access to Messages 1, 12, and 123, Encoder 2 has access to Messages 12, 23, and 123, and Encoder 3 has access to Messages 3, 23, and 123. It should be noted that there are partially-common messages 12 and 23, that do not appear in two-input multiple access channels. We have

$$S(1) \equiv \{1, 12, 123\}$$

$$S(2) \equiv \{12, 23, 123\}$$

$$S(3) \equiv \{3, 23, 123\}$$

$$I(1) \equiv \{1\}$$

$$I(3) \equiv \{3\}$$

$$I(12) \equiv \{1, 2\}$$

$$I(23) \equiv \{2, 3\}$$

$$I(123) \equiv \{1, 2, 3\}$$

$$\mathfrak{I} \equiv \{\{1, 2, 3\}, \{1, 2\}, \{2, 3\}, \{1\}, \{3\}\}\}$$

$$\mathcal{S}(\{1, 2, 3\}) \equiv \{123\}$$

$$\mathcal{S}(\{1, 2\}) \equiv \{12\}$$

$$\mathcal{S}(\{2, 3\}) \equiv \{23\}$$

$$\mathcal{S}(\{1\}) \equiv \{1\}$$

$$\mathcal{S}(\{3\}) \equiv \{3\}.$$

It should be noted that this example is an unsupported case in which previous constructions [29] [35] cannot be applied directly.

From the following two lemmas, we have the fact that  $\{S(\mathcal{I}')\}_{\mathcal{I}'\in\mathcal{I}}$  forms a partition of S. Lemma 1:

$$\bigcup_{\mathcal{I}'\in\mathfrak{I}}\mathcal{S}(\mathcal{I}')=\mathcal{S}.$$

*Proof:* Since  $\bigcup_{\mathcal{I}' \in \mathfrak{I}} \mathcal{S}(\mathcal{I}') \subset \mathcal{S}$  is trivial, it is sufficient to show that  $\mathcal{S} \subset \bigcup_{\mathcal{I}' \in \mathfrak{I}} \mathcal{S}(\mathcal{I}')$ . Assume that  $s \in \mathcal{S}$  and  $\mathcal{I}' \equiv \mathcal{I}(s)$ . Then we have  $s \in \mathcal{S}(\mathcal{I}(s)) = \{s' : \mathcal{I}(s') = \mathcal{I}(s)\}$ . This implies that  $\mathcal{S}(\mathcal{I}(s)) \neq \emptyset$  and  $\mathcal{I}' = \mathcal{I}(s) \in \mathfrak{I}$ . Then we have  $s \in \bigcup_{\mathcal{I}' \in \mathfrak{I}} \mathcal{S}(\mathcal{I}')$  and  $\mathcal{S} \subset \bigcup_{\mathcal{I}' \in \mathfrak{I}} \mathcal{S}(\mathcal{I}')$ . Lemma 2: For any  $\mathcal{I}'$  and  $\mathcal{I}''$  satisfying  $\mathcal{I}' \neq \mathcal{I}''$ , we have

$$\mathcal{S}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}'') = \emptyset.$$

*Proof:* We show the lemma by contradiction. Assume that  $\mathcal{I}' \neq \mathcal{I}''$  and  $\mathcal{S}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}'') \neq \emptyset$ . From  $\mathcal{S}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}'') \neq \emptyset$ , there is  $s \in \mathcal{S}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}'')$  satisfying  $\mathcal{I}(s) = \mathcal{I}'$  and  $\mathcal{I}(s) = \mathcal{I}''$ . Then we have  $\mathcal{I}' = \mathcal{I}''$ , which contradicts  $\mathcal{I}' \neq \mathcal{I}''$ .

Let  $\overset{\circ}{S}(\mathcal{I}')$  and  $\overset{\bullet}{S}(\mathcal{I}')$  be defined as

$$\stackrel{\circ}{S}(\mathcal{I}') \equiv \bigcup_{\substack{\mathcal{I}'' \in \mathfrak{I}: \\ \mathcal{I}'' \supset \mathcal{I}'}} \mathcal{S}(\mathcal{I}'') \tag{2}$$

$$\overset{\circ}{\mathcal{S}}(\mathcal{I}') \equiv \bigcup_{\substack{\mathcal{I}'' \in \mathfrak{I}: \\ \mathcal{I}'' \supseteq \mathcal{I}'}} \mathcal{S}(\mathcal{I}'') 
\overset{\bullet}{\mathcal{S}}(\mathcal{I}') \equiv \bigcup_{\substack{\mathcal{I}'' \in \mathfrak{I}: \\ \mathcal{I}'' \subset \mathcal{I}'}} \mathcal{S}(\mathcal{I}''). \tag{3}$$

Then we have the following lemmas.

*Lemma 3:* For any  $\mathcal{I}' \in \mathfrak{I}$ , we have

$$\mathcal{S}(\mathcal{I}') \cap \overset{\circ}{\mathcal{S}}(\mathcal{I}') = \varnothing.$$

Proof: The lemma is shown immediately from Lemma 2.

Lemma 4: For any  $\mathcal{I}' \in \mathfrak{I}$ , we have

$$\bigcap_{i \in \mathcal{I}'} \mathcal{S}(i) = \bigcup_{\substack{\mathcal{I}'' \in \mathfrak{I}: \\ \mathcal{I}'' \supset \mathcal{I}'}} \mathcal{S}(\mathcal{I}'') = \overset{\circ}{\mathcal{S}} (\mathcal{I}') \cup \mathcal{S}(\mathcal{I}').$$

*Proof:* The relation  $\bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}'') = \overset{\circ}{\mathcal{S}}(\mathcal{I}') \cup \mathcal{S}(\mathcal{I}')$  is shown immediately from the definition of  $\overset{\circ}{\mathcal{S}}(\mathcal{I}')$ . We show below the relations  $\bigcap_{i \in \mathcal{I}'} \mathcal{S}(i) \subset \bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}'')$  and  $\bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}'') \subset \bigcap_{i \in \mathcal{I}'} \mathcal{S}(i)$ ; together they imply  $\bigcap_{i \in \mathcal{I}'} \mathcal{S}(i) = \mathcal{S}(\mathcal{I}'')$  $\bigcup_{\mathcal{I}''\in\mathfrak{I}:\mathcal{I}''\supset\mathcal{I}'}\mathcal{S}(\mathcal{I}'').$ 

First, assume that  $s \in \bigcap_{i \in \mathcal{I}'} \mathcal{S}(i)$  and  $\mathcal{I}'' \equiv \mathcal{I}(s)$ . Then we have the fact that  $s \in \mathcal{S}(i)$  for all  $i \in \mathcal{I}'$ . Since  $s \in \mathcal{S}(i)$  implies  $i \in \mathcal{I}(s)$ , we have the fact that  $\mathcal{I}' \subset \mathcal{I}(s) = \mathcal{I}''$ . Since  $s \in \mathcal{S}(\mathcal{I}(s)) = \{s' : \mathcal{I}(s') = \mathcal{I}(s)\}$ , we have  $\mathcal{S}(\mathcal{I}(s)) \neq \emptyset$  and  $\mathcal{I}'' = \mathcal{I}(s) \in \mathfrak{I}$ . Then we have  $s \in \bigcup_{\mathcal{I}'' \in \mathcal{I}(\mathcal{I}'') = \mathcal{I}(s)} \mathcal{S}(\mathcal{I}'')$ , which implies  $\bigcap_{i \in \mathcal{I}'} \mathcal{S}(i) \subset \bigcup_{\mathcal{I}'' \in \mathcal{I}(\mathcal{I}'') = \mathcal{I}'} \mathcal{S}(\mathcal{I}'')$ .

 $\mathcal{I}'' = \mathcal{I}(s) \in \mathfrak{I}. \text{ Then we have } s \in \bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}''), \text{ which implies } \bigcap_{i \in \mathcal{I}'} \mathcal{S}(i) \subset \bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}'').$  Next, assume that  $s \in \bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}'').$  Then there is  $\mathcal{I}''$  such that  $\mathcal{I}'' \supset \mathcal{I}'$  and  $s \in \mathcal{S}(\mathcal{I}'').$  Since  $s \in \mathcal{S}(\mathcal{I}'')$  implies  $\mathcal{I}' \subset \mathcal{I}'' = \mathcal{I}(s)$ , we have  $i \in \mathcal{I}(s)$  and  $s \in \mathcal{S}(i)$  for all  $i \in \mathcal{I}'.$  Then we have  $s \in \bigcap_{i \in \mathcal{I}'} \mathcal{S}(i)$ , which implies  $\bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \supset \mathcal{I}'} \mathcal{S}(\mathcal{I}'') \subset \bigcap_{i \in \mathcal{I}'} \mathcal{S}(i).$ 

*Lemma 5:* For any  $i \in \mathcal{I}'$ , we have

$$\mathcal{S}(\mathcal{I}') \subset \mathcal{S}(i) \tag{4}$$

$$\overset{\circ}{\mathcal{S}}(\mathcal{I}') \subset \mathcal{S}(i). \tag{5}$$

The above relations imply that Encoder i has access to the set of messages  $M_{\mathcal{S}(\mathcal{I}')}^{(n)} \equiv \{M_s^{(n)}\}_{s \in \mathcal{S}(\mathcal{I}')}$  and  $M_{\mathcal{S}(\mathcal{I}')}^{(n)} \equiv \{M_s^{(n)}\}_{s \in \mathcal{S}(\mathcal{I}')}$ .

*Proof:* The lemma is shown immediately from Lemma 4.

Lemma 6: For any  $i \in \mathcal{I}$ , we have

$$\bigcup_{\substack{\mathcal{I}' \in \mathfrak{I}:\\ i \in \mathcal{I}'}} \mathcal{S}(\mathcal{I}') = \mathcal{S}(i).$$

Proof: First, we show  $\bigcup_{\mathcal{I}'\in\mathfrak{I}:i\in\mathcal{I}'}\mathcal{S}(\mathcal{I}')\subset\mathcal{S}(i)$ . Let  $s\in\bigcup_{\mathcal{I}'\in\mathfrak{I}:i\in\mathcal{I}'}\mathcal{S}(\mathcal{I}')$ . Then there is  $\mathcal{I}'\in\mathfrak{I}$  such that  $i\in\mathcal{I}'$  and  $s\in\mathcal{S}(\mathcal{I}')$ . From  $s\in\mathcal{S}(\mathcal{I}')$ , we have  $\mathcal{I}(s)=\mathcal{I}'$ . Since  $i\in\mathcal{I}'$  implies  $i\in\mathcal{I}(s)$ , we have  $s\in\mathcal{S}(i)$ . Next, we show  $\mathcal{S}(i)\subset\bigcup_{\mathcal{I}'\in\mathfrak{I}:i\in\mathcal{I}'}\mathcal{S}(\mathcal{I}')$ . Let  $s\in\mathcal{S}(i)$  and  $\mathcal{I}'\equiv\mathcal{I}(s)$ . Then we have  $i\in\mathcal{I}(s)=\mathcal{I}'$ . Since  $s\in\mathcal{S}(\mathcal{I}(s))=\{s':\mathcal{I}(s')=\mathcal{I}(s)\}$ , we have  $\mathcal{S}(\mathcal{I}(s))\neq\emptyset$  and  $\mathcal{I}'=\mathcal{I}(s)\in\mathfrak{I}$ . Then we have  $s\in\bigcup_{\mathcal{I}'\in\mathfrak{I}:i\in\mathcal{I}'}\mathcal{S}(\mathcal{I}')$ . From the above two facts, we have the lemma.

In subsequent sections, we assume that all elements in  $\mathfrak{I} = \{\mathcal{I}_1, \mathcal{I}_2, \dots, \mathcal{I}_{|\mathfrak{I}|}\}$  are sorted in a linear extension of the reversed partial ordering, which yields the following property:  $\mathcal{I}_k \subsetneq \mathcal{I}_{k'}$  implies k' < k for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ . In Examples 1–3, all elements of  $\mathfrak{I}$  are sorted in this order. An algorithm for computing the linear extension is described in Appendix A. From (2), we have

$$\overset{\circ}{\mathcal{S}}(\mathcal{I}_k) = \bigcup_{\substack{k' \in \{1, \dots, k-1\}:\\ \mathcal{I}_{k'} \supseteq \mathcal{I}_k}} \mathcal{S}(\mathcal{I}_{k'}). \tag{6}$$

Lemma 7: If k' < k, then

$$\mathcal{S}(\mathcal{I}_{k'}) \subset \stackrel{\bullet}{\mathcal{S}} (\mathcal{I}_k)^{\complement}.$$

*Proof:* Let us assume that  $\mathcal{S}(\mathcal{I}_{k'}) \cap \overset{\bullet}{\mathcal{S}}(\mathcal{I}_k) = \mathcal{S}(\mathcal{I}_{k'}) \cap \left[\bigcup_{\mathcal{I}'' \in \mathfrak{I}: \mathcal{I}'' \subset \mathcal{I}_k} \mathcal{S}(\mathcal{I}'')\right] \neq \emptyset$ . Since Lemma 2 imply that only one of  $\mathcal{S}(\mathcal{I}_{k'}) = \mathcal{S}(\mathcal{I}'')$  and  $\mathcal{S}(\mathcal{I}_{k'}) \cap \mathcal{S}(\mathcal{I}'') = \emptyset$  holds, we have the fact that  $\mathcal{I}_{k'} \subset \mathcal{I}_k$ . Then we have  $k' \geqslant k$  from the assumption on  $\{\mathcal{I}_1, \dots, \mathcal{I}_{|\mathfrak{I}|}\}$ . Hence we have the fact that k' < k implies  $\mathcal{S}(\mathcal{I}_{k'}) \cap \overset{\bullet}{\mathcal{S}}(\mathcal{I}_k) = \emptyset$  and  $\mathcal{S}(\mathcal{I}_{k'}) \subset \overset{\bullet}{\mathcal{S}}(\mathcal{I}_k)^{\complement}$ .

# III. CAPACITY REGION

This section introduces the definition of a multi-letter characterized capacity region for a general multiple-input-multiple-output channel coding [35]. Let  $P(\cdot)$  denote the probability of an event.

For each  $i \in \mathcal{I}$ , Encoder i generates channel input  $X_i^n$  from the set of messages  $M_{\mathcal{S}(i)}^{(n)} \equiv \{M_s^{(n)}\}_{s \in \mathcal{S}(i)}$ . Decoder j receives channel output  $Y_j^n$  and reproduces the set of messages  $\widehat{M}_{\mathcal{D}(j)}^{(n)} \equiv \{\widehat{M}_{j,s}^{(n)}\}_{s \in \mathcal{D}(j)}$ , where  $\mathcal{D}(j)$  is the index set of messages reproduced by Decoder j, and  $\widehat{M}_{j,s}^{(n)}$  is the reproduction by Decoder j corresponding to Message s. Let  $\widehat{M}_{\mathcal{D}(\mathcal{J})}^{(n)} \equiv \{\widehat{M}_{j,s}^{(n)}\}_{j \in \mathcal{J}, s \in \mathcal{D}(j)}$ . Then the joint distribution of  $(M_{\mathcal{S}}^{(n)}, X_{\mathcal{I}}^n, Y_{\mathcal{J}}^n, \widehat{M}_{\mathcal{D}(\mathcal{J})}^{(n)})$  is given as

$$\begin{split} & \mu_{M_{\mathcal{S}}^{(n)}X_{\mathcal{I}}^{n}Y_{\mathcal{J}}^{n}\widehat{M}_{\mathcal{D}(\mathcal{I})}^{(n)}}(\boldsymbol{m}_{\mathcal{S}},\boldsymbol{x}_{\mathcal{I}},\boldsymbol{y}_{\mathcal{J}},\widehat{\boldsymbol{m}}_{\mathcal{D}(\mathcal{I})}) \\ & = \left[\prod_{j \in \mathcal{J}} \mu_{\widehat{M}_{\mathcal{D}(j)}^{(n)}|Y_{j}^{n}}(\widehat{\boldsymbol{m}}_{\mathcal{D}(j)}|\boldsymbol{y}_{j})\right] \mu_{Y_{\mathcal{J}}^{n}|X_{\mathcal{I}}^{n}}(\boldsymbol{y}_{\mathcal{J}}|\boldsymbol{x}_{\mathcal{I}}) \left[\prod_{i \in \mathcal{I}} \mu_{X_{i}^{n}|M_{\mathcal{S}(i)}^{(n)}}(\boldsymbol{x}_{i}|\boldsymbol{m}_{\mathcal{S}(i)})\right] \left[\prod_{s \in \mathcal{S}} \frac{1}{|\mathcal{M}_{s}^{(n)}|}\right]. \end{split}$$

We expect that, with probability close to 1,  $\widehat{M}_{j,s}^{(n)}=M_s^{(n)}$  for all  $j\in\mathcal{J}$  and  $s\in\mathcal{D}(j)$  if n is sufficiently large. We call rate vector  $\{R_s\}_{s\in\mathcal{S}}$  achievable if there is a (possibly stochastic) code  $\{(\{\Phi_i^{(n)}\}_{i\in\mathcal{I}}, \{\Psi_j^{(n)}\}_{j\in\mathcal{J}})\}_{n=1}^{\infty}$  consisting of encoders  $\Phi_i^{(n)}:\mathcal{M}_{\mathcal{S}(i)}^{(n)}\to\mathcal{X}_i^n$  and decoders  $\Psi_j^{(n)}:\mathcal{Y}_j^n\to\mathcal{M}_{\mathcal{D}(j)}^{(n)}$  such that

$$\liminf_{n \to \infty} \frac{\log_2 |\mathcal{M}_s^{(n)}|}{n} \geqslant R_s \quad \text{for all } s \in \mathcal{S}$$

$$\lim_{n \to \infty} P\left(\widehat{M}_{j,s}^{(n)} \neq M_s^{(n)} \text{ for some } j \in \mathcal{J} \text{ and } s \in \mathcal{D}(j)\right) = 0,$$
(8)

where  $X_i^n \equiv \Phi_i^{(n)}(M_{S(i)}^{(n)})$  and  $\widehat{M}_{\mathcal{D}(j)}^{(n)} \equiv \Psi_j^{(n)}(Y_j^n)$ . Capacity region  $\mathcal{R}_{\mathrm{OP}}$  is defined as the closure of the set of all achievable rate vectors

In the following, we use the information spectrum method introduced in [17], and we do not assume conditions such as consistency, stationarity, and ergodicity. For sequence  $\{\mu_{U_nV_n}\}_{n=1}^{\infty}$  of joint probability distributions corresponding to  $(\boldsymbol{U},\boldsymbol{V}) \equiv \{(U_n,V_n)\}_{n=1}^{\infty}, \underline{H}(\boldsymbol{U}|\boldsymbol{V})$  denotes the spectral conditional inf-entropy rate and  $\overline{H}(\boldsymbol{U}|\boldsymbol{V})$  denotes the spectral conditional supentropy rate. Formal definitions are given in Appendix B.

Let  $Z^n_{\mathcal{S}} \equiv \{Z^n_s\}_{s \in \mathcal{S}}$  be the random variables subject to the distribution defined as

$$p_{Z_{\mathcal{S}}^{n}}(\boldsymbol{z}_{\mathcal{S}}) = \prod_{\mathcal{I}' \in \mathcal{I}} p_{Z_{\mathcal{S}(\mathcal{I}')}^{n}|Z_{\mathcal{S}(\mathcal{I}')}^{n}}(\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}|\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}^{\circ}), \tag{9}$$

where

$$p_{Z^n_{\mathcal{S}(\mathcal{I}')}|Z^n_{\overset{\circ}{\mathcal{S}}(\mathcal{I}')}}(\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}|\boldsymbol{z}_{\overset{\circ}{\mathcal{S}}(\mathcal{I}')}) \equiv p_{Z^n_{\mathcal{S}(\mathcal{I}')}}(\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}) \quad \text{if} \ \overset{\circ}{\mathcal{S}}(\mathcal{I}') = \varnothing.$$

The alphabet of  $Z_s^n$  is denoted by  $Z_s^n$  for each  $s \in S$ . It should be noted that it is unnecessary to assume that  $Z_s^n$  is the n-dimensional Cartesian product of  $Z_s$ . We use notations  $Z_s^n$  and  $Z_s^n$  to consider the stationary memoryless case.

Let  $\mathcal{R}_{\mathrm{IT}}$  be defined as the set of all  $\{R_s\}_{s\in\mathcal{S}}$  satisfying the condition that there are a set of general sources  $\mathbf{Z}_{\mathcal{S}} \equiv \{\mathbf{Z}_s\}_{s\in\mathcal{S}}$  and a set of numbers  $\{r_s\}_{s\in\mathcal{S}}$  such that

$$R_s \geqslant 0 \tag{10}$$

$$\sum_{s \in \mathcal{S}'} [R_s + r_s] \leq \underline{H}(\mathbf{Z}_{\mathcal{S}'} | \mathbf{Z}_{\hat{\mathcal{S}}(\mathcal{I}')})$$

$$\sum_{s \in \mathcal{D}'} r_s \geqslant \overline{H}(\mathbf{Z}_{\mathcal{D}'} | \mathbf{Y}_j, \mathbf{Z}_{\mathcal{D}(j) \setminus \mathcal{D}'})$$

for all  $(\mathcal{I}', \mathcal{S}', j, \mathcal{D}')$  satisfying  $\mathcal{I}' \in \mathfrak{I}$ ,  $\emptyset \neq \mathcal{S}' \subset \mathcal{S}(\mathcal{I}')$ ,  $j \in \mathcal{J}$ ,  $\emptyset \neq \mathcal{D}' \subset \mathcal{D}(j)$ , where the joint distribution of  $(Z_{\mathcal{S}}^n, X_{\mathcal{I}}^n, Y_{\mathcal{J}}^n)$  is given as

$$\mu_{Z_{\mathcal{S}}^{n}X_{\mathcal{I}}^{n}Y_{\mathcal{J}}^{n}}(\boldsymbol{z}_{\mathcal{S}},\boldsymbol{x}_{\mathcal{I}},\boldsymbol{y}_{\mathcal{J}}) = \mu_{Y_{\mathcal{J}}^{n}|X_{\mathcal{I}}^{n}}(\boldsymbol{y}_{\mathcal{J}}|\boldsymbol{x}_{\mathcal{I}}) \left[ \prod_{i \in \mathcal{I}} \mu_{X_{i}^{n}|Z_{\mathcal{S}(i)}^{n}}(\boldsymbol{x}_{i}|\boldsymbol{z}_{\mathcal{S}(i)}) \right] \mu_{Z_{\mathcal{S}}^{n}}(\boldsymbol{z}_{\mathcal{S}})$$
(13)

by using  $\mu_{Z_S^n}$  defined by (9). It should be noted that we can eliminate auxiliary variables  $\{r_s\}_{s\in\mathcal{S}}$  by applying the Fourier-Motzkin method [13, Appendix D].

We have the following theorem. The proof of  $\mathcal{R}_{\mathrm{OP}} \subset \mathcal{R}_{\mathrm{IT}}$  is given in Section V. For the proof of  $\mathcal{R}_{\mathrm{OP}} \supset \mathcal{R}_{\mathrm{IT}}$ , we construct a code in Section VI.

Theorem 1:

$$\mathcal{R}_{\mathrm{OP}} = \mathcal{R}_{\mathrm{IT}}.$$

Remark 1: When channels and auxiliary sources are stationary and memoryless, we can replace  $\underline{H}(\mathbf{Z}_{S'}|\mathbf{Z}_{S(\mathcal{I}')})$  by  $H(Z_{S'}|Z_{S(\mathcal{I}')})$  and  $\overline{H}(\mathbf{Z}_{\mathcal{D}'}|\mathbf{Y}_j,\mathbf{Z}_{\mathcal{D}(j)\setminus\mathcal{D}'})$  by  $H(Z_{\mathcal{D}'}|Y_j,Z_{\mathcal{D}(j)\setminus\mathcal{D}'})$  to obtain a single-letter characterized achievable region. By considering an extension of the problem (super problem [29]) with zero rate auxiliary messages, which is analogous to introducing auxiliary random variables, we can obtain a potential extension of the single-letter characterized achievable region, where the specific cases are given in [26] [29] [35]. In [35], we find a multi-letter characterized capacity region by using the reduction technique introduced in [9, Problems 14.22-14.24] [15]. It should be noted here that the characterization presented in this paper provides a potentially larger achievable region when channels and auxiliary sources are restricted to being stationary and memoryless.

# IV. JOINT DISTRIBUTION CONSISTENT WITH ACCESS STRUCTURE

Before proving Theorem 1, we investigate the possible joint distribution of random variables consistent with access structure A.

Let  $\mathcal{I}'$  be a subset of  $\mathcal{I}$ . We refer to  $Z^n_{\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)}$  as common sources for Encoders  $\mathcal{I}'$ , to  $Z^n_{\mathcal{S}(\mathcal{I}')}$  as private sources for Encoders  $\mathcal{I}'$ , to  $Z^n_{\bigcup_{\mathcal{I}''\in\mathfrak{I}:\mathcal{I}''\subset\mathcal{I}'}\mathcal{S}(i)}$  as private sources relevant to Encoders  $\mathcal{I}'$ , to  $Z^n_{[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)]\cap\mathcal{S}(\mathcal{I}')^\complement}$  as public sources for Encoders  $\mathcal{I}'$ , and to  $Z^n_{[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)]^\complement\cap[\bigcup_{\mathcal{I}''\in\mathfrak{I}:\mathcal{I}''\subset\mathcal{I}'}\mathcal{S}(\mathcal{I}'')]^\complement}$  as irrelevant sources to Encoders  $\mathcal{I}'$ .

Here, let us consider the following problem. Encoder i has access to the set of random variables  $Z^n_{\mathcal{S}(i)} \equiv \{Z^n_s\}_{s\in\mathcal{S}(i)}$ , where

Here, let us consider the following problem. Encoder i has access to the set of random variables  $Z^n_{\mathcal{S}(i)} \equiv \{Z^n_s\}_{s \in \mathcal{S}(i)}$ , where  $Z^n_s$  corresponds to message  $M^{(n)}_s$  but random variables  $\{Z^n_s\}_{s \in \mathcal{S}}$  are allowed to be correlated on condition that private sources for Encoders  $\mathcal{I}'$  are allowed to be correlated with other sources only through their public sources for all  $\mathcal{I}' \in \mathfrak{I}$ ; that is, they satisfy the following Markov relation

$$Z^{n}_{\left[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)\right]^{\complement}\cap\left[\bigcup_{\mathcal{I}''\in\mathfrak{I};\mathcal{I}''\subset\mathcal{I}'}\mathcal{S}(\mathcal{I}'')\right]^{\complement}}\leftrightarrow Z^{n}_{\left[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)\right]\cap\mathcal{S}(\mathcal{I}')^{\complement}}\leftrightarrow Z^{n}_{\mathcal{S}(\mathcal{I}')}$$
(14)

for all  $\mathcal{I}' \in \mathfrak{I}$ . It should be noted that common sources for Encoders  $\mathcal{I}'$  are allowed to be correlated. Other encoders may have access to the public sources for Encoders  $\mathcal{I}'$  but do not have access to the private sources relevant to Encoders  $\mathcal{I}'$ . In this situation, we specify the joint distribution of  $\{Z_s^n\}_{s\in\mathcal{S}}$ . The following lemma solves this problem.

Lemma 8: The following two statements are equivalent.

- Joint source  $Z_S^n$  satisfies (14) for all  $\mathcal{I}' \in \mathfrak{I}$ .
- The joint distribution  $\mu_{Z_S^n}$  of  $Z_S^n$  is given by (9).

*Proof:* Let  $\overset{\circ}{\mathcal{S}}(\mathcal{I}')$  and  $\overset{\bullet}{\mathcal{S}}(\mathcal{I}')$  be defined by (2) and (3), respectively. Let  $\{\mathcal{I}_k\}_{k=1}^{|\mathfrak{I}|}$  be defined at the end of Section II. First, we show that the first statement implies the second statement. We have

$$\left[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)\right] \cap \mathcal{S}(\mathcal{I}')^{\complement} = \left[\mathcal{S}(\mathcal{I}') \cup \stackrel{\circ}{\mathcal{S}}(\mathcal{I}')\right] \cap \mathcal{S}(\mathcal{I}')^{\complement} 
= \left[\mathcal{S}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}')^{\complement}\right] \cup \left[\stackrel{\circ}{\mathcal{S}}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}')^{\complement}\right] 
= \stackrel{\circ}{\mathcal{S}}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}')^{\complement} 
= \left[\stackrel{\circ}{\mathcal{S}}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}')^{\complement}\right] \cup \left[\stackrel{\circ}{\mathcal{S}}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}')\right] 
= \stackrel{\circ}{\mathcal{S}}(\mathcal{I}') \cap \left[\mathcal{S}(\mathcal{I}')^{\complement} \cup \mathcal{S}(\mathcal{I}')\right] 
= \stackrel{\circ}{\mathcal{S}}(\mathcal{I}'),$$

where the first equality comes from Lemma 4, and the fourth equality comes from Lemma 3. From Lemma 4, we have the fact that

$$\left[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)\right]^{\complement} \cap \left[\bigcup_{\mathcal{I}''\subseteq\mathcal{I}'}\mathcal{S}(\mathcal{I}'')\right]^{\complement} = \left[\left[\bigcap_{i\in\mathcal{I}'}\mathcal{S}(i)\right] \cup \left[\bigcup_{\mathcal{I}''\subseteq\mathcal{I}'}\mathcal{S}(\mathcal{I}'')\right]\right]^{\complement} \\

Then the condition (14) is equivalent to

$$\mu_{Z_{S}^{n}}(\boldsymbol{z}_{S}) = \prod_{k=1}^{|\mathfrak{I}|} \mu_{Z_{S(\mathcal{I}_{k})}^{n}|Z_{\bigcup_{k'=1}^{k-1}S(\mathcal{I}_{k'})}^{n}} (\boldsymbol{z}_{S(\mathcal{I}_{k})}|\boldsymbol{z}_{\bigcup_{k'=1}^{k-1}S(\mathcal{I}_{k'})})$$

$$= \prod_{k=1}^{|\mathfrak{I}|} \mu_{Z_{S(\mathcal{I}_{k})}^{n}|Z_{\mathring{S}(\mathcal{I}_{k})}^{n}} (\boldsymbol{z}_{S(\mathcal{I}_{k})}|\boldsymbol{z}_{\mathring{S}(\mathcal{I}_{k})})$$

$$= \prod_{\mathcal{I}' \in \mathfrak{I}} \mu_{Z_{S(\mathcal{I}')}^{n}|Z_{\mathring{S}(\mathcal{I}')}^{n}} (\boldsymbol{z}_{S(\mathcal{I}')}|\boldsymbol{z}_{\mathring{S}(\mathcal{I}')}), \tag{18}$$

where the first equality comes from Lemmas 1 and 2, the second equality comes from (6), (17), and Lemma 7.

Next, we show that the second statement implies the first statement. Assume that  $\mathcal{S}(\mathcal{I}') \cap \left[\bigcup_{\mathcal{I}''' \in \mathfrak{I}: \mathcal{I}''' \supseteq \mathcal{I}''} \mathcal{S}(\mathcal{I}'')\right] \neq \emptyset$ . Since Lemmas 1 and 2 imply that only one of  $\mathcal{I}' = \mathcal{I}'''$  and  $\mathcal{S}(\mathcal{I}') \cap \mathcal{S}(\mathcal{I}''') = \emptyset$  holds, we have the fact that  $\mathcal{I}' \supseteq \mathcal{I}''$  and  $\mathcal{S}(\mathcal{I}'') \cap \overset{\circ}{\mathcal{S}}(\mathcal{I}') = \emptyset$ . Furthermore,  $\mathcal{I}' \supseteq \mathcal{I}''$  implies  $\mathcal{S}(\mathcal{I}'') \subset \overset{\bullet}{\mathcal{S}}(\mathcal{I}') \cap \overset{\bullet}{\mathcal{S}}(\mathcal{I}') \cap \overset{\bullet}{\mathcal{S}}(\mathcal{I}') \cap \overset{\circ}{\mathcal{S}}(\mathcal{I}') \cap \overset{\bullet}{\mathcal{S}}(\mathcal{I}') \cap \overset{\bullet}{$ 

$$S(\mathcal{I}') \cup \overset{\circ}{\mathcal{S}} (\mathcal{I}') \cup \left[\overset{\bullet}{\mathcal{S}} (\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}')\right]^{\complement} = S(\mathcal{I}') \cup \overset{\circ}{\mathcal{S}} (\mathcal{I}') \cup \left[\overset{\circ}{\mathcal{S}} (\mathcal{I}')^{\complement} \cap \overset{\bullet}{\mathcal{S}} (\mathcal{I}')^{\complement}\right]$$

$$= \left[S(\mathcal{I}') \cup \overset{\circ}{\mathcal{S}} (\mathcal{I}') \cup \overset{\circ}{\mathcal{S}} (\mathcal{I}')^{\complement}\right] \cap \left[S(\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}')^{\complement}\right]$$

$$= S(\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}')^{\complement}$$

$$\left[S(\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}') \cup \left[\overset{\bullet}{\mathcal{S}} (\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}')\right]^{\complement}\right]^{\complement} = \left[S(\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}} (\mathcal{I}')^{\complement}\right]^{\complement}$$

$$(19)$$

$$= \mathcal{S}(\mathcal{I}')^{\complement} \cap \stackrel{\circ}{\mathcal{S}} (\mathcal{I}')^{\complement} \cap \stackrel{\bullet}{\mathcal{S}} (\mathcal{I}'), \tag{20}$$

we have (14) from

where the last equality comes from the fact that  $\mathcal{S}(\mathcal{I}'') \subset \overset{\circ}{\mathcal{S}}(\mathcal{I}') \cup \overset{\bullet}{\mathcal{S}}(\mathcal{I}') \cap \overset{\circ}{\mathcal{S}}(\mathcal{I}') \cap \overset{\circ}{\mathcal{S}}(\mathcal{I}'') = \varnothing$ .

# V. PROOF OF THE CONVERSE

In the following, we prove  $\mathcal{R}_{\mathrm{OP}} \subset \mathcal{R}_{\mathrm{IT}}$ .

Assume that  $\{R_s\}_{s\in\mathcal{S}}\in\mathcal{R}_{\mathrm{OP}}$  and let  $r_s\equiv 0$  for each  $s\in\mathcal{S}$ . Then there is a code  $\{(\{\Phi_i^{(n)}\}_{i\in\mathcal{I}}, \{\Psi_j^{(n)}\}_{j\in\mathcal{J}})\}_{n=1}^{\infty}$  that satisfies (7) and (8) for all  $i\in\mathcal{I}$  and  $j\in\mathcal{J}$ .

(7) and (8) for all  $i \in \mathcal{I}$  and  $j \in \mathcal{J}$ . For  $j \in \mathcal{J}$  and  $\mathcal{D}' \subset \mathcal{D}(j)$ , let  $\Psi_{j,\mathcal{D}'}^{(n)}(Y_j^n)$  be the projection of  $\Psi_j^{(n)}(Y_j^n)$  on  $\mathcal{M}_{\mathcal{D}'}^{(n)}$ . Then we have

$$\lim_{n \to \infty} P(\Psi_{j,\mathcal{D}'}^{(n)}(Y_j^n) \neq M_{\mathcal{D}'}^{(n)}) = 0$$

from (8). From Lemmas 11 and 12 in Appendix B, we have

$$\overline{H}(\mathbf{M}_{\mathcal{D}'}|\mathbf{Y}_j, \mathbf{M}_{\mathcal{D}(j)\setminus\mathcal{D}'}) \leqslant \overline{H}(\mathbf{M}_{\mathcal{D}'}|\mathbf{Y}_j) 
= 0.$$
(22)

From (22) and  $\overline{H}(M_{\mathcal{D}'}|Y_j, M_{\mathcal{D}(j)\setminus\mathcal{D}'}) \ge 0$ , we have

$$\overline{H}(\boldsymbol{M}_{\mathcal{D}'}|\boldsymbol{Y}_j,\boldsymbol{M}_{\mathcal{D}(j)\setminus\mathcal{D}'})=0.$$

Then it is clear that

$$\sum_{s \in \mathcal{D}'} r_s \geqslant \overline{H}(M_{\mathcal{D}'}|Y_j, M_{\mathcal{D}(j)\setminus \mathcal{D}'})$$
(23)

for all  $(j, \mathcal{D}')$  satisfying  $j \in \mathcal{J}$  and  $\emptyset \neq \mathcal{D}' \subset \mathcal{D}(j)$ .

Assume that  $\mathcal{I}' \in \mathfrak{I}$  and  $\mathcal{S}' \subset \mathcal{S}(\mathcal{I}')$ . Since the distribution  $\mu_{M_{\mathcal{S}'}^{(n)}}$  is uniform on  $\mathcal{M}_{\mathcal{S}'}^{(n)}$ , we have the fact that

$$\frac{1}{n} \log_2 \frac{1}{\mu_{M_{S'}^{(n)}}(m_{S'})} = \frac{1}{n} \log_2 |\mathcal{M}_{S'}^{(n)}|$$

$$\geqslant \liminf_{n \to \infty} \frac{1}{n} \log_2 |\mathcal{M}_{S'}^{(n)}| - \delta$$
(24)

for all  $m_{S'} \in \mathcal{M}_{S'}^{(n)}$ ,  $\delta > 0$ , and all sufficiently large n. This implies that

$$\lim_{n \to \infty} P\left(\frac{1}{n} \log_2 \frac{1}{\mu_{M_{\mathcal{S}'}^{(n)}}(M_{\mathcal{S}'}^{(n)})} < \liminf_{n \to \infty} \frac{1}{n} \log_2 |\mathcal{M}_{\mathcal{S}'}^{(n)}| - \delta\right) = 0.$$

$$(25)$$

Let  $M_{S'} \equiv \{M_{S'}^{(n)}\}_{n=1}^{\infty}$  be a general source. Then we have

$$\liminf_{n \to \infty} \frac{1}{n} \log_2 |\mathcal{M}_{S'}^{(n)}| - \delta \leqslant \underline{H}(\mathbf{M}_{S'})$$

$$= \underline{H}(\mathbf{M}_{S'}|\mathbf{M}_{\mathring{S}(\mathcal{I}')}), \tag{26}$$

where the inequality comes from (25) and the definition of  $\underline{H}(M_{\mathcal{S}'})$  in Appendix B, and the equality comes from the fact that Lemma 3 implies that  $M_{\mathcal{S}'}^{(n)}$  and  $M_{\mathring{\mathcal{S}}(\mathcal{I}')}^{(n)}$  are independent. We have

$$\sum_{s \in \mathcal{S}'} [R_s + r_s] = \sum_{s \in \mathcal{S}'} R_s$$

$$\leq \liminf_{n \to \infty} \frac{\log_2 |\mathcal{M}_{S'}^{(n)}|}{n} \\
\leq \underline{H}(M_{S'}|M_{\overset{\circ}{S}(\mathcal{I}')}) + \delta, \tag{27}$$

where the equality comes from the fact that  $r_s = 0$  for all  $s \in \mathcal{S}$ , the first inequality comes from (7), and the second inequality comes from (26). By letting  $\delta \to 0$ , we have

$$\sum_{s \in S'} [R_s + r_s] \leqslant \underline{H}(M_{S'}|M_{\overset{\circ}{S}(\mathcal{I}')})$$
(28)

for all  $(\mathcal{I}', \mathcal{S}')$  satisfying  $\mathcal{I}' \in \mathfrak{I}$  and  $\varnothing \neq \mathcal{S}' \subset \mathcal{S}(\mathcal{I}')$ . Let  $\mathbf{Z}_s \equiv \mathbf{M}_s$  for each  $s \in \mathcal{S}$  and  $\mathbf{X}_i \equiv \{\Phi_i^{(n)}(M_{\mathcal{S}(i)}^{(n)})\}_{n=1}^{\infty}$  for each  $i \in \mathcal{I}$ . From Lemma 8 and the fact that  $Z_{\mathcal{S}}^n$  satisfies (14) for all  $\mathcal{I}' \in \mathfrak{I}$ , the joint distribution of  $(Z_{\mathcal{S}}^n, X_{\mathcal{I}}^n, Y_{\mathcal{I}}^n)$  is allowed to be given by (9) and (13). Then, from (23) and (28), we have  $\{R_s\}_{s \in \mathcal{S}} \in \mathcal{R}_{\mathrm{IT}}$ , which implies  $\mathcal{R}_{\mathrm{OP}} \subset \mathcal{R}_{\mathrm{IT}}$ .

### VI. CONSTRUCTION OF CHANNEL CODE

This section introduces a channel code based on the idea drawn from [27] [30] [31] [33] [36]; a similar idea is found in [9, Theorem 14.3] [40].

For each  $s \in \mathcal{S}$ , let us introduce a set  $\mathcal{C}_s^{(n)}$  and two functions  $f_s: \mathcal{Z}_s^n \to \mathcal{C}_s^{(n)}$  and  $g_s: \mathcal{Z}_s^n \to \mathcal{M}_s^{(n)}$ , where the dependence of  $f_s$  and  $g_s$  on n is omitted. We can use sparse matrices as functions  $f_s$  and  $g_s$  by assuming that  $\mathcal{Z}_s^n$ ,  $\mathcal{C}_s^{(n)}$ , and  $\mathcal{M}_s^{(n)}$  are linear spaces on the same finite field. For a given  $\mathcal{S}' \subset \mathcal{S}$  and  $f_{\mathcal{S}'} \equiv \{f_s\}_{s \in \mathcal{S}'}$ ,  $g_{\mathcal{S}'} \equiv \{g_s\}_{s \in \mathcal{S}'}$ 

$$\mathfrak{C}_{f_{\mathcal{S}'}}(\boldsymbol{c}_{\mathcal{S}'}) \equiv \{\boldsymbol{z}_{\mathcal{S}'}: f_s(\boldsymbol{z}_s) = \boldsymbol{c}_s \text{ for all } s \in \mathcal{S}'\}$$

$$\mathfrak{C}_{(f,g)_{\mathcal{S}'}}(\boldsymbol{c}_{\mathcal{S}'}, \boldsymbol{m}_{\mathcal{S}'}) \equiv \{\boldsymbol{z}_{\mathcal{S}'}: f_s(\boldsymbol{z}_s) = \boldsymbol{c}_s, g_s(\boldsymbol{z}_s) = \boldsymbol{m}_s \text{ for all } s \in \mathcal{S}'\},$$

where  $z_{S'} \equiv \{z_s\}_{s \in S'}$  and  $(f,g)_{S'}(z) \equiv \{(f_s(z),g_s(z))\}_{s \in S'}$ . We define  $\chi(S)$  as

$$\chi(S) \equiv \begin{cases} 1 & \text{if statement S is true} \\ 0 & \text{if statement S is false.} \end{cases}$$

We fix two sets of functions  $f_{\mathcal{S}}$  and  $g_{\mathcal{S}}$ , and a set of vectors  $c_{\mathcal{S}}$  such that they are available for constructing encoders and decoders. For each  $i \in \mathcal{I}$ , Encoder i uses  $f_{\mathcal{S}(i)}$ ,  $g_{\mathcal{S}(i)}$ , and  $c_{\mathcal{S}(i)}$ . For each  $j \in \mathcal{J}$ , Decoder j uses  $f_{\mathcal{D}(j)}$ ,  $g_{\mathcal{D}(j)}$ , and  $c_{\mathcal{D}(j)}$ . We fix the probability distribution  $\mu_{Z_{\mathcal{S}}^n} \equiv \{\mu_{Z_s^n}\}_{s \in \mathcal{S}}$  given by (9) and conditional probability distributions  $\{\mu_{X_i^n}|_{Z_{\mathcal{S}(i)}^n}\}_{i \in \mathcal{I}}$ .

We define a constrained-random-number generator for encoder use. For given  $\mathcal{I}' \in \mathfrak{I}$ ,  $\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}$ ,  $\boldsymbol{c}_{\mathcal{S}(\mathcal{I}')}$ , and  $\boldsymbol{m}_{\mathcal{S}(\mathcal{I}')}$ , let  $\widetilde{Z}^n_{\mathcal{S}(\mathcal{I}')}$  be a random variable corresponding to the distribution

$$\mu_{\widetilde{Z}_{\mathcal{S}(\mathcal{I}')}^{n}|\widetilde{Z}_{\mathcal{S}(\mathcal{I}')}^{n}|\widetilde{Z}_{\mathcal{S}(\mathcal{I}')}^{n}M_{\mathcal{S}(\mathcal{I}')}^{(n)}}(\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}|\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}^{\circ},\boldsymbol{c}_{\mathcal{S}(\mathcal{I}')},\boldsymbol{m}_{\mathcal{S}(\mathcal{I}')})$$

$$\equiv \frac{\mu_{Z_{\mathcal{S}(\mathcal{I}')}^{n}|Z_{\mathcal{S}(\mathcal{I}')}^{n}}(\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}|\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}^{\circ})\chi(\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}\in\mathfrak{C}_{(f,g)_{\mathcal{S}(\mathcal{I}')}}(\boldsymbol{c}_{\mathcal{S}(\mathcal{I}')},\boldsymbol{m}_{\mathcal{S}(\mathcal{I}')}))}{\mu_{Z_{\mathcal{S}(\mathcal{I}')}^{n}|Z_{\mathcal{S}(\mathcal{I}')}^{n}}(\mathfrak{C}_{(f,g)_{\mathcal{S}(\mathcal{I}')}}(\boldsymbol{c}_{\mathcal{S}(\mathcal{I}')},\boldsymbol{m}_{\mathcal{S}(\mathcal{I}')})|\boldsymbol{z}_{\mathcal{S}(\mathcal{I}')}^{\circ})}, \tag{29}$$

where  $\{\stackrel{\circ}{\mathcal{S}}(\mathcal{I}')\}_{I'\in\mathfrak{I}}$  is obtained before encoding by employing Algorithm 1. We assume that the constrained-random number generator outputs the same  $z_{\mathcal{S}(\mathcal{I}')}$  to all encoders that have access to message  $m_{\mathcal{S}(\mathcal{I}')}$  for a given  $\mathcal{I}'\in\mathfrak{I}$ . Then Encoder i generates  $z_{\mathcal{S}(i)}$  by using Algorithm 2 based on Lemma 6 and (9), where (6) implies that Encoder i has obtained  $z_{\stackrel{\circ}{\mathcal{S}}(\mathcal{I}_k)}$  at Line 2 of Algorithm 2. We define encoding function  $\Phi_i^{(n)}:\mathcal{M}_{\mathcal{S}(i)}^{(n)}\to\mathcal{X}_i^n$  as

$$\Phi_i^{(n)}(\boldsymbol{m}_{\mathcal{S}(i)}) \equiv W_i^n(\widetilde{Z}_{\mathcal{S}(i)}^n),$$

where the encoder claims an error when  $\mu_{Z^n_{\mathcal{S}(\mathcal{I}')}|Z^n_{\mathring{\mathcal{S}}(\mathcal{I}')}}(\mathfrak{C}_{(f,g)_{\mathcal{S}(\mathcal{I}')}}(c_{\mathcal{S}(\mathcal{I}')}, m_{\mathcal{S}(\mathcal{I}')})|z_{\mathring{\mathcal{S}}(\mathcal{I}')}) = 0$  and  $W^n_i$  is the channel corresponding to the conditional probability distribution  $\mu_{X^n_i|Z^n_{\mathcal{S}(i)}}$ . The flow of vectors is illustrated in Fig. 5.

Remark 2: By using the interval algorithm introduced in [27], encoders can share the same output of a given constrained-random-number generator by sharing a fixed real number belonging to [0,1].

We define a constrained-random-number generator used by Decoder j. For each  $j \in \mathcal{J}$ , Decoder j generates  $\hat{\boldsymbol{z}}_{\mathcal{D}(j)} \equiv \{\hat{\boldsymbol{z}}_s\}_{s \in \mathcal{D}(j)}$  by using a constrained-random-number generator whose distribution is given as

$$\mu_{\hat{Z}_{\mathcal{D}(j)}^{n}|C_{\mathcal{D}(j)}^{(n)}Y_{j}^{n}}(\hat{\boldsymbol{z}}_{\mathcal{D}(j)}|\boldsymbol{c}_{\mathcal{D}(j)},\boldsymbol{y}_{j}) \equiv \frac{\mu_{Z_{\mathcal{D}(j)}^{n}|Y_{j}^{n}}(\hat{\boldsymbol{z}}_{\mathcal{D}(j)}|\boldsymbol{y}_{j})\chi(f_{\mathcal{D}(j)}(\hat{\boldsymbol{z}}_{\mathcal{D}(j)}) = \boldsymbol{c}_{\mathcal{D}_{j}})}{\mu_{Z_{\mathcal{D}(j)}^{n}|Y_{j}^{n}}(\mathfrak{C}_{f_{\mathcal{D}(j)}}(\boldsymbol{c}_{\mathcal{D}(j)})|\boldsymbol{y}_{j})}$$
(30)

```

for given vector  $c_{\mathcal{D}(j)}$  and side information  $y_j \in \mathcal{Y}_j^n$ , where  $f_{\mathcal{D}(j)}(\hat{z}_{\mathcal{D}(j)}) \equiv \{f_s(\hat{z}_s)\}_{s \in \mathcal{D}(j)}$ . We define the decoding function  $\Psi_j^{(n)}: \mathcal{Y}_j^n \to \mathcal{M}_{\mathcal{D}(j)}^{(n)}$  as

$$\Psi_j^{(n)}(\boldsymbol{y}_j) \equiv \{g_s(\hat{\boldsymbol{z}}_{j,s})\}_{s \in \mathcal{D}(j)}.$$




Fig. 6. Construction of Decoder j: It is assumed that  $\mathcal{D}(j) \equiv \{s_1, s_2, \dots, s_{|\mathcal{D}(j)|}\}$ .

The flow of vectors is illustrated in Fig. 6. It should be noted here that  $\hat{Z}_{\mathcal{D}(j)}^n$  is analogous to the decoder reproducing the output  $z_{\mathcal{D}(j)} \equiv \{z_s\}_{s \in \mathcal{D}(j)}$  of correlated sources, where  $c_s \equiv f_s(z_s)$  corresponds to the codeword by using encoding function  $f_s$ .

It should be noted that, for sources that are memoryless, the tractable approximation algorithms for a constrained-random-number generator summarized in [34] can be used; the maximum a posteriori probability decoder is optimal but may be intractable.

Let




Fig. 5. Construction of Encoder i: It is assumed that  $\mathcal{K}(i) \equiv \{k: i \in \mathcal{I}_k\} \equiv \{k_1, k_2, \dots, k_{|\mathcal{K}(i)|}\}$  satisfies  $k_1 < k_2 < \dots < k_{|\mathcal{K}(i)|}$ . Arrows from  $\boldsymbol{z}_{\mathcal{S}(I_{k'})}$  to  $\widetilde{Z}_{\mathcal{S}(I_k)}$  are ignored when  $\mathcal{I}_k \subsetneq \mathcal{I}_{k'}$  is not satisfied.

where  $R_s$  represents the rate of Message s. Let  $\widehat{M}^{(n)}_{\mathcal{D}(j)} \equiv \Psi^{(n)}_j(Y^n_j)$  and  $\operatorname{Error}(f_{\mathcal{S}},g_{\mathcal{S}},\boldsymbol{c}_{\mathcal{S}})$  be the error probability defined as

The following theorem, implies the achievability part,  $\mathcal{R}_{\mathrm{IT}} \subset \mathcal{R}_{\mathrm{OP}}$ , of Theorem 1. The proof is given in Section VII.

Theorem 2: For a given access structure  $(S, \mathcal{I}, \mathcal{A})$ , let us define  $\mathfrak{I}, S(\mathcal{I}')$ , and  $\overset{\circ}{S}(\mathcal{I}')$  as described in Section II. Let us assume that  $\{(r_s, R_s)\}_{s \in \mathcal{S}}$  satisfies

for all  $(\mathcal{I}', \mathcal{S}', j, \mathcal{D}')$  satisfying  $\mathcal{I}' \in \mathfrak{I}$ ,  $\emptyset \neq \mathcal{S}' \subset \mathcal{S}(\mathcal{I}')$ ,  $j \in \mathcal{J}$ , and  $\emptyset \neq \mathcal{D}' \subset \mathcal{D}(j)$ , where the joint distribution of  $(Z_S^n, X_T^n, Y_T^n)$  is given by (9) and (13). Then for all  $\delta > 0$  and all sufficiently large n there are functions (sparse matrices)  $f_{\mathcal{S}}$ ,  $g_{\mathcal{S}}$ , and a set of vectors  $c_{\mathcal{S}}$  such that  $\operatorname{Error}(f_{\mathcal{S}}, g_{\mathcal{S}}, c_{\mathcal{S}}) \leq \delta$ .

Remark 3: It should be noted that for specific  $\mu_{Z_S^n X_T^n Y_T^n}$  and  $\{R_s\}_{s \in S}$  we can find  $\{r_s\}_{s \in S}$  satisfying (33) and (34) by employing linear programming whenever they exist.

# VII. PROOF OF THEOREM 2

In the following, we omit the dependence of C, M, X, Y, and Z on n.

Let us assume that ensembles  $(\mathcal{F}_s, p_{F_s})$  and  $(\mathcal{G}_s, p_{G_s})$ , where their dependence on n is omitted, have the hash property ((52) described in Appendix C) for every  $s \in \mathcal{S}$ . For each  $s \in \mathcal{S}$ , let

where we omit the dependence of  $C_s$  and  $M_s$  on n. We use the fact without notice that

where we  $\{\mathcal{I}_k\}_{k=1}^{|\mathfrak{I}|}$  is defined at the end of Section II. We use the fact without notice that  $\{\mathcal{S}_k\}_{k=1}^{|\mathfrak{I}|}$  forms a partition of  $\mathcal{S}$ , where it is shown by Lemmas 1 and 2. We use the fact without notice that  $S_k$  and  $\overset{\circ}{S}_k$  are disjoint, where it is shown by Lemma 3. Since (6) implies

# APPENDIX

### A. Algorithm for Linear Extension of Reversed Partial Ordering of Subsets

This section introduces an algorithm for computing the linear extension of the reversed partial ordering of  $\mathfrak{I} \equiv \{\mathcal{I}_1, \dots, \mathcal{I}_{|\mathfrak{I}|}\} \subset 2^{\mathcal{I}}$  which yields the following property:  $\mathcal{I}_k \subsetneq \mathcal{I}_{k'}$  implies k' < k for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ .

When a partial ordering is represented by a directed acyclic graph, the standard topological sort [5, Section 22.4] can be employed with time complexity of  $O(|\mathfrak{I}|+a)$ , where a is the number of arcs. However, when no directed acyclic graph is available, the construction has time complexity of  $O(|\mathcal{I}||\mathfrak{I}|^2)$ , where factor  $O(|\mathcal{I}|)$  corresponds to the computation of partial ordering of two subsets and  $O(|\mathfrak{I}|^2)$  corresponds to the combination of two vertexes. We may also use a variation of the quick sort [11] which could be employed with expected time complexity of  $O(w|\mathcal{I}||\mathfrak{I}|\log_2|\mathfrak{I}|)$ , where w is the width of the directed acyclic graph and factor  $O(|\mathcal{I}|)$  corresponds to the computation of partial ordering of two subsets.

Here, let us introduce Algorithm 3 similar to the bucket sort [5, Section 8.4], based on the cardinality of a subset. When the time complexity of computing the cardinality of a subset is O(1), this algorithm has time complexity of  $O(|\mathfrak{I}|+|\mathcal{I}|)$ . When the time complexity of computing the cardinality of a subset is  $O(|\mathcal{I}|)$ , this algorithm has time complexity of  $O(|\mathcal{I}|+|\mathcal{I}|)$ . It is assumed that each  $\mathfrak{I}$  and  $\mathfrak{L}(v)$ ,  $v \in \{0,1,\ldots,|\mathcal{I}|\}$  is represented as a list of subsets. Line 1 corresponds to the initialization of  $v \in \{0,1,\ldots,|\mathcal{I}|\}$ . At Line 2,  $\mathfrak{I} \leftarrow \{\mathcal{I}_k\} \cup \mathfrak{L}(|\mathcal{I}_k|)$  means that  $\{\mathcal{I}_k\}$  is appended to  $\mathfrak{L}(|\mathcal{I}_k|)$ . At Line 4,  $\mathfrak{I} \leftarrow \mathfrak{L}(v) \cup \mathfrak{I}$  means that  $\mathfrak{L}(v)$  is appended to the beginning of  $\mathfrak{I}$ . We can implement  $\mathfrak{I}$  and  $\mathfrak{L}(w)$ ,  $w \in \{0,1,\ldots,|\mathcal{I}|\}$  by using a linked list [5, Section 10.2] to reduce the time complexity of the union operation. We have the following lemma.

*Lemma 9:* After employing Algorithm 3,  $\mathfrak{I} \equiv \{\mathcal{I}_1, \dots, \mathcal{I}_{|\mathfrak{I}|}\}$  satisfies the property that  $\mathcal{I}_k \subsetneq \mathcal{I}_{k'}$  implies k' < k for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ .

*Proof:* After employing Algorithm 3,  $\mathfrak{I} \equiv \{\mathcal{I}_1, \dots, \mathcal{I}_{|\mathfrak{I}|}\}$  satisfies the property that  $k \leqslant k'$  implies  $|\mathcal{I}_{k'}| \leqslant |\mathcal{I}_k|$  for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ . This is equivalent to the fact that  $|\mathcal{I}_k| < |\mathcal{I}_{k'}|$  implies k' < k for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ . The above yields the fact that  $\mathcal{I}_k \subsetneq \mathcal{I}_{k'}$  implies  $|\mathcal{I}_k| < |\mathcal{I}_{k'}|$  and k' < k for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ .

Remark 4: We can also use standard sorting algorithms (e.g. quick sort, merge sort, heap sort) based on subset cardinality; the time complexity is  $O(|\mathfrak{I}|\log|\mathfrak{I}|)$  when the time complexity for computing the cardinality of subset  $\mathcal{I}' \in \mathfrak{I}$  is O(1). That is, the standard sorting algorithms could be better than the proposed algorithm if  $|\mathcal{I}| = \Omega(|\mathfrak{I}|\log|\mathfrak{I}|)$  (including the case when  $|\mathcal{I}|$  is unknown/infinite).

# **Algorithm 3** Linear extension of $\mathfrak{I} \subset 2^{\mathcal{I}}$

Input: List  $\mathfrak{I} \equiv \{\mathcal{I}_1, \dots, \mathcal{I}_{|\mathfrak{I}|}\}.$ 

**Output:** Linear extension of  $\mathfrak{I}$ , where  $\mathcal{I}_k \subsetneq \mathcal{I}_{k'}$  implies k' < k for all  $k, k' \in \{1, 2, \dots, |\mathfrak{I}|\}$ .

- 1: for  $v \in \{0, \dots, |\mathcal{I}|\}$  do  $\mathfrak{L}(v) \leftarrow \emptyset$ .
- 2: for  $k \in \{1, \dots, |\mathfrak{I}|\}$  do  $\mathfrak{L}(|\mathcal{I}_k|) \leftarrow \{\mathcal{I}_k\} \cup \mathfrak{L}(|\mathcal{I}_k|)$ .
- 3:  $\mathfrak{I} \leftarrow \emptyset$ .
- 4: for  $v \in \{0, \dots, |\mathcal{I}|\}$  do  $\mathfrak{I} \leftarrow \mathfrak{L}(v) \cup \mathfrak{I}$ .

### B. Information-Spectrum Methods

First, we review the definition of the limit superior/inferior in probability introduced in [17]. For sequence  $\{U_n\}_{n=1}^{\infty}$  of random variables, the limit superior in probability p-limsup $_{n\to\infty}U_n$  and the limit inferior in probability p-liminf $_{n\to\infty}U_n$  are

$$\begin{aligned} & \operatorname{p-limsup}_{n \to \infty} U_n \equiv \inf \left\{ \theta : \lim_{n \to \infty} \mathrm{P} \left( U_n > \theta \right) = 0 \right\} \\ & \operatorname{p-liminf}_{n \to \infty} U_n \equiv \sup \left\{ \theta : \lim_{n \to \infty} \mathrm{P} \left( U_n < \theta \right) = 0 \right\}. \end{aligned}$$

Moreover, we have the following relations [17, Section 1.3]:

$$\operatorname{p-liminf}_{n \to \infty} \left[ U_n + V_n \right] \leqslant \operatorname{p-limsup}_{n \to \infty} U_n + \operatorname{p-liminf}_{n \to \infty} V_n \tag{44}$$

For sequence  $\{\mu_{U_n}\}_{n=1}^{\infty}$  of probability distributions corresponding to U, we define the spectral inf-entropy rate,  $\underline{H}(U)$ , as

$$\underline{H}(U) \equiv \operatorname{p-liminf} \frac{1}{n} \log_2 \frac{1}{\mu_{U_n}(U_n)}.$$

For general sequence  $\{\mu_{U_nV_n}\}_{n=1}^{\infty}$  of joint probability distributions corresponding to  $(\boldsymbol{U},\boldsymbol{V})=\{(U_n,V_n)\}_{n=1}^{\infty}$ , we define the spectral conditional sup-entropy rate  $\overline{H}(U|V)$ , and the spectral conditional inf-entropy rate  $\underline{H}(U|V)$  as

$$\begin{split} &\overline{H}(\boldsymbol{U}|\boldsymbol{V}) \equiv \text{p-limsup} \, \frac{1}{n} \log_2 \frac{1}{\mu_{U_n|V_n}(U_n|V_n)} \\ &\underline{H}(\boldsymbol{U}|\boldsymbol{V}) \equiv \text{p-liminf} \, \frac{1}{n} \log_2 \frac{1}{\mu_{U_n|V_n}(U_n|V_n)}. \end{split}$$

In the following, we introduce some inequalities that we use in the proof of the converse part. Trivially, we have

$$\overline{H}(U|V) \geqslant \underline{H}(U|V) \geqslant 0.$$

We show the following lemmas.

Lemma 10 ( [17, Lemma 3.2.1, Definition 4.1.3]): For general sources  $U = \{U_n\}_{n=1}^{\infty}$  and  $V = \{V_n\}_{n=1}^{\infty}$ , we have

$$\operatorname{p-liminf}_{n\to\infty}\frac{1}{n}\log_2\frac{\mu_{U_n}(U_n)}{\mu_{V_n}(U_n)}\geqslant 0.$$

*Proof:* For completeness, we show the lemma as the proof of [17, Lemma 3.2.1, Definition 4.1.3]. For a given  $\gamma > 0$ , let  $\mathcal{U}'_n$  be defined as

$$\mathcal{U}'_n \equiv \left\{ \boldsymbol{u} : \frac{1}{n} \log_2 \frac{\mu_{U_n}(\boldsymbol{u})}{\mu_{V_n}(\boldsymbol{u})} < -\gamma \right\}. \tag{46}$$

Then we have  $\mu_{U_n}(u) < \mu_{V_n}(u)2^{-n\gamma}$  for all  $u \in \mathcal{U}'_n$ . We have

$$P\left(\frac{1}{n}\log_{2}\frac{\mu_{U_{n}}(U_{n})}{\mu_{V_{n}}(U_{n})} < -\gamma\right) = \sum_{\boldsymbol{u}\in\mathcal{U}_{n}'}\mu_{U_{n}}(\boldsymbol{u})$$

$$< \sum_{\boldsymbol{u}\in\mathcal{U}_{n}'}\mu_{V_{n}}(\boldsymbol{u})2^{-n\gamma}$$

$$\leq 2^{-n\gamma}, \tag{47}$$

which implies

$$\operatorname{p-liminf}_{n\to\infty} \frac{1}{n} \log_2 \frac{\mu_{U_n}(\boldsymbol{u})}{\mu_{V_n}(\boldsymbol{u})} \geqslant -\gamma$$

from the definition of the limit inferior in probability. The lemma is proven by letting  $\gamma \to 0$ .

Lemma 11: For a triplet of general sources  $(U, V, W) = \{(U_n, V_n, W_n)\}_{n=1}^{\infty}$ , we have  $\overline{H}(U|V) \ge \overline{H}(U|V, W)$ . Proof: We have

$$\overline{H}(\boldsymbol{U}|\boldsymbol{V}) - \overline{H}(\boldsymbol{U}|\boldsymbol{V}, \boldsymbol{W}) = \operatorname{p-limsup}_{n \to \infty} \frac{1}{n} \log_2 \frac{1}{\mu_{U_n|V_n}(U_n|V_n)} - \operatorname{p-limsup}_{n \to \infty} \frac{1}{n} \log_2 \frac{1}{\mu_{U_n|V_n}(U_n|V_n)}$$

$$= \operatorname{p-limsup}_{n \to \infty} \frac{1}{n} \log_2 \frac{1}{\mu_{U_n|V_n}(U_n|V_n)} + \operatorname{p-liminf}_{n \to \infty} \frac{1}{n} \log_2 \mu_{U_n|V_nW_n}(U_n|V_n, W_n)$$

$$\geqslant \operatorname{p-liminf}_{n \to \infty} \frac{1}{n} \log_2 \frac{\mu_{U_n|V_nW_n}(U_n|V_n, W_n)}{\mu_{U_n|V_n}(U_n|V_n)}$$

$$= \operatorname{p-liminf}_{n \to \infty} \frac{1}{n} \log_2 \frac{\mu_{U_nV_nW_n}(U_n, V_n, W_n)}{\mu_{U_n|V_n}(U_n|V_n) \mu_{V_nW_n}(V_n, W_n)}$$

$$\geqslant 0, \tag{48}$$

where the second equality comes from (45), the first inequality comes from (44), and the second inequality comes from Lemma 10.

The following lemma is analogous to the Fano inequality.

Lemma 12 ( [22, Lemma 4] [27, Lemma 7]): Let  $(U, V) \equiv \{(U_n, V_n)\}_{n=1}^{\infty}$  be a sequence of two random variables. If there is a sequence  $\{\Psi_n\}_{n=1}^{\infty}$  of (possibly stochastic) functions independent of (U, V) that satisfy the condition

$$\lim_{n \to \infty} P(\Psi_n(V_n) \neq U_n) = 0, \tag{49}$$

then

$$\overline{H}(\boldsymbol{U}|\boldsymbol{V}) = 0.$$

*Proof:* When  $\{\Psi_n\}_{n=1}^{\infty}$  is a sequence of deterministic functions, the lemma is the same as [27, Lemma 7]. For completeness, we show this lemma following to the proof of [17, Lemma 1.3.2].

Let  $\{\psi_n\}_{n=1}^{\infty}$  be a sequence of deterministic functions satisfying

$$\lim_{n \to \infty} P(\psi_n(V_n) \neq U_n) = 0. \tag{50}$$

For  $\gamma > 0$ , let

$$\mathcal{W} \equiv \left\{ (\boldsymbol{u}, \boldsymbol{v}) : \frac{1}{n} \log_2 \frac{1}{\mu_{U_n | V_n}(\boldsymbol{u} | \boldsymbol{v})} \ge \gamma \right\}$$
$$\mathcal{E} \equiv \left\{ (\boldsymbol{u}, \boldsymbol{v}) : \psi_n(\boldsymbol{v}) \ne \boldsymbol{u} \right\}.$$

Then we have

$$P\left(\frac{1}{n}\log_{2}\frac{1}{\mu_{U_{n}|V_{n}}(U_{n}|V_{n})} > \gamma\right) \leq \mu_{U_{n}V_{n}}(W)$$

$$= \mu_{U_{n}V_{n}}(W \cap \mathcal{E}) + \mu_{U_{n}V_{n}}(W \cap \mathcal{E}^{\complement})$$

$$= \mu_{U_{n}V_{n}}(W \cap \mathcal{E}) + \sum_{(\boldsymbol{u},\boldsymbol{v}) \in \mathcal{W} \cap \mathcal{E}^{\complement}} \mu_{U_{n}V_{n}}(\boldsymbol{u},\boldsymbol{v})$$

$$= \mu_{U_{n}V_{n}}(W \cap \mathcal{E}) + \sum_{\boldsymbol{v} \in \mathcal{V}_{n}} \mu_{V_{n}}(\boldsymbol{v}) \sum_{\substack{\boldsymbol{u} \in \mathcal{U}_{n}: \\ \psi_{n}(\boldsymbol{v}) = \boldsymbol{u}}} \mu_{U_{n}|V_{n}}(\boldsymbol{u}|\boldsymbol{v})$$

$$\leq \mu_{U_{n}V_{n}}(W \cap \mathcal{E}) + \sum_{\boldsymbol{v} \in \mathcal{V}_{n}} \mu_{V_{n}}(\boldsymbol{v}) \sum_{\boldsymbol{u} \in \mathcal{U}_{n}: \psi_{n}(\boldsymbol{v}) = \boldsymbol{u}} 2^{-n\gamma}$$

$$\leq P(\psi_{n}(V_{n}) \neq U_{n}) + 2^{-n\gamma}, \tag{51}$$

where the second inequality comes from the definition of W and the last inequality comes from the fact that for all v there is a unique u satisfying  $\psi_n(v) = u$ . From this inequality and (49), we have

$$\lim_{n\to\infty} \mathbf{P}\left(\frac{1}{n}\log_2\frac{1}{\mu_{U_n|V_n}(U_n|V_n)}>\gamma\right)=0.$$

Then we have

$$0 \leqslant \overline{H}(\boldsymbol{U}|\boldsymbol{V}) \leqslant \gamma$$

from the definition of  $\overline{H}(U|V)$ . We have  $\overline{H}(U|V) = 0$  by letting  $\gamma \to 0$ .

When  $\{\Psi_n\}_{n=1}^{\infty}$  is a sequence of stochastic functions, we can obtain sequence  $\{\psi_n\}_{n=1}^{\infty}$  of deterministic functions such that

$$P(\psi_n(V_n) \neq U_n) \leq \sum_{\psi_n} P(\Psi_n = \psi_n) P(\psi_n(V_n) \neq U_n)$$
$$= P(\Psi_n(V_n) \neq U_n)$$

for all  $n \in \mathbb{N}$  from the random coding argument and the fact that  $\Psi_n$  is independent of  $(U_n, V_n)$ . Then we have the fact that (49) implies (50) and  $\overline{H}(U|V) = 0$ .

## C. $(\alpha, \beta)$ -hash property

In this section, we review the hash property introduced in [27] [31] and show two basic lemmas. For set  $\mathcal{F}$  of functions, let  $\operatorname{Im} \mathcal{F} \equiv \bigcup_{f \in \mathcal{F}} \{f(z) : z \in \mathcal{Z}^n\}$ .

Definition  $\tilde{I}$  ([27, Definition 3]): Let  $\mathcal{F}_n$  be a set of functions on  $\mathcal{U}^n$ . For probability distribution  $p_{F_n}$  on  $\mathcal{F}_n$ , we call pair  $(\mathcal{F}_n, p_{F_n})$  an ensemble. Then,  $(\mathcal{F}_n, p_{F_n})$  has an  $(\alpha_{F_n}, \beta_{F_n})$ -hash property if there is pair  $(\alpha_{F_n}, \beta_{F_n})$  depending on  $p_{F_n}$  such that

$$\sum_{\substack{\boldsymbol{z}' \in \mathcal{Z}^n \setminus \{\boldsymbol{z}\}:\\ p_{F_n}(\{f: f(\boldsymbol{z}) = f(\boldsymbol{z}')\}) > \frac{\alpha_{F_n}}{|\operatorname{Im}\mathcal{F}_n|}}} p_{F_n}\left(\left\{f: f(\boldsymbol{z}) = f(\boldsymbol{z}')\right\}\right) \leqslant \beta_{F_n}$$
(52)

for any  $z \in \mathbb{Z}^n$ . Consider the following conditions for two sequences  $\alpha_F \equiv \{\alpha_{F_n}\}_{n=1}^{\infty}$  and  $\beta_F \equiv \{\beta_{F_n}\}_{n=1}^{\infty}$ 

$$\lim_{n \to \infty} \alpha_{F_n} = 1 \tag{53}$$

$$\lim_{n \to \infty} \beta_{F_n} = 0. \tag{54}$$

Then, we can say that  $(\mathcal{F}, p_F)$  has an  $(\alpha_F, \beta_F)$ -hash property if  $\alpha_F$  and  $\beta_F$  satisfy (52)–(54). Throughout this paper, we omit the dependence of  $\mathcal{F}$  and F on n.

It should be noted that when  $\mathcal{F}$  is a two-universal class of hash functions [10] and  $p_F$  is the uniform distribution on  $\mathcal{F}$ , then  $(\mathcal{F}, p_F)$  has a (1,0)-hash property, where  $1 \equiv (1,1,\ldots)$  and  $0 \equiv (0,0,\ldots)$ . Random binning [7] and the set of all linear functions [8] are two-universal classes of hash functions. It is proved in [31, Section III-B] that an ensemble of sparse matrices has a hash property.

First, we introduce the lemma for a joint ensemble.

Lemma 13 ( [31, Lemma 4 of the extended version] [27, Lemma 3] ): Let  $(\mathcal{F}, p_F)$  and  $(\mathcal{G}, p_G)$  be ensembles of functions on the same set  $\mathcal{Z}^n$ . Assume that  $(\mathcal{F}, p_F)$  (resp.  $(\mathcal{G}, p_G)$ ) has an  $(\alpha_F, \beta_F)$ -hash (resp.  $(\alpha_G, \beta_G)$ -hash) property. Let  $(f, g) \in \mathcal{F} \times \mathcal{G}$  be a function defined as

$$(f,g)(z) \equiv (f(z),g(z))$$
 for each  $z \in \mathbb{Z}^n$ .

Let  $p_{(F,G)}$  be a joint distribution on  $\mathcal{F} \times \mathcal{G}$  defined as

$$p_{(F,G)}(f,g) \equiv p_F(f)p_G(g)$$
 for each  $(f,g) \in \mathcal{F} \times \mathcal{G}$ .

Then the ensemble  $(\mathcal{F} \times \mathcal{G}, p_{(F,G)})$  has an  $(\alpha_{(F,G)}, \beta_{(F,G)})$ -hash property, where  $\alpha_{(F,G)}$  and  $\beta_{(F,G)}$  are defined as

$$\alpha_{(F,G)} \equiv \alpha_F \alpha_G$$

$$\beta_{(F,G)} \equiv \beta_F + \beta_G.$$

*Proof:* We show this lemma for completeness. Let

$$p_{F,z,z'} \equiv p_F(\{f : f(z) = f(z')\})$$

$$p_{G,z,z'} \equiv p_G(\{g : g(z) = g(z')\})$$

$$p_{(F,G),z,z'} \equiv p_{(F,G)}(\{(f,g) : (f,g)(z) = (f,g)(z')\}).$$

Then we have

$$\sum_{\substack{\boldsymbol{z}' \in \mathcal{Z}^n \setminus \{\boldsymbol{z}\}: \\ p_{(F,G),\boldsymbol{u},\boldsymbol{u}'} > \frac{\alpha_{(F,G)}}{|\operatorname{Im} F \times \mathcal{G}|}}} p_{(F,G)}(\{(f,g): (f,g)\boldsymbol{z} = (f,g)\boldsymbol{z}'\})$$

$$\leqslant \sum_{\substack{\boldsymbol{z}' \in \mathcal{Z}^n \setminus \{\boldsymbol{z}\}: \\ p_{F,\boldsymbol{z},\boldsymbol{z}'} p_{G,\boldsymbol{z},\boldsymbol{z}'} > \frac{\alpha_F \alpha_G}{|\operatorname{Im} F|(\operatorname{Im} \mathcal{G})}}}} p_{F,\boldsymbol{z},\boldsymbol{z}'} p_{G,\boldsymbol{z},\boldsymbol{z}'}$$

$$= \sum_{\substack{\mathbf{z}' \in \mathcal{Z}^{n} \setminus \{\mathbf{z}\}: \\ p_{F,\mathbf{z},\mathbf{z}'}p_{G,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{F}\alpha_{G}}{|\operatorname{Im}\mathcal{F}||\operatorname{Im}\mathcal{G}|}}} p_{F,\mathbf{z},\mathbf{z}'}p_{G,\mathbf{z},\mathbf{z}'} + \sum_{\substack{\mathbf{z}' \in \mathcal{Z}^{n} \setminus \{\mathbf{z}\}: \\ p_{F,\mathbf{z},\mathbf{z}'}p_{G,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{F}\alpha_{G}}{|\operatorname{Im}\mathcal{F}||\operatorname{Im}\mathcal{G}|}}} p_{F,\mathbf{z},\mathbf{z}'}p_{G,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{F}\alpha_{G}}{|\operatorname{Im}\mathcal{F}||\operatorname{Im}\mathcal{G}|}}$$

$$\leq \sum_{\substack{\mathbf{z}' \in \mathcal{Z}^{n} \setminus \{\mathbf{z}\}: \\ p_{F,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{F}}{|\operatorname{Im}\mathcal{F}|}}} p_{F,\mathbf{z},\mathbf{z}'}p_{G,\mathbf{z},\mathbf{z}'} + \sum_{\substack{\mathbf{z}' \in \mathcal{Z}^{n} \setminus \{\mathbf{z}\}: \\ p_{G,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{G}}{|\operatorname{Im}\mathcal{G}|}}}} p_{F,\mathbf{z},\mathbf{z}'}p_{G,\mathbf{z},\mathbf{z}'}$$

$$\leq \sum_{\substack{\mathbf{z}' \in \mathcal{Z}^{n} \setminus \{\mathbf{z}\}: \\ p_{F,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{F}}{|\operatorname{Im}\mathcal{F}|}}} p_{F,\mathbf{z},\mathbf{z}'} + \sum_{\substack{\mathbf{z}' \in \mathcal{Z}^{n} \setminus \{\mathbf{z}\}: \\ p_{G,\mathbf{z},\mathbf{z}'} > \frac{\alpha_{G}}{|\operatorname{Im}\mathcal{G}|}}}} p_{G,\mathbf{z},\mathbf{z}}$$

$$= \beta_{F} + \beta_{G}$$

$$= \beta_{(F,G)},$$
(55)

where the first inequality comes from the fact that F and G are mutually independent and  $\operatorname{Im}\mathcal{F}\times\mathcal{G}\subset\operatorname{Im}\mathcal{F}\times\operatorname{Im}\mathcal{G}$ , and the last inequality comes from the fact that  $p_{F,\boldsymbol{z},\boldsymbol{z}'}\leqslant 1$  and  $p_{G,\boldsymbol{z},\boldsymbol{z}'}\leqslant 1$ . Then we have the fact that  $(\mathcal{F}\times\mathcal{G},p_{(F,G)})$  has an  $(\alpha_{(F,G)},\beta_{(F,G)})$ -hash property.

Next, we introduce lemmas that are multiple extensions of the *balanced-coloring property* and the *collision-resistant property*. We use the following notations. For each  $s \in \mathcal{S}$ , let  $\mathcal{F}_s$  be a set of functions on  $\mathcal{Z}_s^n$  and  $\mathbf{c}_s \in \operatorname{Im} \mathcal{F}_s$ . Let  $\mathcal{Z}_{S'}^n \equiv \times_{s \in \mathcal{S}'} \mathcal{Z}_s^n$  and

$$\begin{split} \alpha_{F_{\mathcal{S}'}} &\equiv \prod_{s \in \mathcal{S}'} \alpha_{F_s} \\ \beta_{F_{\mathcal{S}'}} &\equiv \prod_{s \in \mathcal{S}'} \left[\beta_{F_s} + 1\right] - 1, \end{split}$$

where  $\prod_{s \in \emptyset} \theta_s \equiv 1$ . It should be noted that

$$\lim_{n \to \infty} \alpha_{F_{S'}} = 1$$

$$\lim_{n \to \infty} \beta_{F_{S'}} = 0$$

for every  $\mathcal{S}' \subset \mathcal{S}$  when  $(\alpha_{F_s}, \beta_{F_s})$  satisfies (53) and (54) for all  $s \in \mathcal{S}$ . For  $\mathcal{T} \subset \mathcal{Z}_{\mathcal{S}}^n$  and  $\mathbf{z}_{\mathcal{S}'} \in \mathcal{Z}_{\mathcal{S}'}^n$ , let  $\mathcal{T}_{\mathcal{S}'}$  and  $\mathcal{T}_{\mathcal{S}'^c|\mathcal{S}'}(\mathbf{z}_{\mathcal{S}'})$  be defined as

$$= \sum_{(\boldsymbol{z}_{\mathcal{D}},\boldsymbol{y})\in\overline{\mathcal{T}}_{Z_{\mathcal{D}}}}\mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}},\boldsymbol{y})E_{F_{\mathcal{D}}}\left[\chi(\check{\boldsymbol{z}}_{\mathcal{D}}(F_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}})|\boldsymbol{y}) \neq \boldsymbol{z}_{\mathcal{D}})\right] + \sum_{(\boldsymbol{z}_{\mathcal{D}},\boldsymbol{y})\in\overline{\mathcal{T}}_{Z_{\mathcal{D}}}^{c}}\mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}},\boldsymbol{y})E_{F_{\mathcal{D}}}\left[\chi(\check{\boldsymbol{z}}_{\mathcal{D}}(F_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}})|\boldsymbol{y}) \neq \boldsymbol{z}_{\mathcal{D}})\right]$$

$$\leqslant \sum_{\mathcal{D}\in\mathcal{D}}\alpha_{F_{\mathcal{D}'}}\left[\beta_{F_{\mathcal{D}\setminus\mathcal{D}'}} + 1\right]\frac{2^{n[\overline{H}(\boldsymbol{Z}_{\mathcal{D}'}|\boldsymbol{Y},\boldsymbol{Z}_{\mathcal{D}\setminus\mathcal{D}'}) + \varepsilon}}{\prod_{s\in\mathcal{D}'}|\mathrm{Im}\mathcal{F}_{s}|} + \beta_{F_{\mathcal{D}}} + \mu_{Z_{\mathcal{D}}Y}(\overline{\mathcal{T}}^{\complement}). \tag{73}$$

Next, we show the following lemma.

Lemma 18 ( [29, Lemma 2 in the extended version]): The expectation of the decoding error probability is evaluated as follows

$$E_{F_{\mathcal{D}}}\left[\mu_{Z_{\mathcal{D}}\hat{Z}_{\mathcal{D}}}\left(\left\{\left(z_{\mathcal{D}},\hat{z}_{\mathcal{D}}\right):\hat{z}_{\mathcal{D}}\neq z_{\mathcal{D}}\right\}\right)\right]$$

$$\leq 2\sum_{\mathcal{D}'\subset\mathcal{D}:\mathcal{D}'\neq\varnothing}\alpha_{F_{\mathcal{D}'}}\left[\beta_{F_{\mathcal{D}\setminus\mathcal{D}'}}+1\right]2^{-n\left[\sum_{s\in\mathcal{D}'}r_{s}-\overline{H}(\mathbf{Z}_{\mathcal{D}'}|\mathbf{Y},\mathbf{Z}_{\mathcal{D}\setminus\mathcal{D}'})-\varepsilon\right]}+2\beta_{F_{\mathcal{D}}}+2\mu_{Z_{\mathcal{D}}Y}(\overline{\mathcal{T}}^{\complement}),\tag{74}$$

where  $C_s \equiv \text{Im}\mathcal{F}_s$  and the decoding error probability  $\mu_{Z_{\mathcal{D}}\hat{Z}_{\mathcal{D}}}\left(\{(\boldsymbol{z}_{\mathcal{D}},\hat{\boldsymbol{z}}_{\mathcal{D}}):\hat{\boldsymbol{z}}_{\mathcal{D}}\neq\boldsymbol{z}_{\mathcal{D}}\}\right)$  depends on  $f_{\mathcal{D}}$  through the relation (70).

*Proof:* For given  $f_{\mathcal{D}}$ , the joint distribution of  $(Z_{\mathcal{D}}^n, C_{\mathcal{D}}^{(n)}, Y^n)$  is given as

$$\mu_{Z_{\mathcal{D}}C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y}) = \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})\chi(f_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) = \boldsymbol{c}_{\mathcal{D}}).$$

Then we have

$$\mu_{Z_{\mathcal{D}}|C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}|\boldsymbol{c}_{\mathcal{D}},\boldsymbol{y}) \equiv \frac{\mu_{Z_{\mathcal{D}}C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}},\boldsymbol{c}_{\mathcal{D}},\boldsymbol{y})}{\sum_{\boldsymbol{z}_{\mathcal{D}}\in\mathcal{Z}_{\mathcal{D}}^{n}}\mu_{Z_{\mathcal{D}}C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}},\boldsymbol{c}_{\mathcal{D}},\boldsymbol{y})}$$

Ш

$$= \frac{\mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})\chi(f_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) = \boldsymbol{c}_{\mathcal{D}})}{\sum_{\boldsymbol{z}_{\mathcal{D}}\in\mathcal{Z}_{\mathcal{D}}^{n}}\mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})\chi(f_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) = \boldsymbol{c}_{\mathcal{D}})}$$

$$= \frac{\mu_{Z_{\mathcal{D}}|Y}(\boldsymbol{z}_{\mathcal{D}}|\boldsymbol{y})\chi(f_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) = \boldsymbol{c}_{\mathcal{D}})}{\sum_{\boldsymbol{z}_{\mathcal{D}}\in\mathcal{Z}_{\mathcal{D}}^{n}}\mu_{Z_{\mathcal{D}}|Y}(\boldsymbol{z}_{\mathcal{D}}|\boldsymbol{y})\chi(f_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) = \boldsymbol{c}_{\mathcal{D}})}$$

$$= \mu_{\hat{Z}_{\mathcal{D}}|C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}|\boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y}), \tag{75}$$

that is, the constrained-random-number generator defined by (30) is a stochastic decision with  $\mu_{Z_D|C_DY}$ . By letting

$$\mu_{\check{Z}_{\mathcal{D}}|C_{\mathcal{D}}Y}(\check{z}_{\mathcal{D}}|c_{\mathcal{D}},y) \equiv \chi(\check{z}_{\mathcal{D}}(c_{\mathcal{D}}|y) = \check{z}_{\mathcal{D}}),$$

we have the fact that

$$\mu_{Z_{\mathcal{D}}\widehat{Z}_{\mathcal{D}}}(\{(\boldsymbol{z}_{\mathcal{D}}, \hat{\boldsymbol{z}}_{\mathcal{D}}) : \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}\}) = \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}, \boldsymbol{c}_{\mathcal{D}} \in \mathcal{C}_{\mathcal{D}}, \\ \boldsymbol{y} \in \mathcal{Y}^{n}, \hat{\boldsymbol{z}}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}} \mu_{Z_{\mathcal{D}}C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y}), \hat{\boldsymbol{z}}_{\mathcal{D}}|C_{\mathcal{D}}Y}(\hat{\boldsymbol{z}}_{\mathcal{D}}|\boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y})$$

$$= \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}, \boldsymbol{c}_{\mathcal{D}} \in \mathcal{C}_{\mathcal{D}}, \\ \boldsymbol{y} \in \mathcal{Y}^{n}, \hat{\boldsymbol{z}}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}} \mu_{Z_{\mathcal{D}}C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y}) \mu_{Z_{\mathcal{D}}|C_{\mathcal{D}}Y}(\hat{\boldsymbol{z}}_{\mathcal{D}}|\boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y})$$

$$\leq 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \boldsymbol{y} \in \mathcal{Y}^{n}, \hat{\boldsymbol{z}}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}} \mu_{Z_{\mathcal{D}}C_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y}) \mu_{\tilde{Z}_{\mathcal{D}}|C_{\mathcal{D}}Y}(\hat{\boldsymbol{z}}_{\mathcal{D}}|\boldsymbol{c}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \boldsymbol{z}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y}) \chi(f_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) = \boldsymbol{c}_{\mathcal{D}}) \chi(\check{\boldsymbol{z}}_{\mathcal{D}}(\boldsymbol{c}_{\mathcal{D}}|\boldsymbol{y}) = \check{\boldsymbol{z}}_{\mathcal{D}})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}} \in \mathcal{Z}_{\mathcal{D}}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}} \in \mathcal{Z}_{\mathcal{D}^{n}: \\ \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}}}}} \mu_{Z_{\mathcal{D}}Y}(\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y})$$

$$= 2 \sum_{\substack{\boldsymbol{z}_{\mathcal{D}$$

where the second equality comes from (69), the first inequality comes from Lemma 20 in Appendix F, and the third equality comes from (70). Then we have the fact that

$$E_{F_{\mathcal{D}}} \left[ \mu_{Z_{\mathcal{D}} \hat{Z}_{\mathcal{D}}} \left( \left\{ (\boldsymbol{z}_{\mathcal{D}}, \hat{\boldsymbol{z}}_{\mathcal{D}}) : \hat{\boldsymbol{z}}_{\mathcal{D}} \neq \boldsymbol{z}_{\mathcal{D}} \right\} \right) \right]$$

$$\leq 2E_{F_{\mathcal{D}}} \left[ \mu_{Z_{\mathcal{D}} Y} \left( \left\{ (\boldsymbol{z}_{\mathcal{D}}, \boldsymbol{y}) : \check{\boldsymbol{z}}_{\mathcal{D}} (F_{\mathcal{D}}(\boldsymbol{z}_{\mathcal{D}}) | \boldsymbol{y}) \neq \boldsymbol{z}_{\mathcal{D}} \right\} \right) \right]$$

$$\leq 2\sum_{\mathcal{D}' \subset \mathcal{D}: \mathcal{D}' \neq \emptyset} \alpha_{F_{\mathcal{D}'}} \left[ \beta_{F_{\mathcal{D} \setminus \mathcal{D}'}} + 1 \right] 2^{-n \left[ \sum_{s \in \mathcal{D}'} r_s - \overline{H}(\boldsymbol{Z}_{\mathcal{D}'} | \boldsymbol{Y}, \boldsymbol{Z}_{\mathcal{D} \setminus \mathcal{D}'}) - \varepsilon \right]} + 2\beta_{F_{\mathcal{D}}} + 2\mu_{Z_{\mathcal{D}} Y} (\overline{\mathcal{T}}^{\mathcal{L}}),$$

$$(77)$$

where we use the relation  $r_s = \log_2(|\mathcal{C}_s|)/n = \log_2(|\mathrm{Im}\mathcal{F}_s|)/n$  in the last inequality.

### F. Proof of Lemmas

Lemma 19: For any sequence  $\{\theta_k\}_{k=1}^K$  of positive numbers, we have

$$\left| \prod_{k=1}^{K} \theta_k - 1 \right| \le \sum_{k=1}^{K} |\theta_k - 1| \prod_{k'=k+1}^{K} \theta_{k'}, \tag{78}$$

where  $\prod_{k'=K+1}^K \theta_{k'} \equiv 1$ . *Proof:* When K=1, (78) is trivial. Assume that (78) is satisfied, then we have

$$\begin{split} \left| \prod_{k=1}^{K+1} \theta_k - 1 \right| &\leqslant \left| \prod_{k=1}^{K+1} \theta_k - \theta_{K+1} \right| + \left| \theta_{K+1} - 1 \right| \\ &= \left| \prod_{k=1}^{K} \theta_k - 1 \right| \theta_{K+1} + \left| \theta_{K+1} - 1 \right| \\ &\leqslant \left[ \sum_{k=1}^{K} \left| \theta_k - 1 \right| \prod_{k'=k+1}^{K} \theta_{k'} \right] \theta_{K+1} + \left| \theta_{K+1} - 1 \right| \end{split}$$

$$= \sum_{k=1}^{K+1} |\theta_k - 1| \prod_{k'=k+1}^{K+1} \theta_{k'}, \tag{79}$$

where the first inequality comes from the triangle inequality, the second inequality comes from the assumption, and the last equality comes from the fact that  $|\theta_{K+1}-1|\prod_{k'=K+1+1}^{K+1}\theta_{k'}=|\theta_{K+1}-1|$ . Then the lemma is shown by induction.

Lemma 20 ( [36, Lemma 4] [34, Corollary 2]): Let (U,V) be a pair consisting of state  $U \in \mathcal{U}$  and observation  $V \in \mathcal{V}$ ,

where  $\mu_{UV}$  is the joint distribution of (U, V). We make a stochastic decision with  $\mu_{U|V}$  that guesses state U by  $\hat{U} \in \mathcal{U}$ , that is, the joint distribution of  $(U, V, \hat{U})$  is given as

$$\mu_{UV\widehat{U}}(u, v, \widehat{u}) \equiv \mu_{UV}(u, v)\mu_{U|V}(\widehat{u}|v).$$

Then the decision error probability of this rule is at most twice the decision error probability of any (possibly stochastic) decision, that is,

$$\sum_{\substack{u \in \mathcal{U}, v \in \mathcal{V}, \hat{u} \in \mathcal{U}: \\ \hat{u} \neq v}} \mu_{UV}(u, v) \mu_{U|V}(\hat{u}|v) \leqslant 2 \sum_{\substack{u \in \mathcal{U}, v \in \mathcal{V}, \check{u} \in \mathcal{U}: \\ \check{u} \neq v}} \mu_{UV}(u, v) \mu_{\check{U}|V}(\check{u}|v)$$

for any arbitrary probability distribution  $\mu_{\check{U}|V}$ .

*Proof:* Here, we show the lemma directly for the completeness of this paper. We have

$$\sum_{u \in \mathcal{U}, v \in \mathcal{V}, \hat{u} \in \mathcal{U}:} \mu_{UV}(u, v) \mu_{U|V}(\hat{u}|v) = \sum_{u \in \mathcal{U}, v \in \mathcal{V}} \mu_{UV}(u, v) [1 - \mu_{U|V}(u|v)]$$

$$= \sum_{u \in \mathcal{U}, v \in \mathcal{V}} [\mu_{U|V}(u|v) - \mu_{U|V}(u|v)^{2}] \mu_{V}(v)$$

$$\leq \sum_{u \in \mathcal{U}, v \in \mathcal{V}} [\mu_{U|V}(u|v) - \mu_{U|V}(u|v)^{2}] \mu_{V}(v) + \sum_{u \in \mathcal{U}, v \in \mathcal{V}} [\mu_{U|V}(u|v) - \mu_{\tilde{U}|V}(u|v)] \mu_{V}(v)$$

$$+ \sum_{u \in \mathcal{U}, v \in \mathcal{V}} [\mu_{U|V}(u|v) - \mu_{\tilde{U}|V}(u|v)]^{2} \mu_{V}(v) + \sum_{u \in \mathcal{U}, v \in \mathcal{V}} \mu_{\tilde{U}|V}(u|v) [1 - \mu_{\tilde{U}|V}(u|v)] \mu_{V}(v)$$

$$= \sum_{u \in \mathcal{U}, v \in \mathcal{V}} 2\mu_{U|V}(u|v) [1 - \mu_{\tilde{U}|V}(u|v)] \mu_{V}(v)$$

$$= 2 \sum_{u \in \mathcal{U}, v \in \mathcal{V}} \mu_{UV}(u, v) [1 - \mu_{\tilde{U}|V}(u|v)]$$

$$= 2 \sum_{u \in \mathcal{U}, v \in \mathcal{V}} \mu_{UV}(u, v) [1 - \mu_{\tilde{U}|V}(u|v)]$$

$$= 2 \sum_{u \in \mathcal{U}, v \in \mathcal{V}} \mu_{UV}(u, v) [1 - \mu_{\tilde{U}|V}(u|v)]$$

$$= 2 \sum_{u \in \mathcal{U}, v \in \mathcal{V}, \tilde{u} \in \mathcal{U}:} \mu_{UV}(u, v) \mu_{\tilde{U}|V}(u|v), \qquad (80)$$

where the inequality comes from the fact that  $\sum_{u \in \mathcal{U}} \mu_{U|V}(u|v) = \sum_{u \in \mathcal{U}} \mu_{\check{U}|V}(u|v) = 1$ , and  $\mu_{\check{U}|V}(u|v) \in [0,1]$  for all  $u \in \mathcal{U}$ and  $v \in \mathcal{V}$ .
