On the Global Convergence of Fitted Q-Iteration with Two-layer Neural Network Parametrization

Abstract

Deep Q-learning based algorithms have been applied successfully in many decision making problems, while their theoretical foundations are not as well understood. In this paper, we study a Fitted Q-Iteration with two-layer ReLU neural network parameterization, and find the sample complexity guarantees for the algorithm. Our approach estimates the Q-function in each iteration using a convex optimization problem. We show that this approach achieves a sample complexity of $\tilde{\mathcal{O}}(1/\epsilon^2)$, which is order-optimal. This result holds for a countable state-spaces and does not require any assumptions such as a linear or low rank structure on the MDP.

1. Introduction

Reinforcement learning aims to maximize the cumulative rewards wherein an agent interacts with the system in a sequential manner, and has been used in many applications including games Silver et al. (2017); Vinyals et al. (2017); Bonjour et al. (2022), robotics Maes et al. (2003), autonomous driving Kiran et al. (2022), ride-sharing Al-Abbasi et al. (2019), networking Geng et al. (2020), recommender systems WARLOP et al. (2018), etc. One of the key class of algorithms used in reinforcement learning are those based on Q-learning. Due to large state space (possibly infinite), such algorithms are parameterized Van Hasselt et al. (2016). However, with general parametrization (e.g., neural network parametrization), sample complexity guarantees to achieve an ϵ gap to the optimal Q-values have not been fully understood. In this paper, we study this problem to provide the first sample complexity results for Q-learning based algorithm with neural network parametrization.

We note that most of the theoretical results for Q-learning based algorithms have been in tabular setups which assume finite states such as in Li et al. (2020); Jin et al. (2018), or assume a linear function approximation Carvalho et al. (2020); Wang et al. (2021a); Chen et al. (2022); Zhou et al. (2021) where the linear representation is assumed to be known. Although practically large state spaces are handled using deep neural networks due to the universal approximation theorem, the theoretical analysis with neural network parametrization of Q-learning is challenging as the training of neural network involves solving a non-convex optimization problem. Recently, the authors of Fan et al. (2020) studied the problem of neural network parametrization for Q-learning based algorithms, and provided the asymptotic global convergence guarantees when the parameters of the neural

network used to approximate the Q function are large. In this paper, we study the first results on sample complexity to achieve the global convergence of Q-learning based algorithm with neural network parametrization.

In this paper, we propose a fitted Q-Iteration based algorithm, wherein the Q-function is parametrized by a two-layer ReLU network. The key for the two-layer ReLU network is that finding the optimal parameters for estimating the Q-function could be converted to a convex problem. In order to reduce the problem from non-convex to convex, one can replace the ReLU function with an equivalent diagonal matrix. Further, the minima of both the non-convex ReLU optimization and the equivalent convex optimization are same Wang et al. (2021b); Pilanci and Ergen (2020).

We find the sample complexity for fitted Q-Iteration based algorithm with neural network parametrization. The gap between the learnt Q-function and the optimal Q-function arises from the parametrization error due to the 2-layer neural network, the error incurred due to imperfect reformulation of the neural network as a convex optimization problem as well as the error due to the random nature of the underlying MDP. This error reduces with increasing the number of iterations of the fitted Q-iteration algorithm, the number of iterations of the convex optimization step, the number of data points sampled at each step. We achieve an overall sample complexity of $\tilde{\mathcal{O}}\left(\frac{1}{(1-\gamma)^4\epsilon^2}\right)$. Our proof consists of expressing the error in estimation of the Q-function at a fixed iteration in terms of the Bellman error incurred at each successive iteration upto that point. We then express the Bellman error in terms of the previously mentioned components for the statistical error. We then upper bound the expectation of these error components with respect to a distribution of the state action space.

2. Related Works

2.1 Fitted Q-Iteration

The analysis of Q-learning based algorithms has been studied since the early 1990's Watkins and Dayan (1992); Singh and Yee (1994), where it was shown that small errors in the approximation of a task's optimal value function cannot produce arbitrarily bad performance when actions are selected by a greedy policy. Value Iteration algorithms, and its analogue Approximate Value iteration for large state spaces has been shown to have finite error bounds as Puterman (2014). Similar analysis for finite state space has been studied in Bertsekas and Tsitsiklis (1996) and Munos (2007).

When the state space is large (possibly infinite), the value function can not be updated at each state action pair at every iteration. Thus, approximate value iteration algorithms are used that obtains samples from state action space at each iteration and estimates the action value function by minimizing a loss which is a function of the sampled state action pairs. This is the basis of the Fitted Q-Iteration, first explained in Boyan and Moore (1994). Instead of updating the Q-function at each step of the trajectory, it collects a batch of sample transitions and updates the Q-functions based on the collected samples and the existing estimate of the Q-function. The obtained samples could be using a generative model Munos (2003); Ghavamzadeh et al. (2008), or using the buffer memory Kozakowski et al. (2022); Wang et al. (2020).

2.2 Deep Neural Networks in Reinforcement Learning

Parametrization of Q-network is required for scaling the Q-learning algorithms to a large state space. Neural networks have been used previously to parameterize the Q-function Tesauro et al. (1995); Xu and Gu (2020); Fujimoto et al. (2019). This approach, also called Deep Q-learning has been widely used in many reinforcement learning applications Yang et al. (2020); Damjanović et al. (2022); Gao et al. (2020). However, fundamental guarantees of Q-learning with such function approximation are limited, because the non-convexity of neural network makes the parameter optimization problem non-convex.

Even though the sample complexity of Q-learning based algorithms have not been widely studied for general parametrization, we note that such results have been studied widely for policy gradient based approaches Agarwal et al. (2020); Wang et al. (2019); Zhang et al. (2022). The policy gradient approaches directly optimize the policy, while still having the challenge that the parametrization makes the optimization of parameters non-convex. This is resolved by assuming that the class of parametrization (e.g., neural networks) is rich in the sense that arbitrary policy could be approximated by the parametrization. However, note that for systems with infinite state spaces, results for policy gradient methods consist of upper bounds on the gradient of the estimate of the average reward function, such as in Yuan et al. (2022). For upper bounds on the error of estimation of the value function, linear structure on the MDP has to be assumed, as is done in Chen and Zhao (2022).

In the case of analysis of Fitted Q-Iteration (FQI) algorithms such as Fan et al. (2020), upper bounds on the error of estimation of the Q-function are obtained by considering sparse Neural networks with ReLU functions and Holder smooth assumptions on the Neural networks. At each iteration of the FQI algorithm, an estimate of the Q-function is obtained by optimizing a square loss error, which is non-convex in the parameters of the neural network used to represent the Q-function. Due to this non-convexity, the upper bounds are asymptotic in terms of the parameters of the neural network and certain unknown constants. Xu and Gu (2020) improves upon this result by demonstrating finite time error bounds for Q-learning with neural network parametrization. However the error bounds obtained can go unbounded as the number of iterations increase (See Appendix A), hence they do not give any sample complexity results. Our result establishes the first sample complexity results for a (possibly) infinite state space without the need for a linear structure on the MDP.

2.3 Neural Networks Parameter Estimation

The global optimization of neural networks has shown to be NP hard Blum and Rivest (1992). Even though Stochastic Gradient Descent algorithms can be tuned to give highly accurate results as in Bengio (2012), convergence analysis of such methods requires assumptions such as infinite width limit such as in Zhu and Xu (2021). Recently, it has been shown that the parameter optimization for two-layer ReLU neural networks can be converted to an equivalent convex program which is exactly solvable and computationally tractable Pilanci and Ergen (2020). Convex formulations for convolutions and deeper models have also been studied Sahiner et al. (2020a,b). In this paper, we will use these approaches for estimating the parameterized Q-function.

3. Problem Setup

We study a discounted Markov Decision Process (MDP), which is described by the tuple $\mathcal{M} = (\mathcal{S}, \mathcal{A}, P, R, \gamma)$, where \mathcal{S} is a bounded measurable state space, \mathcal{A} is the finite set of actions, we represent set of state action pairs as $[0,1]^d$ (a d dimensional tuple with all elements in [0,1]), where d is a positive integer greater than 1. $P: \mathcal{S} \times \mathcal{A} \to \mathcal{P}(\mathcal{S})$ is the probability transition kernel¹. $R: \mathcal{S} \times \mathcal{A} \to \mathcal{P}([0, R_{\text{max}}])$ is the reward kernel on the state action space with R_{max} being the absolute value of the maximum reward and $0 < \gamma < 1$ is the discount factor. A policy $\pi: \mathcal{S} \to \mathcal{P}(\mathcal{A})$ is a mapping that maps state to a probability distribution over the action space. Here, we denote by $\mathcal{P}(\mathcal{S}), \mathcal{P}(\mathcal{A}), \mathcal{P}([a,b])$, the set of all probability distributions over the state space, the action space, and a closed interval [a,b], respectively. We define the action value function for a given policy π respectively as follows.

$$Q^{\pi}(s,a) = \mathbb{E}\left[\sum_{t=0}^{\infty} \gamma^t r'(s_t, a_t) | s_0 = s, a_0 = a\right],\tag{1}$$

where $r'(s_t, a_t) \sim R(\cdot | s_t, a_t)$, $a_{t+1} \sim \pi(\cdot | s_{t+1})$ and $s_{t+1} \sim P(\cdot | s_t, a_t)$ for $t = \{0, \dots, \infty\}$. For a discounted MDP, we define the optimal action value functions as follows:

$$Q^*(s,a) = \sup_{\pi} Q^{\pi}(s,a) \quad \forall (s,a) \in \mathcal{S} \times \mathcal{A}, \tag{2}$$

A policy that achieves the optimal action value functions is known as the *optimal policy* and is denoted as π^* . It can be shown that π^* is the greedy policy with respect to Q^* Bertsekas and Shreve (2007). Hence finding Q^* is sufficient to obtain the optimal policy. We define the Bellman operator for a policy π as follows

$$(T^{\pi}Q)(s,a) = r(s,a) + \gamma \int Q^{\pi}(s',\pi(s'))P(ds'|s,a), \tag{3}$$

where $r(s,a) = \mathbb{E}(r'(s,a)|(s,a))$ Similarly we define the Bellman Optimality Operator as

$$(TQ)(s,a) = \left(r(s,a) + \max_{a' \in \mathcal{A}} \gamma \int Q(s',a') P(ds'|s,a)\right),\tag{4}$$

Further, operator P^{π} is defined as

$$P^{\pi}Q(s,a) = \mathbb{E}[Q(s',a')|s' \sim P(\cdot|s,a), a' \sim \pi(\cdot|s')],\tag{5}$$

which is the one step Markov transition operator for policy π for the Markov chain defined on $\mathcal{S} \times \mathcal{A}$ with the transition dynamics given by $S_{t+1} \sim P(\cdot|S_t, A_t)$ and $A_{t+1} \sim \pi(\cdot|S_{t+1})$. It defines a distribution on the state action space after one transition from the initial state. Similarly, $P^{\pi_1}P^{\pi_2}\cdots P^{\pi_m}$ is the m-step Markov transition operator following policy π_t at steps $1 \leq t \leq m$. It defines a distribution on the state action space after m transitions from the initial state. We have the relation

$$(T^{\pi}Q)(s,a) = r(s,a) + \gamma \int Q^{\pi}(s',\pi(s'))P(ds'|s,a)$$

= $r(s,a) + \gamma(P^{\pi}Q)(s,a)$ (6)

^{1.} For a measurable set \mathcal{X} , let $\mathcal{P}(\mathcal{X})$ denote the set of all probability measures over \mathcal{X} .

Which defines P^* as

$$P^*Q(s,a) = \max_{a' \in \mathcal{A}} \mathbb{E}[Q(s',a')|s' \sim P(\cdot|s,a)],\tag{7}$$

in other words, P^* is the one step Markov transition operator with respect to the greedy policy of the function on which it is acting.

This gives us the relation

$$(TQ)(s,a) = r(s,a) + \gamma P^*Q(s,a), \tag{8}$$

For any measurable function $f: \mathcal{S} \times \mathcal{A} : \to \mathbb{R}$, we also define

$$\mathbb{E}(f)_{\nu} = \int_{\mathcal{S} \times A} f d\nu, \tag{9}$$

for any distribution $\nu \in \mathcal{P}(\mathcal{S} \times \mathcal{A})$.

For representing the action value function, we will use a 2 layer ReLU neural network. A 2-layer ReLU Neural Network with input $x \in \mathbb{R}^d$ is defined as

$$f(x) = \sum_{i=1}^{m} \sigma'(x^T u_i) \alpha_i, \tag{10}$$

where $m \geq 1$ is the number of neurons in the neural network, the parameter space is $\Theta_m = \mathbb{R}^{d \times m} \times \mathbb{R}^m$ and $\theta = (U, \alpha)$ is an element of the parameter space, where u_i is the i^{th} column of U, and α_i is the i^{th} coefficient of α . The function $\sigma' : \mathbb{R} \to \mathbb{R}_{\geq 0}$ is the ReLU or restricted linear function defined as $\sigma'(x) \triangleq \max(x, 0)$. In order to obtain parameter θ for a given set of data $X \in \mathbb{R}^{n \times d}$ and the corresponding response values $y \in \mathbb{R}^{n \times 1}$, we desire the parameter that minimizes the squared loss (with a regularization parameter $\beta \in [0, 1]$), given by

$$\mathcal{L}(\theta) = \underset{\theta}{\operatorname{arg\,min}} || \sum_{i=1}^{m} \sigma(Xu_{i})\alpha_{i} - y||_{2}^{2} + \beta \sum_{i=1}^{m} ||u_{i}||_{2}^{2}$$
$$+\beta \sum_{i=1}^{m} |\alpha_{i}|^{2}$$
(11)

Here, we have the term $\sigma(Xu_i)$ which is a vector $\{\sigma'((x_j)^Tu_i)\}_{j\in\{1,\dots,n\}}$ where x_j is the j^{th} row of X. It is the ReLU function applied to each element of the vector Xu_i . We note that the optimization in Equation (11) is non-convex in θ due to the presence of the ReLU activation function. In Wang et al. (2021b), it is shown that this optimization problem has an equivalent convex form, provided that the number of neurons m goes above a certain threshold value. This convex problem is obtained by replacing the ReLU functions in the optimization problem with equivalent diagonal operators. The convex problem is given as

$$\mathcal{L}'_{\beta}(p) := (\arg \min_{p} || \sum_{D_{i} \in D_{X}} D_{i}(Xp_{i}) - y ||_{2}^{2} + \beta \sum_{D_{i} \in D_{X}} ||p_{i}||_{2}),$$
(12)

where $p \in \mathbb{R}^{d \times |D_X|}$.

 D_X is the set of diagonal matrices D_i which depend on the dataset X. Except for cases of X being low rank it is not computationally feasible to obtain the set D_X . We instead use $\tilde{D} \in D_X$ to solve the convex problem

$$\mathcal{L}'_{\beta}(p) := \left(\underset{p}{\operatorname{arg\,min}} || \sum_{D_i \in \tilde{D}} D_i(Xp_i) - y ||_2^2 + \beta \sum_{D_i \in \tilde{D}} ||p_i||_2 \right)$$

$$(13)$$

where $p \in \mathbb{R}^{d \times |\tilde{D}|}$.

The relevant details of the formulation and the definition of the diagonal matrices D_i are provided in Appendix B. For a set of parameters $\theta = (u, \alpha) \in \Theta$, we denote neural network represented by these parameters as

$$Q_{\theta}(x) = \sum_{i=1}^{m} \sigma'(x^{T} u_{i}) \alpha_{i}$$
(14)

4. Proposed Algorithm

Algorithm 1 Iterative algorithm to estimate Q function

Input: S, A, γ , Time Horizon $K \in Z$, sampling distribution ν , one step transition operator κ , $T_{k:k \in \{1,\dots,K\}}$

Initialize: $\tilde{Q}(s, a) = 0 \ \forall (s, a) \in \mathcal{S} \times \mathcal{A}$

- 1: **for** $k \in \{1, \dots, K\}$ **do**
- 2: sample n i.i.d (s_i, a_i) with s_i, a_i drawn from the sampling distribution ν

Define π_K as the greedy policy with respect to \tilde{Q}

Output: An estimator \hat{Q} of Q^* and π_k as it's greedy policy

In this section, we describe our Neural Network Fitted Q-iteration algorithm. The key in the algorithm is the use of convex optimization for the update of parameters of the Q-function. The algorithm, at each iteration k, updates the estimate of the Q function, here denoted as Q_k . The update at each step in the ideal case is to be done by applying the Bellman optimality operator defined in Equation (3). However, there are two issues which prevent us from doing that. First, we do not know the transition kernel P. Second for the

case of an infinite state space, we cannot update the estimate at each iteration of the state space. Therefore, we apply an approximation of the Bellman optimality operator defined as

$$\hat{T}Q(s,a) = \left(r'(s,a) + \max_{a' \in \mathcal{A}} \gamma Q(s',a')\right),\tag{15}$$

where $r'(s, a) \sim R(.|s, a)$. Since we cannot perform even this approximated optimality operator for all state action pairs due to the possibly infinite state space, we instead update our estimate of the Q function at iteration k as the 2 layer ReLU Neural Network which minimizes the following loss function

$$\frac{1}{n} \sum_{i=1}^{n} \left(Q_{\theta}(s_i, a_i) - \left(r'(s_i, a_i) + \max_{a' \in \mathcal{A}} \gamma Q_{k-1}(s', a') \right) \right)^2, \tag{16}$$

Here Q_{k-1} is the estimate of the Q function from iteration k-1 and the state action pairs have been sampled from some distribution, ν , over the state action pairs. Note that this is a problem of the form given in Equation (11) with $y_i = (r'(s_i, a_i) + \max_{a' \in \mathcal{A}} \gamma Q_{k-1}(s', a'))$ where $i \in (1, \dots, n)$ and Q_{θ} represented as in Equation (14).

We define the Bellman error at iteration k as

$$\epsilon_k = TQ_{k-1} - Q_k,\tag{17}$$

The main algorithm, Algorithm 1, iteratively samples from the state action space at every iteration, and the corresponding reward is observed. For each of the sampled state action pairs, the approximate Bellman optimality operator given in Equation (15) is applied to obtain the corresponding output value y. We have access to these values under Assumption 3. The sampled set of state action pairs and the corresponding y values are then passed to Algorithm 2, which returns the estimates of the neural network which minimizes the loss given in Equation (16). The algorithm updates the estimate of the action value function as the neural network corresponding to the estimated parameters.

Algorithm 2 optimizes the parameters for the neural network at each step of Algorithm 1. This is performed by reducing the problem to an equivalent convex problem as described in Appendix B. The algorithm first samples a set of diagonal matrices denoted by \tilde{D} in line 2 of Algorithm 2. The elements of \tilde{D} act as the diagonal matrix replacement of the ReLU function. Algorithm 2 then solves an optimization of the form given in Equation (13) with the regularization parameter $\beta=0$. This convex optimization is solved in Algorithm 2 using the projected gradient descent algorithm. After obtaining the optima for this convex program, denoted by $u^*=\{u_i^*\}_{i\in\{1,\cdots,|\tilde{D}|\}}$, in line 10, we transform them to the parameters of a neural network of the form given in Equation (14) which are then passed back to Algorithm 1. The procedure is described in detail along with the relevant definitions in Appendix B.

5. Error Characterization

We now characterize the errors which can result in the gap between the point of convergence and the optimal Q-function. To define the errors, we first define the various possible Qfunctions which we can approximate in decreasing order of the accuracy.

We start by defining the best possible Q-function, Q_{k_1} for episode k > 1. Q_{k_1} is the best approximation of the function TQ_{k-1} possible from the class of two layer ReLU neural networks, with respect to the expected square from the true ground truth TQ_{k-1} .

Definition 1 For a given iteration k of Algorithm 1, we define

$$Q_{k_1} = \underset{Q_{\theta}, \theta \in \Theta}{\operatorname{arg\,min}} \, \mathbb{E}(Q_{\theta} - TQ_{k-1})_{\nu}^2, \tag{19}$$

The expectation is with respect to the sampling distribution of the state action pairs denoted by ν . TQ_{k-1} is the bellman optimality operator applied to Q_{k-1} .

Note that we do not have access to the transition probability kernel P, hence we cannot calculate TQ_{k-1} . To alleviate this, we use the observed next states to estimate the Q-value function. Using this, we define Q_{k_2} as,.

Definition 2 For a given function $Q: \mathcal{S} \times \mathcal{A} \to \left[0, \frac{R_{max}}{1-\gamma}\right]$, we define

$$Q_{k_2} = \underset{Q_{\theta}, \theta \in \Theta}{\arg \min} \mathbb{E}_{(s,a) \sim \nu, s' \sim P(s'|s,a), r'(\cdot|s,a) \sim R(\cdot|s,a)}$$

$$(Q_{\theta}(s,a) - (r'(s,a) + \gamma \max_{a'} Q_{k-1}(s',a'))^2,$$
(20)

Compared to Q_{k_1} , in Q_{k_2} , we are minimizing the expected square loss from target function $(r'(s, a) + \gamma \max_{a'} Q(s', a'))$ or the expected loss function.

To obtain Q_{k_2} , we still need to compute the true expected value in Equation 20. However, we still do not know the transition function P. To remove this limitation, we use sampling. Consider a set, \mathcal{X} , of state-action pairs sampled using distribution ν . We now define Q_{k_3} as,

Definition 3 For a given set of state action pairs \mathcal{X} and a given function $Q: \mathcal{S} \times \mathcal{A} \rightarrow \left[0, \frac{R_{max}}{1-\gamma}\right]$ we define

$$Q_{k_3} = \underset{Q_{\theta}, \theta \in \Theta}{\operatorname{arg \, min}} \frac{1}{|\mathcal{X}|} \sum_{(s_i, a_i) \in \mathcal{X}} \left(Q_{\theta}(s_i, a_i) - \left(r'(s_i, a_i) + \gamma \max_{a' \in \mathcal{A}} Q_{k-1}(s'_i, a') \right) \right)^2, \tag{21}$$

where $r'(s_i, a_i)$, and s'_i are the observes reward and the observed next state for state action pair s_i , a_i respectively.

 Q_{k_3} is the best possible approximation for Q-value function which minimizes the sample average of the square loss functions with the target values as $(r'(s_i, a_i) + \gamma \max_{a' \in \mathcal{A}} Q(s', a'))^2$ or the empirical loss function.

After defining the possible solutions for the Q-values using different loss functions, we define the errors.

We first define approximation error which represents the difference between TQ_{k-1} and its best approximation possible from the class of 2 layer ReLU neural networks. We have

Definition 4 (Approximation Error) For a given iteration k of Algorithm 1, $\epsilon_{k_1} = TQ_{k-1} - Q_{k_1}$, where Q_{k-1} is the estimate of the Q function at the iteration k-1.

We also define Estimation Error which denotes the error between the best approximation of TQ_{k-1} possible from a 2 layer ReLU neural network and Q_{k_2} . We demonstrate that these two terms are the same and this error is zero.

Definition 5 (Estimation Error) For a given iteration k of Algorithm 1, $\epsilon_{k_2} = Q_{k_1} - Q_{k_2}$.

We now define Sampling error which denotes the difference between the minimizer of expected loss function Q_{k_2} and the minimizer of the empirical loss function using samples, Q_{k_3} . We will use Rademacher complexity results to upper bound this error.

Definition 6 (Sampling Error) For a given iteration k of Algorithm 1, $\epsilon_{k_3} = Q_{k_2} - Q_{k_3}$. Here X_k is the set of state action pairs sampled at the k^{th} iteration of Algorithm 1.

Lastly, we define optimization error which denotes the difference between the minimizer of the empirical square loss function, Q_{k_3} , and our estimate of this minimizer that is obtained from the projected gradient descent algorithm.

Definition 7 (Optimization Error) For a given iteration k of Algorithm 1, $\epsilon_{k_4} = Q_{k_3} - Q_k$. Here Q_k is our estimate of the Q function at iteration k of Algorithm 1.

6. Assumptions

In this section, we formally describe the assumptions that will be used in the results.

Assumption 1 Let $\theta^* \triangleq \arg\min_{\theta \in \Theta} \mathcal{L}(\theta)$, where $\mathcal{L}(\theta)$ is defined in (11) and we denote $Q_{\theta^*}(\cdot)$ as $Q_{\theta}(\cdot)$ as defined in (14) for $\theta = \theta^*$. Also, let $\theta_{\tilde{D}}^* \triangleq \arg\min_{\theta \in \Theta} \mathcal{L}_{|\tilde{D}|}(\theta)$, where $\mathcal{L}_{\tilde{D}}(\theta)$ is defined in (52). Further, we denote $Q_{\theta^*_{|\tilde{D}|}}(\cdot)$ as $Q_{\theta}(\cdot)$ as defined in (14) for $\theta = \theta^*_{|\tilde{D}|}$. Then we assume

$$\mathbb{E}(|Q_{\theta^*} - Q_{\theta^*_{|\tilde{D}|}}|)_{\nu} \le \epsilon_{|\tilde{D}|}, \tag{22}$$

for any $\nu \in \mathcal{P}(\mathcal{S} \times \mathcal{A})$

 $\mathcal{L}_{\tilde{D}}(\theta)$ is the non-convex problem equivalent to the convex problem in (13). Thus, $\epsilon_{|\tilde{D}|}$ is a measure of the error incurred due to taking a sample of diagonal matrices \tilde{D} and not the full set D_X . In practice, setting $|\tilde{D}|$ to be the same order of magnitude as d (dimension of the data) gives us a sufficient number of diagonal matrices to get a reformulation of the non convex optimization problem which performs comparably or better than existing gradient descent algorithms, therefore $\epsilon_{|\tilde{D}|}$ is only included for theoretical completeness and will be negligible in practice. This has been practically demonstrated in Mishkin et al. (2022); Bartan and Pilanci (2022); Sahiner et al. (2022). Refer to Appendix B for details of D_X , \tilde{D} and $\mathcal{L}_{|\tilde{D}|}(\theta)$.

Assumption 2 We assume that for all functions $Q: \mathcal{S} \times \mathcal{A} \to \left[0, \left(\frac{R_{\max}}{1-\gamma}\right)\right]$, there exists a function Q_{θ} where $\theta \in \Theta$ such that

$$\mathbb{E}(Q_{\theta} - Q)_{\nu}^{2} \le \epsilon_{bias},\tag{23}$$

for any $\nu \in \mathcal{P}(\mathcal{S} \times \mathcal{A})$.

 ϵ_{bias} reflects the error that is incurred due to the inherent lack of expressiveness of the neural network function class. In the analysis of Fan et al. (2020), this error is assumed to be zero. We account for this error with an assumption similar to the one used in Liu et al. (2020).

Assumption 3 We assume that for the MDP \mathcal{M} , we have access to a one step transition operator $\kappa : \mathcal{S} \times \mathcal{A} \to \mathcal{S} \times ([0, R_{max}])$ defined as

$$\kappa(s,a) = (s', r'(s,a)), \qquad (24)$$

where $s' \sim \mathcal{P}(\cdot|(s, a))$ and $r'(s, a) \sim R(.|s, a)$

One step sampling distributions offer a useful tool for finding next state and rewards as i.i.d samples. In practice such an operator may not be available and we only have access to these samples as a Markov chain. This can be overcome be storing the transitions and then sampling the stored transitions independently in a technique known as experience replay. Examples of experience replay being used are Mnih et al. (2013); Agarwal et al. (2021); Andrychowicz et al. (2017).

Assumption 4 Let ν_1 be a probability measure on $\mathcal{S} \times \mathcal{A}$ which is absolutely continuous with respect to the Lebesgue measure. Let $\{\pi_t\}$ be a sequence of policies and suppose that the state action pair has an initial distribution of ν_1 . Then we assume that for all $\nu_1, \nu_2 \in \mathcal{P}(\mathcal{S} \times \mathcal{A})$ there exists a constant $\phi_{\nu_1,\nu_2} \leq \infty$ such that

$$\sup_{\pi_{1},\pi_{2},\cdots,\pi_{m}} \left\| \frac{d(P^{\pi_{1}}P^{\pi_{2}}\cdots P^{\pi_{m}}\nu_{2})}{d\nu_{1}} \right\|_{\infty} \leq \phi_{\nu_{1},\nu_{2}}$$
(25)

for all $m \in \{1, \dots, \infty\}$, where $\frac{d(P^{\pi_1}P^{\pi_2} \dots P^{\pi_m}\nu_2)}{d\nu_1}$ denotes the Radon Nikodym derivative of the state action distribution $P^{\pi_1}P^{\pi_2} \dots P^{\pi_m}\nu_2$ with respect to the distribution ν_1 .

This assumption puts an upper bound on the difference between the state action distribution ν_1 and the state action distribution induced by sampling a state action pair from the distribution μ_2 followed by any possible policy for the next m steps for any finite value of m. Similar assumptions have been made in Fan et al. (2020); Lazaric et al. (2016).

7. Supporting Lemmas

We will now state the key lemmas that will be used for finding the sample complexity of the proposed algorithm.

Lemma 8 For any given iteration $k \in \{1, \dots, K\}$ for the approximation error denoted by ϵ_{k_1} in Definition 4, we have

$$\mathbb{E}\left(\left|\epsilon_{k_1}\right|\right)_{\nu} \le \sqrt{\epsilon_{bias}},\tag{26}$$

Proof Sketch: We use Assumption 2 and the definition of the variance of a random variable to obtain the required result. The detailed proof is given in Appendix E.1.

Lemma 9 For any given iteration $k \in \{1, \dots, K\}$, $Q_{k_1} = Q_{k_2}$, or equivalently $\epsilon_{k_2} = 0$

Proof Sketch: We use Lemma 14 in Appendix C and use the definitions of Q_{k_1} and Q_{k_2} to prove this result. The detailed proof is given in Appendix E.2.

Lemma 10 For any given iteration $k \in \{1, \dots, K\}$, if the number of samples of the state action pairs sampled by Algorithm 1 at iteration k, denoted by n_k , satisfies

$$n_k \geq 8\left((C_k \eta \beta_k)^2 \epsilon^{-2}\right) \tag{27}$$

for some constants C_k , η and β_k , then the error ϵ_{k_3} defined in Definition 6 is upper bounded as

$$\mathbb{E}\left(\left|\epsilon_{k_3}\right|\right)_{\nu} \le \epsilon,\tag{28}$$

Proof Sketch: First we note that for a fixed iteration k of Algorithm 1, $\mathbb{E}(R_{X,Q_{k-1}}(\theta)) = L_{Q_{k-1}}(\theta)$ where $R_{X,Q_{k-1}}(\theta)$ and $L_{Q_{k-1}}(\theta)$ are defined in Appendix E.3. We use this to get a probabilistic bound on the expected value of $|(Q_{k_2}) - (Q_{k_3})|$ using Rademacher complexity theory. The detailed proof is given in Appendix E.3.

Lemma 11 For any given iteration $k \in \{1, \dots, K\}$ of Algorithm 1, let the number of steps of the projected gradient descent performed by Algorithm 2, denoted by T_k , and the gradient descent step size α_k satisfy

$$T_k \geq \left(\frac{C_k'\epsilon}{l_k}\right)^{-2} L_k^2 ||u_k^*||_2^2 - 1$$
 (29)

$$\alpha_k = \frac{||u_k^*||_2}{L_k \sqrt{T_k + 1}} \tag{30}$$

where $\epsilon < C_k'$, for some constants C_k' , l_k , L_k and $||(u_k^*)||_2$. Then the error ϵ_{k_4} defined in Definition 7 is upper bounded as

$$\mathbb{E}(|\epsilon_{k_4}|)_{\nu} \le \epsilon + \epsilon_{|\tilde{D}|},\tag{31}$$

Proof Sketch: We use the number of iterations T_k required to get an ϵ bound on the difference between the minimum objective value and the objective value corresponding to the estimated parameter at iteration T_k . We use the convexity of the objective and the Lipschitz property of the neural network to get a bound on the Q functions corresponding to the estimated parameters. The detailed proof is given in Appendix E.4.

8. Main Result

In this section, we provide the guarantees for the proposed algorithm, which is given in the following theorem.

Theorem 1 Suppose Assumptions 1-4 hold. Let Algorithm 1 run for K iterations with n_k state-action pairs sampled at iteration $k \in \{1, \dots, K\}$, T_k be the number of steps used and step size α_k in the projected gradient descent in Algorithm 2 at iteration $k \in \{1, \dots, K\}$ and $|\tilde{D}|$ be the number of diagonal matrices sampled in Algorithm 2 for all iterations. Let $\nu \in \mathcal{P}(\mathcal{S} \times \mathcal{A})$ be the state action distribution used to sample the state action pairs in Algorithm 1. Further, let $\epsilon \in (0,1)$, C_k , C'_k , l_k

$$K \geq \frac{1}{\log\left(\frac{1}{\gamma}\right)}\log\left(\frac{6\phi_{\nu,\mu}R_{max}}{\epsilon(1-\gamma)^2}\right) - 1 \tag{32}$$

$$n_k \ge 288(C_k \eta \beta_k \phi_{\nu,\mu} \gamma)^2 (1 - \gamma)^{-4} \epsilon^{-2}$$
 (33)

$$T_k \geq \left(\frac{C_k'\epsilon(1-\gamma)^2}{6l_k\phi_{\nu,\mu}\gamma}\right)^{-2}L_k^2||u_k^*||_2^2 - 1$$

(34)

$$\alpha_k = \frac{||u_k^*||_2}{L_k \sqrt{T_k + 1}}$$

$$\forall k \in \{1, \dots, K\}$$
(35)

and $\epsilon < (C'_k)$ for all $k \in (1, \dots, K)$, then we obtain

$$E(Q^* - Q^{\pi_K})_{\mu} \le \epsilon + \frac{2\phi_{\nu,\mu}\gamma}{(1-\gamma)^2} (\sqrt{\epsilon_{bias}} + \epsilon_{|\tilde{D}|}),$$

where $\mu \in \mathcal{P}(\mathcal{S} \times \mathcal{A})$. Thus we get an overall sample complexity given by $\sum_{k=1}^{K} n_k = \tilde{\mathcal{O}}(\epsilon^{-2}(1-\gamma)^{-4})$.

The above algorithm achieves a sample complexity of $\tilde{\mathcal{O}}(1/\epsilon^2)$, which is the first such result for general parametrized large state space reinforcement learning. Further, we note that $\tilde{\mathcal{O}}(1/\epsilon^2)$ is the best order-optimal result even in tabular setup Zhang et al. (2020). In the following, we provide an outline of the proof, with the detailed proof provided in the Appendix D.

The expectation of the difference between our estimated Q function denoted by Q^{π_K} and the optimal Q function denoted by Q^* (where π_k is the policy obtained at the final step K of algorithm 1) is first expressed as a function of the Bellman errors (defined in Equation (17)) incurred at each step of Algorithm 1. The Bellman errors are then split into different components which are analysed separately. The proof is thus split into two stages. In the first stage, we demonstrate how the expectation of the error of estimation $(Q^{\pi_K} - Q^*)$ of the Q function is upper bounded by a function of the Bellman errors incurred till the final step K. The second part is to upper bound the expectation of the Bellman error.

Upper Bounding Q Error In Terms Of Bellman Error: Since we only have access to the approximate Bellman optimality operator defined in Equation (15), we will rely upon the analysis laid out in Farahmand et al. (2010) and instead of the iteration of the value functions, we will apply a similar analysis to the action value function to get the desired result. We recreate the result for the value function from Lemmas 2 and 3 of Munos (2003) for the action value function Q to obtain

$$Q^* - Q_K \leq \sum_{k=1}^{K-1} \gamma^{K-k-1} (P^{\pi^*})^{K-k-1} \epsilon_k,$$

$$+ \gamma^K (P^{\pi^*})^K (Q^* - Q_0)$$
(36)

and

$$Q^* - Q^{\pi_K} \leq (I - \gamma P^{\pi_K})^{-1} \left(P^{\pi^*} - P^{\pi_K} \right)$$

$$(Q^* - Q_K)$$
(37)

where $\epsilon_k = TQ_{k-1} - Q_k$.

We use the results in Equation (36) and (37) to obtain

$$\mathbb{E}(Q^* - Q^{\pi_K})_{\mu} \leq \frac{2\gamma}{(1 - \gamma)} \left[\sum_{k=1}^{K-1} \gamma^{K-k} \mathbb{E}(|\epsilon_k|)_{\mu} \right] + \frac{2R_{\max} \gamma^{K+1}}{(1 - \gamma)^2}, \tag{38}$$

The first term on the right hand side is called as the algorithmic error, which depends on how good our approximation of the Bellman error is. The second term on the right hand side is called as the statistical error, which is the error incurred due to the random nature of the system and depends only on the parameters of the MDP as well as the number of iterations of the FQI algorithm.

The expectation of the error of estimation is taken with respect to any arbitrary distribution on the state action space denoted as μ . The dependence of the expected value of the error of estimation on this distribution is expressed through the constant $\phi_{\nu,\mu}$, which is a measure of the similarity between the distributions ν and μ .

Upper Bounding Expectation of Bellman Error: The upper bound on $\mathbb{E}(Q^* - Q^{\pi_K})_{\mu}$ in Equation (38) is in terms of $\mathbb{E}(|\epsilon_k|)_{\mu}$, where $\epsilon_k = TQ_{k-1} - Q_k$ is a measure of how closely our estimate of the Q function at iteration k approximates the function obtained by applying the bellman optimality operator applied to the estimate of the Q function at iteration k-1. Intuitively, this error depends on how much data is collected at each iteration, how efficient our solution to the optimization step is to the true solution, and how well our function class can approximate the true Bellman optimality operator applied to the estimate at the end of the previous iteration. Building upon this intuition, we split ϵ_k into four different components as follows.

$$\epsilon_{k} = TQ_{k-1} - Q_{k}$$

$$= \underbrace{TQ_{k-1} - Q_{k1}}_{\epsilon_{k1}} + \underbrace{Q_{k1} - Q_{k2}}_{\epsilon_{k2}} + \underbrace{Q_{k2} - Q_{k3}}_{\epsilon_{k3}}$$

$$+ \underbrace{Q_{k3} - Q_{k}}_{\epsilon_{k4}}$$

$$= \epsilon_{k_{1}} + \epsilon_{k_{2}} + \epsilon_{k_{3}} + \epsilon_{k_{4}}, \tag{39}$$

We use the Lemmas 8, 9, 10, and 11 to bound the error terms in Equation (39). Before plugging these in Equation (38), we replace ϵ in the Lemma results with $\epsilon' = \epsilon \frac{(1-\gamma)^3}{6\gamma}$ as these error terms are in a summation in Equation (38). We also bound the last term on the right hand side of Equation (38) by solving for a value of K that makes the term smaller than $\frac{\epsilon}{3}$.

9. Conclusion and Future Work

In this paper, we study a Fitted Q-Iteration with two-layer ReLU neural network parametrization, and find the sample complexity guarantees for the algorithm. Using the convex approach for estimating the Q-function, we show that our approach achieves a sample complexity of $\tilde{\mathcal{O}}(1/\epsilon^2)$, which is order-optimal. This demonstrates the first approach for achieving sample complexity beyond linear MDP assumptions for large state space.

This study raises multiple future problems. First is whether we can remove the assumption on the generative model, while estimating Q-function by efficient sampling of past samples. Further, whether the convexity in training that was needed for the results could be extended to more than two layers. Finally, efficient analysis for the error incurred when a sample of cones are chosen rather than the complete set of cones and how to efficiently choose this subset will help with a complete analysis by which Assumption 1 can be relaxed.

A. Comparison of Result with Xu and Gu (2020)

Analysis of Q learning algorithms with neural network function approximation was carried out in Xu and Gu (2020), where finite time error bounds were studied for estimation of the Q function for MDP's with countable state spaces. The final result in Xu and Gu (2020) is of the form

$$\frac{1}{T} \sum_{t=1}^{T} \mathbb{E}(Q(s, a, \theta_t) - Q^*(s, a)) \le \tilde{\mathcal{O}}\left(\frac{1}{\sqrt{T}}\right) + \tilde{\mathcal{O}}(\sqrt{\log(T)})$$
(40)

Here, $Q(s, a, \theta_t)$ is the estimate of the Q function obtained using the neural network with the parameters obtained at step t of the Q learning algorithm represented by θ_t and $Q^*(s, a)$ is the optimal Q function. T is the total number of iterations of the Q learning algorithm.

The first term on the right hand side of (40) is monotonically decreasing with respect to T. The second term on the right hand side monotonically increases with respect to T. This term is present due to the error incurred by the linear approximation of the neural network representing the Q function. Our approach does not require this approximation due to the convex representation of the neural network. Due to the increasing function of T, it is not possible to obtain the number of iteration of the Q learning required to make the error of estimation smaller than some fixed value. Thus, this result cannot be said to be a sample complexity result. However, in our results, this is not the case.

B. Convex Reformulation with Two-Layer Neural Networks

In order to understand the convex reformulation of the squared loss optimization problem, consider the vector $\sigma(Xu_i)$

$$\sigma(Xu_i) = \begin{bmatrix} \{\sigma'((x_1)^T u_i)\} \\ \{\sigma'((x_2)^T u_i)\} \\ \vdots \\ \{\sigma'((x_n)^T u_i)\} \end{bmatrix}$$
(41)

Now for a fixed $X \in \mathbb{R}^{n \times d}$, different $u_i \in \mathbb{R}^{d \times 1}$ will have different components of $\sigma(Xu_i)$ that are non zero. For example, if we take the set of all u_i such that only the first element of $\sigma(Xu_i)$ are non zero (i.e, only $(x_1)^T u_i \geq 0$ and $(x_j)^T u_i < 0 \ \forall j \in [2, \dots, n]$) and denote it by the set \mathcal{K}_1 , then we have

$$\sigma(Xu_i) = D_1(Xu_i) \quad \forall u_i \in \mathcal{K}_1,$$

where D_1 is the $n \times n$ diagonal matrix with only the first diagonal element equal to 1 and the rest 0. Similarly, there exist a set of u's which result in $\sigma(Xu)$ having certain components to be non-zero and the rest zero. For each such combination of zero and non-zero components, we will have a corresponding set of u'_is and a corresponding $n \times n$ Diagonal matrix D_i . We define the possible set of such diagonal matrices possible for a given matrix

X as

$$D_X = \{ D = diag(\mathbf{1}(Xu \ge 0)) : u \in \mathbb{R}^d, D \in \mathbb{R}^{n \times n} \}, \tag{42}$$

where $diag(\mathbf{1}(Xu \geq 0))$ represents a matrix given by

$$D_{k,j} = \begin{cases} \mathbf{1}(x_j^T u), & \text{for } k = j \\ 0 & \text{for } k \neq j \end{cases}, \tag{43}$$

where $\mathbf{1}(x) = 1$ if x > 0 and $\mathbf{1}(x) = 0$ if $x \le 0$. Corresponding to each such matrix D_i , there exists a set of u_i given by

$$\mathcal{K}_i = \{ u \in \mathbb{R}^d : \sigma(Xu_i) = D_i X u_i, D_i \in D_X \}$$
(44)

where I is the $n \times n$ identity matrix. The number of these matrices D_i is upper bounded by 2^n . From Wang et al. (2021b) the upper bound is $\mathcal{O}\left(r\left(\frac{n}{r}\right)^r\right)$ where r = rank(X). Also, note that the sets \mathcal{K}_i form a partition of the space $\mathbb{R}^{d\times 1}$. Using these definitions, we define the equivalent convex problem to the one in Equation (11) as

$$\mathcal{L}_{\beta}(v, w) := \underset{v, w}{\operatorname{arg \, min}} (|| \sum_{D_i \in D_X} D_i(X(v_i - w_i)) - y||_2^2 + \beta \sum_{D_i \in D_X} ||v_i||_2 + ||w_i||_2)$$

$$(45)$$

where $v = \{v_i\}_{i \in 1, \dots, |D_X|}$, $w = \{w_i\}_{i \in 1, \dots, |D_X|}$, $v_i, w_i \in \mathcal{K}_i$, note that by definition, for any fixed $i \in \{1, \dots, |D_X|\}$ at-least one of v_i or w_i are zero. If v^*, w^* are the optimal solutions to Equation (45), the number of neurons m of the original problem in Equation (11) should be greater than the number of elements of v^*, w^* , which have at-least one of v_i^* or w_i^* non-zero. We denote this value as $m_{X,y}^*$, with the subscript X denoting that this quantity depends upon the data matrix X and response y.

We convert v^*, w^* to optimal values of Equation (11), denoted by $\theta^* = (U^*, \alpha^*)$, using a function $\psi : \mathbb{R}^d \times \mathbb{R}^d \to \mathbb{R}^d \times \mathbb{R}$ defined as follows

$$\psi(v_i, w_i) = \begin{cases} (v_i, 1), & \text{if } w_i = 0\\ (w_i, -1), & \text{if } v_i = 0\\ (0, 0), & \text{if } v_i = w_i = 0 \end{cases}$$

$$(46)$$

where according to Pilanci and Ergen (2020) we have $(u_i^*, \alpha_i^*) = \psi(v_i^*, w_i^*)$, for all $i \in \{1, \dots, |D_X|\}$ where u_i^*, α_i^* are the elements of θ^* . Note that restriction of α_i to $\{1, -1, 0\}$ is shown to be valid in Mishkin et al. (2022). For $i \in \{|D_X|+1, \dots, m\}$ we set $(u_i^*, \alpha_i^*) = (0, 0)$.

Since D_X is hard to obtain computationally unless X is of low rank, we can construct a subset $\tilde{D} \in D_X$ and perform the optimization in Equation (45) by replacing D_X with \tilde{D} to get

$$\mathcal{L}_{\beta}(v, w) := \underset{v, w}{\arg \min}(||\sum_{D_{i} \in \tilde{D}} D_{i}(X(v_{i} - w_{i})) - y||_{2}^{2} + \beta \sum_{D_{i} \in \tilde{D}} ||v_{i}||_{2} + ||w_{i}||_{2})$$

$$(47)$$

where $v = \{v_i\}_{i \in 1, \dots, |\tilde{D}|}$, $w = \{w_i\}_{i \in 1, \dots, |\tilde{D}|}$, $v_i, w_i \in \mathcal{K}_i$, by definition, for any fixed $i \in \{1, \dots, |\tilde{D}|\}$ at-least one of v_i or w_i are zero.

The required condition for \tilde{D} to be a sufficient replacement for D_X is as follows. Suppose $(v, w) = (\bar{v}_i, \bar{w}_i)_{i \in (1, \dots, |\tilde{D}|)}$ denote the optimal solutions of Equation (47). Then we require

$$m \ge \sum_{D_i \in \tilde{D}} |\{\bar{v}_i : \bar{v}_i \ne 0\} \cup \{\bar{w}_i : \bar{w}_i \ne 0\}|$$
(48)

Or, the number of neurons in the neural network are greater than the number of indices i for which at-least one of v_i^* or w_i^* is non-zero. Further,

$$diag(Xu_i^* \ge 0 : i \in [m]) \in \tilde{D} \tag{49}$$

In other words, the diagonal matrices induced by the optimal u_i^* 's of Equation (11) must be included in our sample of diagonal matrices. This is proved in Theorem 2.1 of Mishkin et al. (2022).

A computationally efficient method for obtaining \tilde{D} and obtaining the optimal values of the Equation (11), is laid out in Mishkin et al. (2022). In this method we first get our sample of diagonal matrices \tilde{D} by first sampling a fixed number of vectors from a d dimensional standard multivariate distribution, multiplying the vectors with the data matrix X and then forming the diagonal matrices based of which co-ordinates are positive. Then we solve an optimization similar to the one in Equation (45), without the constraints, that its parameters belong to sets of the form K_i as follows.

$$\mathcal{L}'_{\beta}(p) := \arg\min_{p} (||\sum_{D_i \in \tilde{D}} D_i(Xp_i) - y||_2^2 + \beta \sum_{D_i \in \tilde{D}} ||p_i||_2), \tag{50}$$

where $p \in \mathbb{R}^{d \times |\tilde{D}|}$. In order to satisfy the constraints of the form given in Equation (45), this step is followed by a cone decomposition step. This is implemented through a function $\{\psi_i'\}_{i \in \{1, \cdots, |\tilde{D}|\}}$. Let $p^* = \{p_i^*\}_{i \in \{1, \cdots, |\tilde{D}|\}}$ be the optimal solution of Equation (50). For each i we define a function $\psi_i' : \mathbb{R}^d \to \mathbb{R}^d \times \mathbb{R}^d$ as

$$\psi_{i}'(p_{i}) = (v_{i}, w_{i})$$

$$such that p = v_{i} - w_{i}, and v_{i}, w_{i} \in \mathcal{K}_{i}$$

$$(51)$$

Then we obtain $\psi(p_i^*) = (\bar{v}_i, \bar{w}_i)$. As before, at-least one of v_i , w_i is 0. Note that in practice we do not know if the conditions in Equation (48) and (49) are satisfied for a given sampled \tilde{D} . We express this as follows. If \tilde{D} was the full set of Diagonal matrices then we would have $(\bar{v}_i, \bar{w}_i) = v_i^*, w_i^*$ and $\psi(\bar{v}_i, \bar{w}_i) = (u_i^*, \alpha_i^*)$ for all $i \in (1, \dots, |D_X|)$. However, since that is not the case and $\tilde{D} \in D_X$, this means that $\{\psi(\bar{v}_i, \bar{w}_i)\}_{i \in (1, \dots, |\tilde{D}|)}$ is an optimal solution of a non-convex optimization different from the one in Equation (11). We denote this non-convex optimization as $\mathcal{L}_{|\tilde{D}|}(\theta)$ defined as

$$\mathcal{L}_{|\tilde{D}|}(\theta) = \arg\min_{\theta} ||\sum_{i=1}^{m'} \sigma(Xu_i)\alpha_i - y||_2^2 + \beta \sum_{i=1}^{m} ||u_i||_2^2 + \beta \sum_{i=1}^{m} |\alpha_i|^2,$$
 (52)

where $m' = |\tilde{D}|$ or the size of the sampled diagonal matrix set. In order to quantify the error incurred due to taking a subset of D_X , we assume that the expectation of the absolute value of the difference between the neural networks corresponding to the optimal solutions of the non-convex optimizations given in Equations (52) and (11) is upper bounded by a constant depending on the size of \tilde{D} . The formal assumption and its justification is given in Assumption 1.

C. Supplementary lemmas and Definitions

Here we provide some definitions and results that will be used to prove the lemmas stated in the paper.

Definition 12 For a given set $Z \in \mathbb{R}^n$, we define the Rademacher complexity of the set Z as

$$Rad(Z) = \mathbb{E}\left(\sup_{z \in Z} \frac{1}{n} \sum_{i=1}^{d} \Omega_i z_i\right)$$

where Ω_i is random variable such that $P(\Omega_i = 1) = \frac{1}{2}$, $P(\Omega_i = -1) = \frac{1}{2}$ and z_i are the co-ordinates of z which is an element of the set Z

Lemma 13 Consider a set of observed data denoted by $z = \{z_1, z_2, \dots z_n\} \in \mathbb{R}^n$, a parameter space Θ , a loss function $\{l : \mathbb{R} \times \Theta \to \mathbb{R}\}$ where $0 \le l(\theta, z) \le 1 \ \forall (\theta, z) \in \Theta \times \mathbb{R}$. The empirical risk for a set of observed data as $R(\theta) = \frac{1}{n} \sum_{i=1}^{n} l(\theta, z_i)$ and the population risk as $r(\theta) = \mathbb{E}l(\theta, \tilde{z}_i)$, where \tilde{z}_i is a co-ordinate of \tilde{z} sampled from some distribution over Z.

We define a set of functions denoted by \mathcal{L} as

$$\mathcal{L} = \{ z \in Z \to l(\theta, z) \in \mathbb{R} : \theta \in \Theta \}$$
 (54)

Given $z = \{z_1, z_2, z_3 \cdots, z_n\}$ we further define a set $\mathcal{L} \circ z$ as

$$\mathcal{L} \circ z = \{ (l(\theta, z_1), l(\theta, z_2), \cdots, l(\theta, z_n)) \in \mathbb{R}^n : \theta \in \Theta \}$$
 (55)

Then, we have

$$\mathbb{E}\sup_{\theta\in\Theta}|\{r(\theta)-R(\theta)\}| \le 2\mathbb{E}\left(Rad(\mathcal{L}\circ z)\right) \tag{56}$$

If the data is of the form $z_i = (x_i, y_i), x \in X, y \in Y$ and the loss function is of the form $l(a_{\theta}(x), y)$, is L lipschitz and $a_{\theta} : \Theta \times X \to \mathbb{R}$, then we have

$$\mathbb{E}\sup_{\theta\in\Theta}|\{r(\theta)-R(\theta)\}| \le 2L\mathbb{E}\left(Rad(\mathcal{A}\circ\{x_1,x_2,x_3,\cdots,x_n\})\right)$$
(57)

where

$$\mathcal{A} \circ \{x_1, x_2, \cdots, x_n\} = \{(a(\theta, x_1), a(\theta, x_2), \cdots, a(\theta, x_n)) \in \mathbb{R}^n : \theta \in \Theta\}$$
 (58)

The detailed proof of the above statement is given in (Rebeschini, P. (2022). Algorithmic Foundations of Learning [Lecture Notes]. https://www.stats.ox.ac.uk/ rebeschi/teaching/AFoL/20/material/. The upper bound for $\mathbb{E}\sup_{\theta\in\Theta}(\{r(\theta)-R(\theta)\})$ is proved in the aformentioned reference. However, without loss of generality the same proof holds for the upper bound for $\mathbb{E}\sup_{\theta\in\Theta}(\{R(\theta)-r(\theta)\})$. Hence the upper bound for $\mathbb{E}\sup_{\theta\in\Theta}|\{r(\theta)-R(\theta)\}|$ can be established.

Lemma 14 Consider two random random variable $x \in \mathcal{X}$ and $y, y' \in \mathcal{Y}$. Let $\mathbb{E}_{x,y}, \mathbb{E}_x$ and $\mathbb{E}_{y|x}, \mathbb{E}_{y'|x}$ denote the expectation with respect to the joint distribution of (x, y), the marginal distribution of x, the conditional distribution of y given x and the conditional distribution of y' given x respectively. Let $f_{\theta}(x)$ denote a bounded measurable function of x parameterised by some parameter x and y be bounded measurable function of both x and y.

Then we have

 Q_k denotes our estimate of the action value function at step k of Algorithm 1 and Q^{π_k} denotes the action value function induced by the policy π_k which is the greedy policy with respect to Q_k .

$$L_{Q_{k-1}}(\theta) = \mathbb{E}_{(s,a) \sim \nu, s' \sim P(s'|s,a), r'(\cdot|s,a) \sim R(\cdot|s,a)} (Q_{\theta}(s,a) - (r'(s,a) + \gamma \max_{a'} Q_{k-1}(s',a'))^2$$

We denote by $\theta_{k_2}, \theta_{k_3}$ the parameters of the neural networks Q_{k_2}, Q_{k_3} respectively. Q_{k_2}, Q_{k_3} are defined in Definition 2 and 3 respectively.

We then obtain,

$$\begin{array}{lcl} R_{X,Q_{k-1}}(\theta_{k_2}) - R_{X,Q_{k-1}}(\theta_{k_3}) & \leq & R_{X,Q_{k-1}}(\theta_{k_2}) - R_{X,Q_{k-1}}(\theta_{k_3}) + L_{Q_{k-1}}(\theta_{k_2}) - L_{Q_{k-1}}(\theta_{k_3}) 6) \\ & = & R_{X,Q_{k-1}}(\theta_{k_2}) - L_{Q_{k-1}}(\theta_{k_2}) - R_{X,Q_{k-1}}(\theta_{k_3}) + L_{Q_{k-1}}(\theta_{k_2}) 7) \\ & \leq & \underbrace{|R_{X,Q_{k-1}}(\theta_{k_2}) - L_{Q_{k-1}}(\theta_{k_2})|}_{I} + \underbrace{|R_{X,Q_{k-1}}(\theta_{k_3}) - L_{Q_{k-1}}(\theta_{k_3})|}_{II} \end{array}$$

We get the inequality in Equation (196) because $L_{Q_{k-1}}(\theta_{k_3}) - L_{Q_{k-1}}(\theta_{k_2}) > 0$ as Q_{k_2} is the minimizer of the loss function $L_{Q_{k-1}}(Q_{\theta})$.

Consider Lemma 13. The loss function $R_{X_k,Q_{k-1}}(\theta_{k_3})$ can be written as the mean of loss functions of the form $l(a_{\theta}(s_i,a_i),y_i)$ where l is the square function. $a_{\theta}(s_i,a_i) = Q_{\theta}(s_i,a_i)$ and $y_i = (r'(s_i,a_i) + \gamma \max_{a' \in \mathcal{A}} Q_{k-1}(s',a'))$. Thus we have

$$\mathbb{E} \sup_{\theta \in \Theta} |R_{X,Q_{k-1}}(\theta) - L_{Q_{k-1}}(\theta)| \le 2\eta \mathbb{E} \left(Rad(\mathcal{A} \circ \{(s_1, a_1), (s_2, a_2), (s_3, a_3), \cdots, (s_n, a_n)\} \right) \right)$$

(199)

Where $n_k = |X|$, $(\mathcal{A} \circ \{(s_1, a_1), (s_2, a_2), (s_3, a_3), \dots, (s_n, a_n)\} = \{Q_{\theta}(s_1, a_1), Q_{\theta}(s_2, a_2), \dots, Q_{\theta}(s_n, a_n)\}$ and η is the Lipschitz constant for the square function over the state action space $[0, 1]^d$. The expectation is with respect to $(s_i, a_i) \sim \nu, s_i' \sim P(s'|s, a), r_i \sim R(.|s_i, a_i)_{i \in (1, \dots, n_k)}$.

From (Ma, Tengyu. (2018). Statistical Learning Theory [Lecture Notes]. https://web.stanford.edu/class/cs25 we have that

$$(Rad(\mathcal{A} \circ \{(s_1, a_1), (s_2, a_2), (s_3, a_3), \cdots, (s_n, a_n)\})) \le 2 \frac{\beta_k}{\sqrt{n_k}}$$
(200)

Where $\{||\theta|||_2 \leq \beta_k; \forall \theta \in \Theta\}$. Since we only have to demonstrate the inequality for θ_{k_2} and θ_{k_3} , we set β_k as a constant greater than $\max(||\theta_{k_2}||_2, ||\theta_{k_3}||_2)$, which gives us

$$\mathbb{E}|(R_{X,Q_{k-1}}(\theta_{k_2})) - L_{Q_{k-1}}(\theta_{k_2})| \le 2\left(\frac{\eta\beta_k}{\sqrt{n_k}}\right)$$

The same argument can be applied for Q_{k_3} to get

$$\mathbb{E}|(R_{X,Q_{k-1}}(\theta_{k_3})) - L_{Q_{k-1}}(\theta_{k_3})| \le 2\left(\frac{\eta\beta_k}{\sqrt{n_k}}\right)$$
 (202)

Thus, if we have

$$n_k \ge 2\left(\frac{2\eta\beta_k}{\epsilon}\right)^2 \tag{203}$$

Then we have

$$\mathbb{E}\left(R_{X,Q_{k-1}}(\theta_{k_2}) - R_{X,Q_{k-1}}(\theta_{k_3})\right) \le \epsilon \tag{204}$$

Plugging in the definition of $R_{X,Q_{k-1}}(\theta_{k_2}), R_{X,Q_{k-1}}(\theta_{k_3})$ in equation (204) we get

$$\mathbb{E}\frac{1}{n_k}\sum_{i=1}^{n_k}(Q_{k_2}(s_i,a_i)-Q_{k_3}(s_i,a_i))(Q_{k_2}(s_i,a_i)+Q_{k_3}(s_i,a_i)-2(r(s_i,a_i))+\gamma\max_{a\in\mathcal{A}}Q_{k-1}(s^{'},a)) \quad (205)$$

Now since all (s_i, a_i) are independent (205) becomes

$$\mathbb{E}\underbrace{(Q_{k_{2}}(s,a) - Q_{k_{3}}(s,a))}_{A1}\underbrace{(Q_{k_{2}}(s,a) + Q_{k_{3}}(s,a) - 2(r(s,a)) + \gamma \max_{a \in \mathcal{A}} Q_{k-1}(s',a))}_{A2} \leq (206)$$

Where the expectation is now over a single (s,a) drawn from ν , $r(s,a) \sim R(.|s,a)$ and $s' \sim P(.|s,a)$. We re-write Equation (206) as

$$\int \underbrace{(Q_{k_{2}}(s,a) - Q_{k_{3}}(s,a))}_{A1} \underbrace{(Q_{k_{2}}(s,a) + Q_{k_{3}}(s,a) - 2(r(s,a)) + \gamma \max_{a \in \mathcal{A}} Q_{k-1}(s',a))}_{A2} d\nu(s,a) d\mu_{2}(r) d\mu_{3}(s') \leq \epsilon$$
(207)

Where ν , μ_2 , μ_3 are the measures with respect to (s,a), $r^{'}$ and $s^{'}$ respectively Now for the integral in Equation (207) we split the integral into four different integrals. Each integral is over the set of (s, a), r', s' corresponding to the 4 different combinations of signs of A1, A2.

$$\int_{\{(s,a),r^{'},s^{'}\}:A1\geq0,A2\geq0}(A1)(A2)d\nu(s,a)d\mu_{2}(r)d\nu_{3}(s^{'}) + \int_{\{(s,a),r^{'},s^{'}\}:A1<0,A2<0}(A1)(A2)d\nu(s,a)d\mu_{2}(r)d\mu_{3}(s^{'}) + \int_{\{(s,a),r^{'},s^{'}\}:A1\geq0,A2<0}(A1)(A2)d\nu(s,a)d\mu_{2}(r)d\nu_{3}(s^{'}) + \int_{\{(s,a),r^{'},s^{'}\}:A1<0,A2\geq0}(A1)(A2)d\nu(s,a)d\mu_{2}(r)d\mu_{3}(s^{'})$$

Now note that the first 2 terms are non-negative and the last two terms are non-positive. We then write the first two terms as

We write the last two terms as

$$\int_{\{(s,a),r',s'\}:A1\geq 0,A2\leq 0} (A1)(A2)d\nu(s,a)d\mu_2(r)d\mu_3(s') = C_{k_3}\epsilon$$

$$\int_{\{(s,a),r',s'\}:A1\leq 0,A2\geq 0} (A1)(A2)d\nu(s,a)d\mu_2(r)d\mu_3(s') = C_{k_4}\epsilon$$
(211)

$$\int_{\{(s,a),r',s'\}:A1<0,A2\geq 0} (A1)(A2)d\nu(s,a)d\mu_2(r)d\mu_3(s') = C_{k_4}\epsilon$$
(212)

Here $C_{k_1}, C_{k_2}, C_{k_4}$ and C_{k_4} are positive constants. Plugging Equations (209), (210), (211), (212) into Equation (207).

$$(C_{k_1} + C_{k_2})\mathbb{E}(|Q_{k_2} - Q_{k_3}|)_{\nu} - (C_{k_3} + C_{k_4})\epsilon \le \epsilon \tag{213}$$

(214)

which implies

$$\mathbb{E}(|Q_{k_2} - Q_{k_3}|)_{\nu} \leq \left(\frac{1 + C_{k_3} + C_{k_4}}{C_{k_1} + C_{k_2}}\right) \epsilon \tag{215}$$

(216)

Now define $\left(\frac{1+C_{k_3}+C_{k_4}}{C_{k_1}+C_{k_2}}\right)=C_k$ to get

$$\mathbb{E}(|Q_{k_2} - Q_{k_3}|)_{\nu} \le C_k \epsilon \tag{217}$$

Therefore, we have that if the number of samples of the data set X of (s_i, a_i) pairs drawn independently from ν satisfies

$$n_k \ge 2\left(\frac{2\eta\beta_k}{\epsilon}\right)^2,\tag{219}$$

then we get

Replacing ϵ with $\epsilon(C_k)$ in Equation (219), we obtain that if

E.4 Proof Of Lemma 4

Proof For a given iteration k of Algorithm 1 the optimization problem to be solved in Algorithm 2 is the following

Here, Q_{k-1} is the estimate of the Q function from the iteration k-1 and the state action pairs $(s_i, a_i)_{i=\{1,\dots,n\}}$ have been sampled from a distribution over the state action

pairs denoted by ν . Since $\min_{\theta} \mathcal{L}(\theta)$ is a non convex optimization problem we instead solve the equivalent convex problem given by

$$u_k^* = \underset{u}{\operatorname{arg \, min}} g_k(u) = \underset{u}{\operatorname{arg \, min}} || \sum_{D_i \in \tilde{D}} D_i X_k u_i - y_k ||_2^2$$
 (225)

$$subject\ to|u|_1 \le \frac{R_{\text{max}}}{1-\gamma} \tag{226}$$

Here, $X_k \in \mathbb{R}^{n_k \times d}$ is the matrix of sampled state action pairs at iteration $k, y_k \in \mathbb{R}^{n_k \times 1}$ is the vector of target values at iteration k. \tilde{D} is the set of diagonal matrices obtained from line 2 of Algorithm 2 and $u \in \mathbb{R}^{|\tilde{D}d| \times 1}$ (Note that we are treating u as a vector here for notational convenience instead of a matrix as was done in Section 4).

The constraint in Equation (226) ensures that the all the co-ordinates of the vector $\sum_{D_i \in \tilde{D}} D_i X_k u_i$ are upper bounded by $\frac{R_{max}}{1-\gamma}$ (since all elements of X_k are between 0 and 1). This ensures that the corresponding neural network represented by Equation (14) is also upper bounded by $\frac{R_{max}}{1-\gamma}$. We use the a projected gradient descent to solve the constrained convex optimization problem which can be written as.

$$u_k^* = \underset{u:|u|_1 \le \frac{R_{\max}}{1-\gamma}}{\arg \min} g_k(u) = \underset{u:|u|_1 \le \frac{R_{\max}}{1-\gamma}}{\arg \min} || \sum_{D_i \in \tilde{D}} D_i X_k u_i - y_k ||_2^2$$
 (227)

From Ang, Andersen(2017). "Continuous Optimization" [Notes]. https://angms.science/doc/CVX we have that if the step size $\alpha_k = \frac{||u_k^*||_2}{L_k\sqrt{T_k+1}}$, after K iterations of the projected gradient descent algorithm we obtain

Where L_k is the lipschitz constant of $g_k(u)$ and u_{T_k} is the parameter estimate at step T_k .

Therefore if the number of iteration of the projected gradient descent algorithm T_k and the step-size α satisfy

Let $(v_i^*, w_i^*)_{i \in (1, \dots, |\tilde{D}|)}, (v_i^{T_k}, w_i^{T_k})_{i \in (1, \dots, |\tilde{D}|)}$ be defined as

$$(v_i^{T_k}, w_i^{T_k})_{i \in (1, \dots, |\tilde{D}|)} = \psi_i'(u_i^{T_k})_{i \in (1, \dots, |\tilde{D}|)}$$
(233)

where $\psi^{'}$ is defined in Equation (51). Further, we define $\theta^*_{|\tilde{D}|}$ and θ^{T_k} as

$$\theta_{|\tilde{D}|}^* = \psi(v_i^*, w_i^*)_{i \in (1, \dots, |\tilde{D}|)}$$
(234)

$$\theta^{T_k} = \psi(v_i^{T_k}, w_i^{T_k})_{i \in (1, \dots, |\tilde{D}|)}$$
(235)

where ψ is defined in Equation (46), $\theta^*_{|\tilde{D}|} = \arg\min_{\theta} \mathcal{L}_{|\tilde{D}|}(\theta)$ for $\mathcal{L}_{|\tilde{D}|}(\theta)$ defined in Appendix B.

Since $(g(u_{T_k}) - g(u^*)) \le \epsilon$, then by Lemma 15, we have

$$|\theta^{T_k} - \theta^*|_1 \le \frac{\epsilon}{C_k'} \tag{241}$$

which according to Equation (238) implies that

$$\begin{split} \mathbb{E}(|Q_{k}(s,a) - Q_{k_{3}}(s,a)|)_{\nu} & \leq & \mathbb{E}(|Q_{k}(s,a) - Q_{\theta_{\tilde{D}}^{*}}(s,a)|)_{\nu} + \mathbb{E}(|Q_{k_{3}}(s,a) - Q_{\theta_{\tilde{D}}^{*}}(s,a)|)_{\tilde{D}} \\ & \leq & \epsilon + \epsilon_{|\tilde{D}|} \end{split} \tag{258}$$

46
