We study a relational perspective of graph database querying. Such a perspective underlies various graph database systems but very few theoretical investigations have been conducted on it. This perspective offers a powerful and unified framework to study graph database querying, by which algorithms and complexity follow from classical results. We provide two concrete applications.

The first is querying property graphs. The property graph data model supersedes previously proposed graph models and underlies the new standard GQL for graph query languages. We show that this standard can be, by and large, expressed by extensions of relational calculus with transitive closure operators (FO[TC]) and existential second-order quantifiers (ESO). With this, we obtain optimal data complexity bounds, along with extensions including schema validation.

The second application is incorporating data from concrete domains (e.g., numbers) in graph database querying. We use embedded finite model theory and, by exploiting a generic Restricted Quantifier Collapse (RQC) result for FO[TC] and ESO, we obtain optimal data complexity bounds for GQL with arithmetics and comparisons. Moreover, we show that Regular Data Path Querying with operations on data (i.e. using register automata formalisms) can be captured in FO[TC] over embedded finite graphs while preserving nondeterministic logspace data complexity.

#### 1 INTRODUCTION

Graph databases have gained an increasing amount of popularity in the last decades, with numerous application domains, including social networks, semantic web, biological and ecological databases, and more. On the practical side, there has been rapid growth in the development of commercial graph database systems, including systems like Neo4j, Oracle, IBM, TigerGraph, and JanusGraph, among others.

Heterogeneity of graph data models in database theory. The study of graph databases in database theory can be traced back to the work of Mendelzon and Wood [\[25\]](#page-16-0) in 1995 on Regular Path Queries (RPQ), where they popularized the data model of edge-labeled graphs. This has been the standard graph data model for a long time in database theory [\[5,](#page-15-0) [9,](#page-15-1) [12,](#page-15-2) [16,](#page-15-3) [17,](#page-15-4) [25\]](#page-16-0)). Since then the area has undergone several paradigm shifts on the notion of a "graph data model", including *data graphs* [\[22\]](#page-15-5) and property graphs [\[1,](#page-15-6) [10,](#page-15-7) [13,](#page-15-8) [14\]](#page-15-9). Data graphs were introduced in [\[22,](#page-15-5) [23\]](#page-16-1) owing to the lack of a treatment of "data" (attributes associated with nodes and edges, like "id", "name" and "age"

of a person) in the data model of edge-labeled graphs. Many classical query languages (like RPQ) have been extended to also incorporate such data [\[1,](#page-15-6) [4,](#page-15-10) [11,](#page-15-11) [22\]](#page-15-5), e.g., in the query language RDPQ (Regular Data Path Queries). Data graphs unfortunately still do not capture the graph model that has been adopted by practitioners, e.g., the "schemaless" nature of a graph. The property graph data model [\[1,](#page-15-6) [10\]](#page-15-7) has been proposed to address such deficiencies, and is today still undergoing an active development.

A property graph [\[1\]](#page-15-6) is a graph whose node and edges are attached with labels, often representing their type, and properties kept in a key-value store. Figure [1](#page-1-0) depicts a property graph  $G_{\text{bike}}$  of bike lanes and roads between towns and crossroads. It has two node types (indicated by their labels—Town and Crossroad). and two edge types (Bike-lane and Road). Towns have properties like name, and coordinates, Bike-lanes have length, and Roads may have tolls. Notice that Bike-lanes are undirected whereas Roads are.

The property graph data model was adopted by the newly suggested standard for graph query languages, namely GQL. The standard is highly influenced by real-world query languages and consists of two parts. The first, SQL/PGQ, is an extension of SQL for graph databases. The second, GQL, is a standalone language for graph databases. It is intended that GQL will serve a similar role for graph databases as SQL for relational databases. In two very recent papers [\[13,](#page-15-8) [14\]](#page-15-9) a digest of this standard was presented to the research community. This formalization opens up a wide range of research questions for database theoriests as summarized in [\[10\]](#page-15-7):

"Given the novelty of the language, and its goal as the future standard of querying property graphs, it is important to fully understand the expressiveness and complexity of its various fragments, in the spirit of many decades of research tradition in database query languages [...]"

These paradigm shifts in graph data models lead to the question, of whether results on prior graph data models still hold and, if so, whether they should be reproven. As argued in [\[1\]](#page-15-6), many algorithmic results from older data models can be adapted in property graphs. This claim must, however, be taken with a grain of salt for two reasons. Firstly, this claim was only backed up by examples without enumerating all results that exist for prior models. Secondly, the notion of "queries" on property graphs is continually being revised to reflect real world graph database systems.

Relational perspective on graphs. The development of data models and query evaluation algorithms for graph databases in database theory seems to have taken place separately from relational databases. That said, it is undeniable that relational database theory possesses a much more mature theory that is rooted in mathematical logic and finite model theory. For this reason, it is natural to wonder whether "relational perspectives" on graph databases can be beneficial. Such perspectives amount to, loosely speaking, encoding the semantics of a graph query  $(e.g.$  on property graphs) as a query over relational structures, and applying complexity results that are available for relational databases. As we will show below, relational perspectives of graph databases yield a powerful method for obtaining algorithmic results for graph querying, particularly the complexity of query evaluation.

Contributions. Under the obvious encoding of property graphs as relational databases, we show that prominent query languages over graphs, in particular, GQL [\[13,](#page-15-8) [14\]](#page-15-9) can be embedded into first-order logic with transitive closure, and second-order logic. Using this, we show that the *data* complexity (i.e. the complexity of query evaluation measured only in the size of the database) of various query languages over graphs are corollaries of existing results over relational databases. Moreover, via translations on logic over embedded finite models (i.e., finite models with access to concrete infinite domains such as numerical theories), we also obtain data complexity bounds for extensions of query languages over graphs with data types,  $e.g.,$  where property values are numbers and arithmetics is allowed in the queries.

More precisely, we establish a close connection between GQL and two logics on relational databases: (i) the transitive closure logic [FO\[TC\],](#page-4-0) and (ii) Second-Order logic [\(SO\)](#page-4-1). Our first result is that basic GQL without restrictions on the shapes of matched paths can be captured by [FO\[TC\].](#page-4-0) Loosely speaking, restrictors allow the user to restrict paths to simple paths (i.e. no repeating nodes), trails (no repeating edges), and shortest paths. This immediately yields an NL upper bound since this is the data complexity of [FO\[TC\]](#page-4-0) over relational structures. Since the graph reachability problem is in NL-complete [\[28\]](#page-16-2) this upper bound is the best we can hope for. Next, we show that basic GQL with restrictors on paths can be captured by [SO.](#page-4-1) With this, we infer an upper bound of polynomial hierarchy PH (i.e. the complexity of [SO](#page-4-1) on relational structures) on the data complexity of GQL. We leave the precise data complexity of GQL with restrictors open, but we mention that the data complexity of GQL is both NP-hard and co-NP-hard since it can express the existence (and non-existence) of simple paths of even lengths, which is NP-hard (resp. co-NP-hard) [\[20\]](#page-15-12).

Next, we show how our embedding to logics on relational databases yields the possibility of extending GQL, while preserving the complexity, with the ability to (1) meta-querying and schema validation (e.g. checking the existence of a path containing only nodes with at least one common attribute), and (2) query data types (in particular, numeric data types and arithmetic operations on them). The second extension was raised as an open problem in the report [\[10\]](#page-15-7) on the standardization of SQL/PGQ and GQL by the working groups. To extend GQL with data types, we exploit classical results [\[6\]](#page-15-13) in constraint databases and embedded finite model theory on the data complexity of [FO\[TC\]](#page-4-0) and [SO,](#page-4-1) when extended with data types, which does not increase the data complexity for evaluation.

As a final result, we show how the recent result [\[11,](#page-15-11) [22\]](#page-15-5) on the NL data complexity of RDPQ (RPQ extended with testing of data values along the path) can be obtained by embedding RDPQ to [FO\[TC\]](#page-4-0) over relational databases with NL data complexity. The same data complexity NL can be obtained even with data types, which follows from a result in embedded finite model theory [\[6\]](#page-15-13).

Organization. After recalling the the basics of property graphs and logics on relational structures in Section [2,](#page-3-1) we illustrate in Section [3](#page-5-0) some applications of relational embedding of property graphs through examples. In Section [4,](#page-6-0) we provide an encoding of GQL to the transitive closure logic and second-order logic, through which we obtain the data complexity of GQL. In Section [5,](#page-11-0) we show how classical embedded finite model theory over relational structures can be used to extend query languages like GQL and RDPQ with data types, and obtain data complexity for them. Due to space limits, full definitions and proofs can be found in the Appendix.

#### <span id="page-3-1"></span>2 PRELIMINARIES: LOGIC AND PROPERTY GRAPHS

We present the definition of property graphs, and the standard definitions of relational structure and logic, along with their classical complexity bounds.

#### 2.1 Property Graphs as Relational Structures

We say that a structure is ordered if it is equipped with a designated binary relation that defines a total order on its active domain.

where  $N^G \subset \mathcal{H}, E_d^G \subset \mathcal{E}_d, E_u^G \subset \mathcal{E}_u$  are finite sets and  $\text{src}^G, \text{tgt}^G \subset (E_d^G \cup E_u^G) \times N^G$  indicate which are the source and target endpoints, respectively, of an edge<sup>[1](#page-3-4)</sup>, property  $G \subset (E^G \cup N^G) \times \mathcal{K} \times \mathcal{P}$ indicate what are the properties of an edge or a node attached to a key, and  $labeled \subset E^G \cup N^G \times \mathcal{L}$ indicates which labels are attached to a node or an edge, where  $E^G = E_d^G \cup E_u^G$ . A graph database  $\mathcal G$ is a tuple  $\langle G_1, \ldots, G_m \rangle$  of [property graphs](#page-3-0)  $G_i$ .

We view a graph database as a relational structure by viewing each of its [property graphs](#page-3-0) as [structures](#page-3-3) interpreting the [vocabulary](#page-11-1) specified in Equation [\(1\)](#page-3-5).

#### 2.2 First and Second-Order Logic

For any  $\bar{x}$ [-valuation](#page-3-8)  $\nu$  and  $\sigma$ [-structure](#page-3-3) S, we define the semantics  $[\![\varphi(\bar{x})]\!]_v^S \in \{\top, \bot\}$  and  $[\![\underline{t}]\!]_v^S \in$ [Const](#page-3-2) for any [formula](#page-4-1) or [term](#page-7-0) whose free variables are in  $\bar{x}$ . We extend [FO](#page-3-8) with transitive closure to obtain FO[TC] by allowing a new type of [formula](#page-4-1)  $[TC_{\bar{u},\bar{v}}(\varphi(\bar{u}\bar{\tilde{v}}))] (\bar{x},\bar{y})$  where  $\varphi$  is a formula, and  $\bar{u},\bar{v},\bar{x},\bar{y}$  are of the same dimension k. We refer to  $\bar{p}$  as "*parameters*". This, along with Proposition [2.1,](#page-4-4) enables us to conclude that on [ordered structures,](#page-3-3) [FO\[TC\]](#page-4-0) is subsumed in [ESO.](#page-4-3)

#### <span id="page-4-5"></span>2.3 Evaluation of first and second-order logic

We are interested in the complexity of evaluation. The *evaluation problem* for a logic  $\mathcal{L}$  is the problem of determining, given a formula  $\varphi(\bar{x})$  in  $\mathcal{L}$ , a [structure](#page-3-3) S and a [valuation](#page-3-8)  $\nu$ , whether  $[\![\varphi(\bar{x})]\!]_y^S = \top$ . The following proposition is well-known (e.g. see [\[21\]](#page-15-14)).

- (1) The [evaluation problem](#page-4-5) for  $FO[TC]$  is NL-complete in data complexity.
- (2) The [evaluation problem](#page-4-5) for [ESO](#page-4-3) is NP-complete in data complexity.
- (3) The [evaluation problem](#page-4-5) for [SO](#page-4-1) is PH-complete in data complexity.

#### <span id="page-5-0"></span>3 APPLICATIONS OF RELATIONAL EMBEDDINGS: A TEASER

In this section, we give a flavor of the kind of queries that can be expressed by embedding graph queries to logic over relational structures. As we will see later in the paper, this can be done without sacrificing data complexity. Our examples focus on the following features: meta-querying (schema querying and validation) and data types. We note that. To the best of our knowledge, there are not any formal results on expressiveness limits for [GQL.](#page-8-0) So while some of the following queries are easily expressible in logic over relational structures, they seem impossible to express in [GQL.](#page-8-0)

Meta-querying. We first start with a pure first-order query (without paths) that epitomizes metaquerying. Suppose we want to do "coreference resolution", that is, identify nodes and edges that may refer to the same entity. To this end, we can write a query of the form: Return all pairs of node and edge id's having the same labels, and the same properties and values. This can be expressed with a first-order logic formula such as

that seems to be not expressible in most graph query languages including [GQL,](#page-8-0) due to limited meta-querying capability (e.g. cannot quantify over properties).

We now proceed to path queries. We start with a simple query that can be expressed in GQL, and show how to express this in [FO\[TC\].](#page-4-0) The query returns pairs of towns having a bike lane path between them. In [GQL](#page-8-0) we can express this query as

where  $\{1..\infty\}$  stands for unbounded repetition. It can also be expressed in [FO\[TC\]](#page-4-0) by

We now proceed to examples that can be expressed in the transitive closure logic and secondorder logic, but it is not clear how (and whether it is possible) to express them in GQL. The first example quantifies over an attribute (i.e. meta-querying) that is then referred to inside the path query. As we will see, the data complexity for this query is still in NL. The following query tests if all nodes along a path share the same attribute by

Note that we used [TC](#page-4-0) in the previous formula but this is just a syntactic sugar because it can be simulated by a second-order quantification that refers to all possible transitive relations of a first-order order formula.

Numeric data types. We now discuss queries with numeric data types, which are currently not supported by GQL. Suppose now that we have a relation  $F_{\text{LOODED}}(x\text{-}coord, y\text{-}coord, radius)$  with reports of flooded areas due to recent storms. Is there a way to go from Meerkerk to Asperen by Bike lanes avoiding flooded areas? We can express such a property by using the the extension of [FO\[TC\]](#page-4-0) with constraints over Real Ordered Field (ROF) [\[6\]](#page-15-13), which is expressed as follows:

Other spatial features can also be added into the query, as is common in constraint databases. For example, we can write that all the nodes in the path from Meerkerk to Asperen lie on a line (see Chapter 13 of [\[21\]](#page-15-14)). Here, we may easily modify the above query by existentially quantifying  $r$ and s such that  $y = rx + s$  for any coordinate  $(x, y)$  in the path between Meerkerk and Asperen. Such a quantification is an example of non-active-domain quantifiers (since  $r$  and  $s$  might not be in the database). Despite this, the data complexity for the extended logic is still NL, as was proven in [\[6\]](#page-15-13). This will be discussed in more detail in Section [5.](#page-11-0)

# <span id="page-6-0"></span>4 FROM GRAPH QUERY LANGUAGES TO LOGIC

In this section, we show how the logics just mentioned capture large fragments of [GQL](#page-8-0) and schema query languages, resulting in upper bounds for data complexity. Different fragments of [GQL](#page-8-0) can be subsumed in [FO\[TC\]](#page-4-0) and [SO](#page-4-1) and [ESO.](#page-4-3) We will follow the definitions of [\[13,](#page-15-8) [14\]](#page-15-9), and briefly present GQL's full syntax, and its semantics by examples. Full definitions can be found in Appendix [B.1.](#page-17-2)

#### 4.1 GQL

Before giving the syntax of GQL which we need to phrase our main complexity result, we give some intuition of the language. We start with an illustrative example.

<span id="page-6-1"></span>Example 4.1. Consider the bike lanes graph depicted in Figure [1,](#page-1-0) and the social network graph in Figure [2.](#page-5-1) The following GQL query answers the question: Does Yan have a friend in a town accessible from his by bike lanes?

The query is computed as follows: we start with a relation that consists of the empty mapping which is the default input. Then, we evaluate the clauses sequentially. The first clause indicates that we should use the social graph. Then, in the match, we join the default input with pairs  $(x, y)$ such that  $x$  is a node id and  $y$  is his friend. We filter the result so that  $x$  is Yan's node, and in the return clause project on  $x, y$ . We get a relation  $R$  with two attributes  $x, y$ . (This projection does not affect the relation and it is there due to GQL's syntax.) We then continue to the use clause which indicates that the graph we are considering now changes. We join  $R$  with the result of the match, that is, pairs  $x'$ ,  $y'$  that represent town ids connected by bike lanes. We obtain a relation with x, y, x', y' as attributes. We then filter it by checking whether the persons in x, y actually live in  $x', y',$  respectively. We then use the return clause to project on the empty set since we are interested in a Boolean query.

As the example illustrates, GQL is built upon path patterns used to extract relations from the graph. GQL manipulates these extracted relation with a sequential form of relational algebra.

The 'let  $x = \chi'$  joins the input table with a relation consisting of mapping from x to values of  $\chi$ . The 'for x in  $\psi$ ' joins the input with the unbinding of  $\psi$  into x (for instance if  $\psi$  is a path then x consists of tuples, each of which is an element in y). Finally, 'filter  $\theta$ ' selects only tuples that satisfy  $\theta$ . Notice that Example [4.1](#page-6-1) contains different GQL clauses.

[Linear queries](#page-8-0) are defined recursively. Firstly, 'use  $GL'$  joins the input relation with the semantics of L evaluated on G; and 'CL' joins the input with L and then with C. Finally, 'return  $\chi_1$  as  $x_1, \ldots, \chi_n$  as  $x_n$ ' joins the input with the relation whose attributes are  $x_1, \ldots, x_n$ 

 $\Gamma$  and values are given by  $\chi_1, \ldots, \chi_n$ . Finally, the semantics of [GQL queries](#page-8-0) are then either a [linear](#page-8-0) [query](#page-8-0) or a construct of the form 'use  $G\{\mathcal{Q}_1$  $G\{\mathcal{Q}_1$  $G\{\mathcal{Q}_1$  then  $\mathcal{Q}_2 \cdots$  then  $\mathcal{Q}_\ell\}$ ' whose semantics is obtained by sequentially applying the queries  $\mathcal{Q}_1, \ldots, \mathcal{Q}_\ell$  $\mathcal{Q}_1, \ldots, \mathcal{Q}_\ell$  $\mathcal{Q}_1, \ldots, \mathcal{Q}_\ell$  on G. Then, there are also the standard set operations —intersection, union and difference.

It is important to emphasize that the binding of the semantics can bind to variables either nodes and edges ids, or constants, or composite elements such as lists and paths. That is, the entries of the output relation are either atomic or composite.

#### <span id="page-8-3"></span>4.2 Translation and Complexity Bounds for GQL

We can now show how to translate [GQL queries](#page-8-0) into logical formulas.

The (Boolean) *evaluation problem* for [GQL](#page-8-0) is that of deciding, given a [GQL query](#page-8-0)  $\mathcal Q$  $\mathcal Q$  and a graph database  $\mathcal{G}$ , whether  $[\mathcal{Q}]]^{\mathcal{G}}$  $[\mathcal{Q}]]^{\mathcal{G}}$  $[\mathcal{Q}]]^{\mathcal{G}}$  is non-empty. The *data complexity of the evaluation problem* is the complexity of approximation problem is the complexity of answering the evaluation problem while regarding  $\mathcal Q$  $\mathcal Q$  as being fixed.

<span id="page-8-2"></span>Fragments in [FO\[TC\]](#page-4-0). We shall henceforth focus on the *basic fragment of GQL*, that is, the fragment excluding variables that are assigned with paths and lists.

*Example 4.4.* The variable z in  $\pi_2$  of Example [4.2](#page-7-6) is mapped to a list of edges since it appears under repetition. The variable  $X$  from the second part of Example [4.3](#page-7-7) is a path binding and hence it is mapped to a path. The basic fragment disallows this kind of assignments by restrictions on the syntax.

We can describe this fragment syntactically as follows:

- no [path-bindings](#page-7-5) in [graph patterns](#page-7-5)
- for every [path pattern](#page-7-1) of the form  $\pi_1 \pi_2$  it holds that  $sch(\pi_1) \cap sch(\pi_2) = \emptyset$  $sch(\pi_1) \cap sch(\pi_2) = \emptyset$  and
- for every [path pattern](#page-7-1) of the form  $\pi^{n...m}$  it holds that  $sch(\pi) = \emptyset$  $sch(\pi) = \emptyset$ .

<span id="page-9-0"></span>The syntactic restriction indeed leads us to have the desired conditions on the output:

PROPOSITION 4.1. The output of the [basic fragment](#page-8-2) of [GQL queries](#page-8-0) is a relation whose entries are not lists nor paths.

We define *restrictor-free* [GQL queries](#page-8-0) as those queries in which [restrictors](#page-7-5) are omitted. That is, queries in which [graph patterns](#page-7-5) [Π](#page-7-5) are restricted to  $\Pi := [X = ]\pi | \Pi, \Pi$ . Over these queries can be translated into [FO\[TC\],](#page-4-0) as specified in the following statement (whose proof can be found in Appendix [B.2\)](#page-20-0).

<span id="page-9-2"></span>THEOREM [4.5.](#page-20-1) For every [basic](#page-8-2) [restrictor-free](#page-9-0) [GQL query](#page-8-0)  $\mathcal Q$  $\mathcal Q$  there is an [FO\[TC\]](#page-4-0) formula  $\varphi_{\mathcal Q}(\bar x)$  where  $\bar{x} = sch(\mathcal{Q})$  such that for every graph database  $\mathcal{G}$ ,

The intuition behind the proof is that whenever we have an unbounded repetition we use the [TC](#page-4-0) operator. All other operations can be quite easily embedded in [FO.](#page-3-8)

This, along with Proposition [2.3](#page-4-6) (1), enable us to conclude the following upper-bound:

COROLLARY 4.6. The data complexity of the evaluation problem for [basic](#page-8-2) [restrictor-free](#page-9-0) GOL queries is in NL.

Does the use of [restrictors](#page-7-5) necessitate a logic that is more expressive than [FO\[TC\]?](#page-4-0) The following lower bound, along with the assumption  $NP \neq NL$ , provide a positive answer to this question.

<span id="page-9-4"></span>PROPOSITION [4.2.](#page-23-0) There exists a [basic](#page-8-2) [GQL query](#page-8-0) that uses either of the [restrictors](#page-7-5) [acyclic](#page-17-2), [trail](#page-17-2) whose [evaluation problem](#page-8-3) is NP-complete.

<span id="page-9-1"></span>Queries and [Second-order logic.](#page-4-1) As it turn out, GQL queries with [restrictors](#page-7-5) can be encoded in [SO.](#page-4-1)  $\ulcorner$  If we want to focus on [ESO](#page-4-3) we need further limitations. We define the *positive fragment* of GQL as that consists of positive queries  $\mathcal{Q}$  $\mathcal{Q}$  $\mathcal{Q}$  without negations  $\neg$  in conditions  $\theta$ , and without except.

<span id="page-9-3"></span>THEOREM [4.7.](#page-23-1) For every [basic](#page-8-2) [GQL query](#page-8-0)  $\mathcal Q$  $\mathcal Q$  there is an [SO](#page-4-1) formula  $\varphi_{\mathcal Q}(\bar x)$  where  $\bar x = sch(\mathcal Q)$  $\bar x = sch(\mathcal Q)$  $\bar x = sch(\mathcal Q)$  such that for every graph database  $G$ ,

Further, if [Q](#page-8-1) is [positive](#page-9-1) and does not use the [restrictor](#page-7-5) shortest then  $\varphi_{\mathcal{Q}}$  is in [ESO](#page-4-3).

The intuition behind the proof of the second part of the theorem is as follows: Assume we have a basic positive query  $\mathcal{Q}$  $\mathcal{Q}$  $\mathcal{Q}$  that does not include restrictors, along with its corresponding [FO\[TC\]](#page-4-0) formula  $\varphi$  that exists due to Theorem [4.5.](#page-9-2) We can existentially quantify over the matched path  $p$  using an [SO](#page-4-1) variable  $X$ , verify that it conforms to the restrictor by an SO formula, and parametrize  $\varphi$  with X such that the parametrized version also verifies that  $p$  is the same path as that represented by  $X$ .

П Theorem [4.7,](#page-9-3) along with Proposition [2.3,](#page-4-6) enables us to conclude the following upper-bound:

Г Corollary 4.8. The data complexity of the [evaluation problem](#page-8-3) for [basic](#page-8-2) [GQL queries](#page-8-0) is in PH, if further the query is positive and does not use the restrictor shortest then complexity is in NP.

# 4.3 Schema Languages for Property Graphs

The relational perspective enables checking whether our graph database conforms to a schema. We adopt the PG-Schema formalism [\[2\]](#page-15-15) for specifying property graph schemas and showing that we can express it naturally without increasing the upper bounds.

To add the ability to check typing, we need to extend the property graph relational encoding by adding Unary predicates for types, e.g., Integer( $\cdot$ ), Real( $\cdot$ ).

Example 4.9. To check whether a node labeled Person conforms to typing conditions, we can require, e.g., that their name is a string. This can be expressed by the [FO](#page-3-8) formula:

 $\forall$ nid, n: property(nid, name, n)  $\rightarrow$  String(n)

Graph databases allow flexibility in modeling the data,  $e.g.,$  two nodes with the same label need not have the same properties. A recent survey [\[27\]](#page-16-3) shows that checking for schema compliance is a highly desirable feature in graph systems. Formalization of a language to check such compliance was presented recently in [\[2\]](#page-15-15). The formalism is called PG-schema and we present it shortly in the following example.

Example 4.10. The following is a formal graph type in the PG-schema formalism:

It defines transportGraphType with two node types townType and crossroadType, and an edge type bikeLaneType. Within the curly braces, there is a list of expected properties with their types. This formal graph type can be translated into a Boolean [FO](#page-3-8) formula that evaluates to ⊤ on the input graph *G* from Figure [1.](#page-1-0)

Formally, PG-schema allows us to define a formal graph type  $S$  whose semantics  $\llbracket S \rrbracket_G$  on a graph  $G$  evaluates to true iff  $G$  satisfies the requirements of  $S$ . (Full details in Appendix [B.4.](#page-25-0))

<span id="page-10-1"></span>THEOREM [4.11.](#page-25-1) Let S be a formal graph type. There is a Boolean [FO](#page-3-8) formula  $\varphi_S()$  such that  $G$ conforms to S if and only if  $[\![\varphi_S(\ )]\!]^{\mathbb{G}} = \top$ 

The proof can be found in Appendix [B.5.](#page-25-2) This allows us to conclude that [FO](#page-3-8) is sufficiently expressive to capture schema conformance which is, hence, in NL.

# 4.4 Graph Path Query Languages on Edge-Labeled Graphs and Data Graphs

 $\Box$  We briefly discuss other data models of graph databases.

Edge-labeled graphs. Firstly, we deal with edge-labeled graphs, which can be interpreted as a [relational structures](#page-3-3) on finite vocabularies consisting of only binary relations representing labeled edges of the graphs.

<span id="page-10-0"></span> $\overline{\Box}$ Queries over edge-labeled graphs are based on Regular Path Queries (RPQs) of Mendelzon and Wood [\[25\]](#page-16-0), which can test the existence of paths adhering to some regular expression. Its closure under conjunction, projection, is known as *Conjunctive Regular Path Queries* (CRPQs) [\[9\]](#page-15-1). Its closure under two-way navigation and transitive closure of binary queries is known as Regular queries [\[26\]](#page-16-4) or Nested Positive 2RPQ [\[8\]](#page-15-16). These languages are subsumed by a simple extension of GPC queries [\[13,](#page-15-8) Theorem 11] which can be trivially expressed in [FO\[TC\].](#page-4-0) As a result, these languages (and their closure under finite unions) are all in [FO\[TC\].](#page-4-0)

Lemma 4.12. [RPQs,](#page-10-0) [CRPQs](#page-10-0) and [Regular Queries](#page-10-0) are expressible in [FO\[TC\]](#page-4-0).

<span id="page-11-2"></span>Data Graphs. A data graph is an edge-labelled finite graph whose nodes carry values from an infinite domain, known as "data values". Here we can model data graphs as [relational structures](#page-3-3) over ternary relations: a tuple  $(u, d, v)$  in some ternary relation R is interpreted as the existence of an edge from  $u$  to  $v$  carrying a label  $(R, d)$  (where  $d$  is the data value). In particular, the paper [\[22\]](#page-15-5) advances the proposal of regular expressions "with memory" (REM), as a way to extend the power regular expressions of [RPQs](#page-10-0) with the ability of testing for (in)equality of data values seen along the path. In a similar vein, a register automata version was also proposed. These query languages are [captured](#page-4-2) by  $FO[TC]$  by using  $k$ -ary transitive closure to encode paths in the product between the [data graph](#page-11-2) and the transition function of the register automata.

<span id="page-11-6"></span>Lemma 4.13. The RDPQs, RQMs and GXPath as defined in [\[22\]](#page-15-5) are in [FO\[TC\]](#page-4-0).

#### <span id="page-11-0"></span>5 INCORPORATING DOMAIN-SPECIFIC OPERATORS

The query languages and logics we have seen so far are capable of checking for properties that combine the topology of the graph structure with the data contained in attributes. Nevertheless, the tests for data properties is limited to equality testing, thus completely ignoring its structure. Practical database query languages typically allow for concrete data domains (e.g. numbers, strings) equipped with a variety of data operations or comparisons (e.g. arithmetics, substrings, order, etc.), which go well beyond equality.

Investigations into relational database queries that incorporate concrete data domains, along with operations on them, were undertaken in the field of *constraint databases* [\[19\]](#page-15-17) and *embedded* finite model theory [\[15\]](#page-15-18). Although these fields have been mostly inactive for the past two decades, we show that classical results in these areas (in particular, [\[6\]](#page-15-13)) can be exploited to extend graph query languages with these data domains, without increasing their data complexity. Concretely, the new results in this section regard: (1) the data complexity for [GQL](#page-8-0) extended with 'data types', and (2) a simpler proof of the NL data complexity of an extension [\[11\]](#page-15-11) of RDPQ with concrete data domains.

 $\Box$ The underlying idea behind constraint databases and embedded finite model theory is to 'embed' a finite database inside an infinite data structure S with a decidable first-order theory. In that way, by incorporating formulas over S into the database queries, one can have access to domain operations within the database. Many such structures can be found in the embedded finite model theory (see, e.g, [\[15,](#page-15-18) Chapter 5]), but among the most prominent ones we can find:

- <span id="page-11-4"></span>П • The Linear Integer Arithmetic (LIA) structure  $\mathfrak{M}_{N,+,<} = \langle \mathbb{N}, 0, 1, +, \leq \rangle$ , that is, where we have <sup>N</sup> as "domain", the constants <sup>0</sup> and <sup>1</sup> (interpreted as <sup>0</sup> and 1), the binary function <sup>+</sup>, and the binary relation  $\leq$ , interpreted accordingly.
- <span id="page-11-3"></span> $\Gamma$ • The Linear Real Arithmetic (LRA) structure  $\mathfrak{M}_{\mathbb{R},+\mathbb{K}} = \langle \mathbb{R}, 0, 1, +\mathbb{K} \rangle$ .
- <span id="page-11-5"></span> $\Gamma$ • The Real Ordered Field (ROF) structure  $\mathfrak{M}_{\mathbb{R},+,\times,\leqslant}=\langle\mathbb{R},0,1,+,\cdot,\leqslant\rangle,$  also known as Tarski's real closed field.

For simplicity we will focus on these three numerical structures, but we mention that other interesting structures exist including reducts of the universal automatic structure [\[7\]](#page-15-19), which allow us to reason about strings.

# 5.1 Embedded Finite Models: The Setting

We briefly introduce here the setting of embedded finite models [\[15,](#page-15-18) Chapter 5].

<span id="page-11-1"></span>The model. Consider an infinite structure  $\mathfrak{M}$  with universe D, over a vocabulary  $\sigma_{\mathfrak{M}}$  containing both function names  $f_1, \ldots, f_n$  and [relation names](#page-3-2)  $R_1, \ldots, R_m$ . We shall henceforth blur the distinction between function/relation names and their interpretation in  $\mathfrak{M}.$ 

Fix a [relational vocabulary](#page-3-7)  $\sigma$ , disjoint from the [vocabulary](#page-11-1) of  $\mathfrak{M}$ . A  $\mathfrak{M}$ -embedded finite relational structure over  $\sigma$  is a finite relational  $\sigma$ [-structure](#page-3-3) S such that [Const](#page-3-2) is taken to be the set of first-order [definable](#page-12-0)  $^3$  $^3$  elements over  $\mathfrak M.$  That is, each [relation name](#page-3-2) of  $\sigma$  is interpreted in  $\mathrm S$  as a finite relation over  $\mathfrak{M}$ [-definable](#page-12-0) elements.

The logic. We define progressively more expressive logic over  $\mathfrak{M}$ -embedded structures: (1) first-order logic [FO](#page-3-8)[ $\mathfrak{M}$ ], (2) hybrid transitive closure logic [FO\[HTC\]](#page-12-2)[ $\mathfrak{M}$ ], (3) hybrid second-order logic  $HSO[\mathfrak{M}]$  $HSO[\mathfrak{M}]$ .

<span id="page-12-3"></span>Г A formula  $\varphi$  in [FO](#page-3-8)[ $\mathfrak{M}$ ] over the [relational vocabulary](#page-3-7)  $\sigma$  is simply a first-order formula over the [vocabulary](#page-11-1)  $\sigma' := \sigma \cup \sigma_{\mathfrak{M}}$ , where we additionally allow the *active-domain quantifier*  $\exists^{adom} x$  $\exists^{adom} x$  $\exists^{adom} x$ . Here, the quantifier  $\exists^{adom} x$  $\exists^{adom} x$  $\exists^{adom} x$  asserts the existence of an element in the [active domain](#page-3-3) of a given [relational](#page-3-3) [structure](#page-3-3) S, whereas the standard quantifier  $\exists x$  asserts the existence of an element in the domain D of  $\mathfrak{M}$  (i.e., not necessarily in the [active domain\)](#page-3-3). The meaning of the formula is immediate from first-order logic, i.e., we interpret this over the structure  $\mathfrak{M}'$  over the vocabulary  $\sigma'$  with domain  $D$ and relations/functions from  $\mathfrak{M}$  and S. Such a formula  $\varphi$  is said to be an *active-domain formula*, if every quantifier therein is an [active-domain quantifier.](#page-12-3) The following is a classical result from  $\Box$  embedded finite model theory (see, e.g., [\[6,](#page-15-13) [15\]](#page-15-18)), which is often called Restricted Quantifier Collapse (RQC).

<span id="page-12-7"></span><span id="page-12-5"></span>PROPOSITION 5.1 ([\[6\]](#page-15-13)). Let  $\mathfrak M$  be either [LRA,](#page-11-3) [LIA,](#page-11-4) or [ROF.](#page-11-5) Each [FO](#page-3-8)[ $\mathfrak M$ ]-formula is equivalent to an [active-domain](#page-12-3) [FO](#page-3-8)[ ${\mathfrak M}$ ]-formula. Therefore, the data complexity for FO[ ${\mathfrak M}$ ] is in TC $^0$ .

The transformation into [FO](#page-3-8)[ $\mathfrak{M}$ ]-formulas in the above proposition yields the complexity TC<sup>0</sup> because an [active-domain formula](#page-12-3) can be evaluated virtually in the same way as a normal [FO](#page-3-8) formula without data types, except that each atomic formula from  $\mathfrak{M}$  will be evaluated using the decision procedures from  $\mathfrak{M}$ . This is also why we obtain TC<sup>0</sup> instead of AC<sup>0</sup> (the data complexity of [FO\)](#page-3-8), since each fixed<sup>[4](#page-12-4)</sup>  $\mathfrak{M}$ -formula (which can be assumed to be quantifier-free for [LRA,](#page-11-3) [LIA,](#page-11-4) and [ROF,](#page-11-5) since they admit quantifier elimination) can be evaluated in  $TC^0$ .

<span id="page-12-2"></span>Interestingly, as shown by Benedikt and Libkin [\[6\]](#page-15-13), the above proposition has been extended to more powerful logics including [FO\[TC\]](#page-4-0) and [SO.](#page-4-1) The trick is to interpret the "higher-order features"  $\sqrt{\ }$  with an active-domain interpretation. The resulting logics are called *Hybrid Transitive Closure Logic* (FO[HTC]) and [Hybrid Second-Order Logic](#page-13-0) [\(HSO\)](#page-13-0), respectively. More precisely, syntactically, we define  $FO[HTC][\mathfrak{M}]$  $FO[HTC][\mathfrak{M}]$  as an extension of  $FO[\mathfrak{M}]$  $FO[\mathfrak{M}]$  with the [TC](#page-4-0)-operators as defined for  $FO[TC]$  in Section [2.](#page-3-1) Semantically, for any interpretation  $\nu$  in a  $\mathfrak{M}$ -embedded structure S, the meaning of

$$
[TC_{\bar{u},\bar{v}}(\varphi(\bar{u}\bar{v}\bar{p}))](\bar{x},\bar{y})
$$
\n(2)

is that there exists a sequence of k-tuples of [active domain](#page-3-3) elements  $\bar{d}_0, \ldots, \bar{d}_n \in \text{adom}(S)^k$  $\bar{d}_0, \ldots, \bar{d}_n \in \text{adom}(S)^k$  $\bar{d}_0, \ldots, \bar{d}_n \in \text{adom}(S)^k$  such that (i)  $[\![\varphi]\!]_{\tilde{u}\tilde{v}\tilde{p}\mapsto \tilde{d}_i\tilde{d}_{i+1}v(\tilde{p})}^S = \top$  for every *i*, (ii)  $\tilde{d}_0 = v(\tilde{x})$ , and (iii)  $\tilde{d}_n = v(\tilde{y})$ . The definition of an [active-domain formula](#page-12-3) from [FO](#page-3-8)[ ${\mathfrak M}$ ] extends to [FO\[HTC\]](#page-12-2)[ ${\mathfrak M}$ ], i.e., each quantifier must be an [active-domain quantifier.](#page-12-3)

<span id="page-12-6"></span>PROPOSITION 5.2 ([\[6\]](#page-15-13)). Let  $\mathfrak M$  be either [LRA,](#page-11-3) [LIA,](#page-11-4) or [ROF.](#page-11-5) Each [FO\[HTC\]](#page-12-2)[ $\mathfrak M$ ]-formula is equivalent to an [active-domain](#page-12-3)  $FO[HTC][\mathfrak{M}]$  $FO[HTC][\mathfrak{M}]$ -formula. Thus, the data complexity for  $FO[HTC][\mathfrak{M}]$  is in NL.

The reasoning for the data complexity in this proposition is the same as for Proposition [5.1.](#page-12-5) Here, we obtain NL because the data complexity for [FO\[TC\]](#page-4-0) is in NL and that  $TC^0 \subseteq NL$ .

<span id="page-12-1"></span><span id="page-12-0"></span> $\Box$ <sup>3</sup>An element  $u \in D$  is definable over  $\Re$  if there exists a  $\Re$ -formula  $\varphi(x)$  such that, for each  $v \in D$ ,  $\lVert \varphi(v) \rVert^{\Re} = \top$  iff  $u = v$ . For example, the set of [definable](#page-12-0) elements over  $\mathfrak{M}_{\mathbb{R}, +, \leqslant}$  is precisely the set of rational numbers.

<span id="page-12-4"></span><sup>&</sup>lt;sup>4</sup>This means that, for a fixed  $\mathfrak{M}$ -formula  $\varphi(\bar{x})$ , the problem of deciding whether  $[\![\varphi(\bar{x})]\!]^{\mathfrak{M}}_{\mu}$  given a mapping  $\mu$  whose domain is  $\bar{x}$ , is in TC<sup>0</sup>.

<span id="page-13-0"></span>Г Finally, we define HSO $[\mathfrak{M}]$  (Hybrid Second-Order Logic) syntactically as an extension of [FO](#page-3-8) $[\mathfrak{M}]$ with second-order quantifiers as defined for [SO](#page-4-1) in Section [2.](#page-3-1) For the second-order quantifiers, we will write  $\exists^{adom}R$  $\exists^{adom}R$  $\exists^{adom}R$  instead of  $\exists R$ . This is because we will interpret  $\exists R\varphi$  as there exists a relation over  $adom(S)$  $adom(S)$  such that  $\varphi$  holds. We define HESO[ $\mathfrak{M}$ ] as a restriction of [HSO](#page-13-0)[ $\mathfrak{M}$ ] to formulas of the form

$$
\exists^{adom} R_1,\ldots,R_n \varphi
$$

where  $\varphi$  is an [FO](#page-3-8)[ $\mathfrak{M}$ ]-formula over  $\sigma_{\mathfrak{M}} \cup \sigma \cup \{R_1, \ldots, R_n\}.$ 

<span id="page-13-1"></span>PROPOSITION 5.3 ([\[6\]](#page-15-13)). Let  $\mathfrak M$  be either [LRA,](#page-11-3) [LIA,](#page-11-4) or [ROF.](#page-11-5) Each [HSO](#page-13-0)[ $\mathfrak M$ ]-formula (resp. HESO[ $\mathfrak M$ ]formula) is equivalent to an [active-domain](#page-12-3) [HSO](#page-13-0) $[\mathfrak{M}]$ -formula (resp. active-domain HESO $[\mathfrak{M}]$ [formula\)](#page-12-3). Therefore, the data complexity for [HSO](#page-13-0) $[\mathfrak{M}]$  (resp. HESO $[\mathfrak{M}]$ ) is in PH (resp. NP).

The reasoning for the data complexity in this proposition is the same as for Proposition [5.1.](#page-12-5) Here, we obtain PH (resp. NP) because the data complexity for [SO](#page-4-1) (resp. [ESO\)](#page-4-3) is in PH (resp. NP) and that  $TC^0 \subseteq NP \subseteq PH$ .

# 5.2 Extending GQL with Data Types

 $\Box$  We will immediately state our main result, before going through the classical results from embedded finite model theory. Fix an infinite structure  $\mathfrak{M}$ . We define now GQL queries with an  $\mathfrak{M}$ -data type. To this end, we first extend the definition of [terms](#page-7-0) to  $\mathfrak{M}$ -terms defined as follows:

$$
\chi := x.a \mid c \mid y \mid f^m(\chi_1, \ldots, \chi_m)
$$

where c is an  $\mathfrak{M}$ [-definable](#page-12-0) constant,  $y$  is a variable ranging over the domain of  $\mathfrak{M},$   $f^m$  is an  $m$ -ary [function name](#page-11-1) in the [vocabulary](#page-11-1) of  $\mathfrak{M}, x \in \vee$  ars,  $a \in \mathcal{K}$ , and every  $\chi_i$  is an  $\mathfrak{M}$ [-term.](#page-7-0) We also extend the definition of [conditions](#page-7-0) to  $\mathfrak{M}$ [-conditions](#page-7-0) by adding

$$
\theta := R^m(\chi_1,\ldots,\chi_m)
$$

where  $R^m$  is an m-ary [relation name](#page-3-2) in the [vocabulary](#page-11-1) of  $\mathfrak{M}$ , and every  $\chi_i$  is an  $\mathfrak{M}$ [-term.](#page-7-0) The semantics of  $\theta$  extends by interpreting  $\chi$  and  $\theta$  "inside"  $\mathfrak{M}$ .

Example 5.1. Suppose that in Example [4.1](#page-6-1) we want to require not only that the town is accessible by bake lanes but also that the Manhattan distance between the two towns is less than a constant  $c$ . To this end, we can add the following filter clause before the final return that will impose this condition:

filter ( $|x'$ .x-coord – y'.x-coord $| + |x'$ .y-coord – y'.y-coord $|) < c$ 

This condition necessitates access to relations such as absolute value, addition, subtraction, and comparison <.

By exploiting Propositions [5.2](#page-12-6) and [5.3,](#page-13-1) our upper bounds extend to GQL queries with data types.

THEOREM 5.2. For every  $\mathfrak{M} \in \{ \mathfrak{M}_{\mathbb{N},+,\leq}, \mathfrak{M}_{\mathbb{R},+,\leq,\leq} \}$ , the data complexity of the evaluation problem of a Boolean GOL query  $\mathcal{Q}$  $\mathcal{Q}$  $\mathcal{Q}$  with an  $\mathfrak{M}$ -data type is

- in NL if  $\mathcal Q$  $\mathcal Q$  is [basic](#page-8-2) [restrictor-free;](#page-9-0)
- in NP if  $\mathcal{Q}$  $\mathcal{Q}$  $\mathcal{Q}$  is [basic,](#page-8-2) [positive](#page-9-1) and uses only the [restrictors](#page-7-5) acyclic, trail;
- in PH otherwise.

Remark 5.3. It is easy to extend [GQL](#page-8-0) to multiple data types (e.g. strings and numbers) by employing multiple infinite structures having [Restricted Quantifier Collapse](#page-12-7) and typed variables, while preserving the same data complexity. The required condition here is that variables of different types are not allowed to "communicate" with each other (i.e. each theory has disjoint function and relation symbols).

# 5.3 Regular Path Queries with Data

Regular data path queries over  $\mathfrak{M}$  (RDPQ[ $\mathfrak{M}$ ]) have been recently introduced [\[11\]](#page-15-11) as a powerful formalism to extend the "data structure blind" RDPQ of [\[22\]](#page-15-5) (as mentioned in [4.13\)](#page-11-6), which is based upon a version of the model of register automata [\[18\]](#page-15-20) running over embedded structures. In a RDPQ[ $\mathfrak{M}$ ]-query, guards and register updates will use general [FO](#page-3-8)[ $\mathfrak{M}$ ]-formulas. In addition, two types of registers are permitted: (1) active-domain registers, which may be modified throughout the automata runs, and (2) general registers, which may not be modified as soon as values have been assigned to them. One main result of [\[11\]](#page-15-11) is the following:

PROPOSITION 5.4. Let  $\mathfrak M$  be either LRA, LIA, or ROF. The data complexity for RDPQ[ $\mathfrak M$ ] is NL.

This was proven by adapting the proof of ROC for [FO](#page-3-8)[ $\mathfrak{M}$ ] (see, e.g., [\[15,](#page-15-18) Chapter 5]) to RDPO[ $\mathfrak{M}$ ]. Our main result is that RDPQ[ $[\mathfrak{M}]$  can be [captured](#page-4-2) by [FO\[HTC\]](#page-12-2)[ $[\mathfrak{M}]$ , and so the data complexity follows already from the classical result of Proposition [5.2](#page-12-6) in embedded finite model theory, without needing to prove new [RQC](#page-12-7) results.

<span id="page-14-0"></span>THEOREM [5.4.](#page-26-0)  $FO[HTC][\mathfrak{M}]$  $FO[HTC][\mathfrak{M}]$  [captures](#page-4-2) RDPQ $[\mathfrak{M}]$ .

<span id="page-14-1"></span>*Example 5.5.* Consider  $\mathfrak{M}$  to be LIA, and  $\sigma$  a [relational vocabulary](#page-3-7) having relations {*value*<sup>[\(](#page-3-7)2[\)](#page-3-7)</sup>,  $a^{(2)}$ ,  $b^{(2)}$ }. Consider the query **q** returning pairs of [active domain](#page-3-3) elements linked via an  $(ab)^*$ -path such that every element in the path has a *value* within 10 units. Let  $\varphi(\textit{curr}, p) =$  $\exists x \text{ value}(curr, x) \land (p - 10 \leq x \leq p + 10)$ , and consider the ERA  $\mathcal{A}$  with one initial state  $q_0$ , one final state  $q_F$ , one extra state  $q_1$ , and one read-only register p. It has transitions  $(q_0, (\text{#}, \varphi), q_F)$ ,  $(q_F, (a, \varphi), q_1)$  and  $(q_1, (b, \varphi), q_F)$ . It follows that the RDPQ  $x \stackrel{\mathcal{J}}{\longrightarrow} y$  expresses the query **q**. Observe that the read-only register  $p$  is used to 'guess' an element that is not far from every other value. Another strategy to implement q would be by using two (normal) registers  $r_{\min}$  and  $r_{\max}$ , while keeping the minimum and maximum value seen so far, and checking that their difference never surpasses 10.

#### 6 CONCLUSIONS

Although the study of graph databases in database theory has evolved separately from relational databases, we have shown — through relational embedding — that many results in graph databases (especially, on the complexity of query evaluation) are in fact corollaries of results on query evaluation on relational databases. To this end, one has to go beyond relational calculus, in particular to extensions with transitive closure and second-order quantification, which have been thoroughly studied in finite model theory [\[21\]](#page-15-14). Through the embedding, we have shown that new results on the complexity of query evaluation can be obtained, in particular of GQL and extensions thereof with meta-querying (i.e. querying and validating schemas) and data types (e.g. numbers). In doing so, we have also contributed to the open problem stated in the recent report [\[10\]](#page-15-7) on the standardization of GQL on extending the current language with data types.

We believe that relational perspectives of graph databases could further benefit the study of graph databases. To this end, we leave a few concrete problems for future work. We have shown through a relational embedding that GQL with restrictors is in [SO](#page-4-1) and therefore its data complexity is in the polynomial hierarchy. Since the current lower bound is only NP-hard and coNP-hard, we leave the precise data complexity for future work. Another interesting problem concerns aggregating over paths (e.g. by summing, counting, averaging, etc. over a given path). Although results on aggregation are available over relational databases (e.g. in embedded finite model theory), most positive results (e.g. see Chapter 5 of [\[15\]](#page-15-18)) do not admit paths (i.e. not go beyond first-order logic). We propose to extend the results of [\[6\]](#page-15-13) on [FO\[HTC\]](#page-12-2) and [SO](#page-4-1) to also admit aggregation.

We say that a path  $p_2$  concatenates to a path  $p_1$  if tgt( $p_1$ ) = src( $p_2$ ). In this case,  $p_1p_2$  is the concatenation of the paths. To emphasize, we write path(p). For partial mappings  $\mu_1, \mu_2$ : [Vars](#page-3-6)  $\rightarrow N \cup E$ , we use  $\mu_1 \sim \mu_2$  to denote that for every  $x \in dom(\mu_1) \cap dom(\mu_2)$  $x \in dom(\mu_1) \cap dom(\mu_2)$  $x \in dom(\mu_1) \cap dom(\mu_2)$ , it holds that  $\mu_1(x) = \mu_2(x)$  where  $dom(\mu)$ denotes the domain of  $\mu$ .

Discrepancies. Our language is different in two aspects:

Assumption (iii) is for the sake of presentation but all results apply also when extending the data model and the query language (in particular, [path patterns\)](#page-7-1) to support it.

Since we only consider [basic](#page-8-2) [restrictor-free](#page-9-0) graph patterns, we only need to take care of the case  $\Pi = \Pi_1, \Pi_2$ . The base case is when  $\Pi_1$  and  $\Pi_2$  are path patterns. In this case, Lemma [B.1](#page-20-2) ensures that there are  $\varphi_{\Pi_1}(\bar x, \bar y)$  and  $\varphi_{\Pi_2}(\bar x, \bar z)$  for which the equivalence stated in the lemma holds. (Notice that we can assume wlog that the variables are ordered like stated - first joint free variables of  $\varphi_{\Pi_1}$  and  $\varphi_{\Pi_2}$  and then the rest.) - [basic](#page-8-2) Boolean [GQL queries](#page-8-0) with the [trail](#page-17-2) [restrictor](#page-7-5) [capture](#page-4-2) Boolean [RPQs](#page-10-0) under trail semantics, [9](#page-23-3)

and that there [RPQs](#page-10-0) whose evaluation is NP-hard in data complexity both under the [simple path](#page-23-4) and [trail semantics](#page-23-4) (see, e.g., [\[3,](#page-15-21) [24\]](#page-16-5)).  $\Box$

Further, if  $\mathfrak Q$  $\mathfrak Q$  is [positive](#page-9-1) and does not use the [restrictor](#page-7-5) shortest then  $\varphi_{\mathfrak Q}$  is in [ESO](#page-4-3).

Therefore, the target formula is  $\varphi(x) := \exists M \psi^{\text{lin}}(M) \wedge \psi^{\text{adom}}(M) \wedge \varphi''_M$  $(\bar{x})$ .

To incorporate the restrictors, we need to parameterize the translation of  $\pi$  with a ternary relation  *which is existentially quantified and describes the restricted nature of the path matched* to the pattern. Recall that acyclic paths (trails) are those in which there are no repeating nodes (edges).

Recall that by Lemma [B.2](#page-22-0) we know that for every [basic](#page-8-2) [restrictor-free](#page-9-0) graph pattern [Π](#page-7-5) there is an [FO\[TC\]](#page-4-0) formula  $\varphi_{\Pi}(\bar{x})$  such that  $\bar{x} = sch(\Pi)$  $\bar{x} = sch(\Pi)$  $\bar{x} = sch(\Pi)$  and for every property graph G and partial mapping  $\mu$  the following are equivalent:

- $\exists \bar{p} : (\bar{p}, \mu) \in [\![ \Pi ]\!]^G$ <br>•  $\mathbb{F}_q$   $(\bar{x}) \mathbb{F}_q^G$   $= \top$
- $[\![\varphi_\pi(\bar{x})]\!]_{\mu(\bar{x})}^G = \bar{T}$

We now obtain a parametrized version of this

We can encode acyclic paths  $(n_1, e_1, \ldots, n_k, e_k, n_{k+1})$  with a ternary relation  $R^{(3)}$  by instantiating it with  $R^{(3)}(n_j, e_j, n_{j+1})$  for every  $1 \leq j \leq k$ . Given a ternary R we can write an [FO](#page-3-8) formula  $\psi^{\text{acyclic}}(R)$  that returns ⊤ if and only if R is an instantiation of an acyclic path. We are now ready to show the following:

It can be shown directly that the conditions of the lemma hold. □

We can use a similar strategy for trail by changing  $\psi^{\text{acyclic}}(R)$  to  $\psi^{\text{trail}}(R)$  which can be expressed in [FO.](#page-3-8) Formally, we have:

These two lemmas allow us to conclude the second part of Theorem [4.7.](#page-9-3)

For the first part of the theorem, let us consider the restrictor shortest. The strategy we take here is somewhat similar but we need quantifier alternation. The intuition is that we can again existentially quantify over that path and make sure it conforms to the restrictor. How can we do so? we know that if a path is the shortest then it contains no repeating nodes and no repeating edges, and there is a bijection from its elements to the elements of any other path. Therefore, we can write similarly to before:

$$
\exists R: \left(\varphi^R_\pi(\bar{x}) \land \forall S: \varphi^R_\pi(\bar{x}) \to \text{bijection}_{R,S}() \right)
$$

where R, S are second-order variables and bijection<sub>R, S</sub>() is an [FO](#page-3-8) formula that returns ⊤ iff there is a bijection from  $R$  to  $S$ . This allows us to conclude the following:

PROOF. We first give an idea for the proof (below) by showing how to capture Example [5.5](#page-14-1) above. Let  $\psi(x, x', p)$  be the formula expressing that there is a path " $x \stackrel{a}{\rightarrow} z \stackrel{x'}{\rightarrow}$ " for some z such that

 $\varphi(x_{curr}, p)$  (as defined in Example [5.5\)](#page-14-1) holds for all  $x_{curr} \in \{x, z, x'\}$ . It follows that

$$
\xi(x_s, x_t) = \exists p \ \mathsf{TC}_{u,v}(\psi(x, x', p)[x/u, x'/v])(x_s, x_t)
$$

expresses the existence of a path from  $x_s$  to  $x_t$  with the desired property.

We now continue with the proof of the above theorem. Let  $x \stackrel{\mathcal{J}}{\longrightarrow} y$  be an RDPQ([FO](#page-3-8),  $\sigma, \mathfrak{M}$ ) over the  $\langle \sigma, \mathfrak{M} \rangle$ -ERA  $\mathcal{A} = (R, P, Q, Q_0, F, \Delta)$ . To avoid unnecessary technical details, let us assume that  $\mathcal A$  is so that every sequence of transitions

where  $q_0 \in Q_0$  verifies that  $\alpha_0 = \#$  and  $\alpha_i \neq \#$ , for every  $i > 0$ . It is easy to see that this is without any loss of generality.

Let  $Q = \{q_1, \ldots, q_n\}$ . For simplicity, we will first assume that the structure has at least *n* distinct elements from the [active domain,](#page-3-3) which we will use to encode the states of the automaton. That is, the formula we will produce will be of the form

$$
\exists x_{q_1},\ldots,x_{q_n} \bigwedge_{i \neq j} x_{q_i} \neq x_{q_j} \wedge \cdots,
$$

where the rest of the formula will use the  $x_{q_i}$  variables to encode the automata states. We will later discuss how to adapt the formula should the embedded structure have less than  $n$  [active domain](#page-3-3) elements

Suppose  $R = \{r_1, ..., r_\ell\}$  and  $P = \{p_1, ..., p_s\}$ .

Consider any transition  $tr = (q, a, \varphi(x_{curr}, \bar{x}_R, \bar{x}'_R, \bar{x}_P), q')$  of  $\Delta$ , where  $\bar{x}_R = x_{r_1}, \ldots, x_{r_\ell}, \bar{x}'_R =$  $x'_{r_1},\ldots,x'_{r_\ell}, \bar{x}_P = x_{p_1},\ldots,x_{p_s}$ . We define the formula  $\rho_{tr}(x_{curr}, x'_{curr}, x_{state}, x'_{state}, \bar{x}_R, \bar{x}'_R, \bar{x}_P)$  associated to this transition to be

$$
a(x_{curr}, x'_{curr}) \wedge (x_{state} = x_q) \wedge (x'_{state} = x_{q'}) \wedge \varphi(x_{curr}, \bar{x}_R, \bar{x}'_R, \bar{x}_P).
$$

That is  $x_{curr}$ ,  $x'_{curr}$  bind to the constants that  $\cal{A}$  is currently traversing;  $x_{state}$ ,  $x'_{state}$  to the constants representing the traversed state; and  $\bar{x}_R, \bar{x}'_R$  represent as usual the pre- and post-conditions for registers; and  $\bar{x}_P$  the parameters. If instead of a relation a we have # we need to simply do the same but stay put. That is, for any transition  $tr = (q, \#, \varphi(x_{curr}, \bar{x}_R, \bar{x}'_R, \bar{x}_P), q')$  of  $\Delta$ , where  $\bar{x}_R = x_{r_1}, \ldots, x_{r_\ell}$ ,  $\bar{x}_R' = x_{r_1}', \ldots, x_{r_\ell}', \bar{x}_P = x_{p_1}, \ldots, x_{p_s}.$  We define the formula  $\rho_{tr}(x_{curr}, x'_{curr}, x_{state}, x'_{state}, \bar{x}_R, \bar{x}_R', \bar{x}_P)$ associated to this transition to be

Let  $\rho$  be the disjunction of all the  $\rho_{tr}$  for all transitions  $tr$  in  $\Delta$ . We can now define the formula representing an (accepting) run of  $\mathcal A$  on a path of a structure. It is simply the transitive closure of  $\rho$ , where we use, as [parameters,](#page-4-0) the variables  $\bar{x}_Q = x_{q_1}, \ldots, x_{q_n}$  representing the states and the variables  $\bar{x}_P$  representing the read-only registers. Finally, one must check that the transitive closure of  $\rho$  applies where  $x_{curr}$  and  $x'_{curr}$  bind to the only two free variables of the formula. Further,  $x_{state}$ and  $x'_{state}$  bind to initial and final states respectively,  $\bar{x}_R$  and  $\bar{x}'_R$  bind to any pair of register (active

<span id="page-28-0"></span>domain) valuations, and  $\bar{x}_P$  binds to any valuation. Formally, we define

Small structures. The above encoding fails on embedded structures with less than  $n$  [active domain](#page-3-3) constants. If the structure has, nevertheless, at least two constants, then we can still do the encoding with vectors of size  $\lceil \log n \rceil = m$ . Concretely, we replace
