He was the first to propose that the Earth	to advance the idea of a sun-centered cosmos. The idea, however, was not taken seriously until the sixteenth century. Nicolaus Copernicus (1473–1543), a Polish astronomer and canon of the church, is sometimes regarded as the founder of modern astronomy. His book On the Revolution of the Celestial Spheres, published days before his death in 1543, proposed that earth turned once daily on its axis and traveled in an annual path around the sun. As a challenge to the old geocentric universe, Copernicus had advanced a new heliocentric (sun-centered) cosmology. In terms of	the astronomers encouraged by this insight was another Northern European perfecting himself as a humanist in Italy. Nicholas Copernicus, born the year Regiomontanus published Peurbach’s epitome of Ptolemaic planetary theory (1473), studied at the University of Cracow and then, in 1496, went to Italy to learn law and medicine in preparation for an ecclesiastical career. He also studied Greek literature. His subsequent position as a cathedral canon in a region contested by Polish and German princes, and also by Prutenic Knights, left him little time to polish his version of proper astronomy.

This early knowledge formed the foundation for the work of Galileo Galilei (1564–1642), who stands out as the dominant facilitator of the entrance of physics into the modern era. In 1609 he became one of the first to make astronomical observations with a telescope. He observed mountains on the Moon, the larger satellites of Jupiter, spots on the Sun, and the phases of Venus. Galileo’s observations convinced him of the correctness of the Copernican theory. His quantitative study of motion formed the foundation of Newton’s revolutionary	seen, Kepler placed the Sun at the focus of a planet’s elliptic orbit. It is Kepler’s theory that we often ascribe to Copernicus. Another genius was needed to make Copernicus’s idea plausible to philosopher and layman alike. Galileo, born in Pisa, Italy, in 1564, became perhaps the first true physicist in the modern sense. His famous experiments with falling bodies introduced another heretical notion—that material bodies could move freely in space if there was no friction to impede their motion.
