An Important Distinction for #2:

A performance funding policy that adds to or reallocates a portion of existing recurring appropriations

OR

A comprehensive state funding model that includes performance as one important component



Linking Costs, State Priorities, and Funding

- Preserving the value of an institution as a state asset
- Recognizing variation in fixed and variable costs
- Aligning state goals with a rational funding strategy that has three critical elements
 - 1. Differentiated roles
 - 2. Predictability & sustainability
 - 3. Improvement
- Serving current students effectively AND serving more and different students better
- Variation in capacity to generate revenue



Components of the Efficiency Review

- 1. Review of state reports on efficiency measures/initiatives in higher education
- 2. National survey of SHEEO agencies
- 3. Survey of Missouri public institutions
- 4. Review of institutional missions
- 5. Assessing opportunities for collaborative activity
- 6. Visits to select campuses



Timeline & Next Steps

- 1. Recommend that the legislature adopt conceptual framework that reflects both costs and performance, but delay implementation until after the 2024 session.
- 2. Use coming months to develop parameters and measures.
- 3. NCHEMS to develop a model and gather feedback.
- 4. Beginning in 2023, undertake the assessment of efficiency at Missouri's public institutions.
- 5. Produce report due June 1, 2023.
