 - 4.2 the publication of the Advertisement by Headline Daily will not be in breach any contract or violate any copyright, trademark, any applicable laws and rules, or any other personal or proprietary right of any person.
- 5. Headline Daily will not be liable for any loss, damage or claim resulting from the failure of any Advertisement to appear from any cause whatsoever, or for the failure of an Advertisement to appear on a specified date.
- 6. Advertisement materials must conform to the production and quality specifications and any other requirements stipulated or referred to in the Rate Card. - 7. The Advertiser submitting the Advertisement shall indemnify Headline Daily against all costs, losses, damages and liabilities arising out of any claims, legal actions or threatened legal actions in relation to or arising from the publication of the Advertisement in accordance with the copy instruction or advertising contract supplied to Headline Daily by the Advertiser.
- 8. If Headline Daily does not receive amendment of copy instructions before the material deadline, it reserves the right to repeat the copy last used and the advertiser shall be in any event liable to pay the full cost of such advertisement published. Late delivery of advertising material or cancellation of booking after the deadline will result in forfeiture of the space reserved and the Advertiser shall be liable to pay the full cost in any event.

- its own expenses collect them at the office of Headline Daily within two months after publication of the advertisement, failing which Headline Daily shall be entitled to destroy them as it deems fit without any liability to the Advertiser.

Headline Daily will not entertain any claims made by the Advertiser in respect of any error in the Advertisement if such claim is made after the fourteenth day following that in which the Advertisement appears. The liability of Headline Daily shall be limited to a maximum at its option of repaying the charge for the Advertisement or republishing the Advertisement free of charge for a second time.
