NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will consider adopting a resolution approving the Central Coast Regional Water Quality Control Board's amendment to the Water Quality Control Plan for the Central Coastal Basin (Basin Plan) establishing total maximum daily loads for nitrogen compounds in the Santa Ynez River basin, Santa Barbara County and the supporting Substitute Environmental Documentation.
