NOTICE OF OPPORTUNITY TO COMMENT AND NOTICE OF PUBLIC WORKSHOP

PROPOSED ADOPTION OF THE STATE FISCAL YEAR (SFY) 2019-20 (FEDERAL FISCAL YEAR (FFY) 2019) INTENDED USE PLAN (IUP) FOR THE CLEAN WATER STATE REVOLVING FUND (CWSRF) AND REVISED GUIDELINES FOR THE SMALL COMMUNITY GRANT FUND (SCGF) PROGRAM (SCGF GUIDELINES)

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will consider adopting the IUP for the CWSRF program and revised SCGF Guidelines as early as the Tuesday, June 18, 2019 Board Meeting.

NOTICE IS ALSO HEREBY GIVEN that the Division of Financial Assistance (DFA) will hold a webcasted public workshop on April 30, 2019. The purpose of the workshop will be to provide an overview of the CWSRF IUP and to receive public input regarding the draft IUP.

BACKGROUND

The CWSRF program provides low-cost financing statewide for wastewater treatment and recycling, non-point source, estuary, storm water, and combined sewer system projects. The SCGF program supplements the CWSRF program, providing grants through Proposition 1, Proposition 68, and other sources to small disadvantaged communities and small severely disadvantaged communities for wastewater projects.

The CWSRF IUP outlines the State Water Board's business plan for the CWSRF and the associated funding programs for state fiscal year (SFY) 2019-20, including revised SCGF Guidelines. It specifically identifies the available funding, the projects eligible for financing, the associated financing terms, and the measures that will be used to track the programs' performance.

The IUP is required by federal statutes and regulations and will be included in the application submitted to the United States Environmental Protection Agency (U.S. EPA) for the FFY 2019 Capitalization Grant. The SCGF Guidelines for the implementation of Proposition 1 and Proposition 68 are required by those voter-approved propositions.
