SUBJECT: All-day CORE conference, Dunnellon, Florida, June 20th, 1964.

DATE: June 22, 1964.

As stated in earlier reports, we felt that both the Gainesville and Dunnellon Groups were in need of further exposure to CORE methods and philosophy. Thus, we organized the conference, a detailed agenda for which is enclosed. Prior to the conference I went to Dunnellon to put out leaflets, a copy of which is enclosed.

The conference went off well, for the most part. It was attended by an interracial group of six from Gainesville, and about 30 Dunnellon citizens, including three adults, the rest of high school and college-age. The evening mass meeting was attended by about 90 persons, a larger number of adults.

Dunnellon CORE has initiated a boycott of certain stores which refuse to hire or promote without regard to race. The group announced the boycott at previous meetings, and it plans to begin publishing the names of persons breaking the boycott in local newspapers. To further support the boycott, Dunnellon CORE will begin picketing these establishments this week, perhaps today. The group has submitted a nine-point list requesting certain concessions by the city government. If this boycott proves effective and some of these points are not met, a more extensive boycott will be initiated.

The conference came at a fortunate time, because a number of teenagers, stimulated partly by the night marches in St. Augustine, have begun small nightly marches through the city not connected with CORE. The conference served to bring them back into the group where they received needed training and support from the adults who mainly make up Dunnellon CORE. Dunnellon CORE has a tremendous potential for immediate and significant work and gains in that city. We hope to be able to continue working with them to give them the guidance and support they may need.
