## 5.1 Statutes and Bylaws

The SC budget for 2025 will be revised in autumn 2024, taking requirements of the chapters into consideration. Applications for Summer Schools will be processed through the Advisory Committee.

Cnl advised LT and NP to inform Consortium officers to mention their SC involvement when applying for travel grants.
