### PROPOSED DECISION

Claimant brings this claim against the Republic of Iraq ("Iraq") alleging that Iraq held him hostage in violation of international law from August to December 1990. Because he has established that Iraq held him hostage for 130 days, he is entitled to an award of \$800,000.

#### BACKGROUND AND BASIS OF THE PRESENT CLAIM

Claimant alleges that he was a military service member stationed at the U.S. Embassy in Kuwait when Iraq invaded the country on August 2, 1990. He asserts that, beginning with the invasion and for approximately 18 weeks thereafter, he was "prohibited from leaving Iraqi controlled territory and [was] otherwise detained as a hostage in Kuwait and Iraq by the Iraqi regime in violation of international law." According to Claimant, he was initially confined to the U.S. Embassy in Kuwait and then later traveled in a convoy to Baghdad, Iraq, where he remained confined first to the U.S.

Embassy in Baghdad and then in two State Department-issued residences. After the Iraqi government authorized all foreign nationals remaining in Kuwait and Iraq to leave, Claimant flew from Baghdad to Frankfurt, Germany, on December 9, 1990, and continued on to the United States the following day.

Although Claimant was not among them, many of the U.S. nationals in Iraq and Kuwait at the time of the 1990-91 Iraqi occupation of Kuwait sued Iraq (and others) in federal court for, among other things, hostage-taking. Those cases were pending when, in September 2010, the United States and Iraq concluded an *en bloc* (lump-sum) settlement agreement. The Agreement, which entered into force in May 2011, covered a number of personal injury claims of U.S. nationals arising from acts of the former Iraqi regime occurring prior to October 7, 2004, including claims of personal injury caused by hostage-taking. Exercising its authority to distribute money from the settlement funds, the U.S. Department of State provided compensation to numerous individuals whose claims were covered by the Agreement, including some whom Iraq had allegedly taken hostage or unlawfully detained following Iraq's 1990 invasion of Kuwait.

Under the International Claims Settlement Act of 1949 ("ICSA"), the Secretary of State has statutory authority to refer "a category of claims against a foreign government" to this Commission.<sup>4</sup> The Secretary has delegated that authority to the State Department's Legal Adviser, who, by letter dated October 7, 2014, referred three

categories of claims to this Commission for adjudication and certification.<sup>5</sup> This was the State Department's second referral of claims to the Commission under the Claims Settlement Agreement, the first having been by letter dated November 14, 2012 ("2012 Referral" or "November 2012 Referral").<sup>6</sup>

One category of claims from the 2014 Referral is applicable here. That category, known as Category A, consists of

claims by U.S. nationals for hostage-taking<sup>1</sup> by Iraq<sup>2</sup> in violation of international law prior to October 7, 2004, provided that the claimant was not a plaintiff in pending litigation against Iraq for hostage taking<sup>3</sup> at the time of the entry into force of the Claims Settlement Agreement and has not received compensation under the Claims Settlement Agreement from the U.S. Department of State. . . .

On October 23, 2014, the Commission published notice in the Federal Register announcing the commencement of the second Iraq Claims Program pursuant to the ICSA and the 2014 Referral.<sup>7</sup>

On October 23, 2015, the Commission received from Claimant a completed Statement of Claim seeking compensation under Category A of the 2014 Referral, together with exhibits supporting the elements of his claim.

#### DISCUSSION

#### Jurisdiction

This Commission's authority to hear claims is limited to the category of claims referred to it by the United States Department of State.<sup>8</sup> The Commission's jurisdiction under the "Category A" paragraph of the 2014 Referral is limited to claims for hostagetaking of (1) "U.S. nationals," provided that the claimant (2) was not a plaintiff in any litigation against Iraq for hostage taking pending on May 22, 2011 (the "Pending Litigation"), and (3) has not received compensation under the Claims Settlement Agreement from the Department of State. 2014 Referral ¶ 3.

#### *Nationality*

This claims program is limited to claims of "U.S. nationals." Here, that means a claimant must have been a national of the United States when the claim arose and continuously thereafter until May 22, 2011, the date the Agreement entered into force.<sup>9</sup> Claimant satisfies the nationality requirement. He has provided a copy of his U.S. birth certificate, as well as a copy of his 2016 Oklahoma voter registration card, which together show that he was a U.S. national at the time of the alleged hostage-taking (August to

December of 1990) and that he remained a U.S. national through the effective date of the Claims Settlement Agreement.

### No Pending Litigation

Additionally, Category A states that the claimant may not have been a plaintiff in any of the so-called Pending Litigation cases at the time of the entry into force of the Claims Settlement Agreement. Footnote 3 of the 2014 Referral specifically lists the Pending Litigation cases for purposes of the Referral. Claimant has averred under oath in his Statement of Claim, and the pleadings in the cases cited in footnote 3 confirm, that he was not a plaintiff in any of those Pending Litigation cases. The Commission thus finds that Claimant has also satisfied this element of his claim.

# No Compensation under the Claims Settlement Agreement from the Department of State

The Claimant also satisfies the final jurisdictional requirement. Claimant has stated that he has never "received any compensation under the [U.S.-Iraq] Claims Settlement Agreement from the Department of State." Further, we have no evidence that the State Department has provided him any compensation under the Claims Settlement Agreement. Therefore, Claimant meets this element of his claim.

In summary, this claim is within the Commission's jurisdiction pursuant to the 2014 Referral and is entitled to adjudication on the merits.

# <u>Merits</u>

## Factual Allegations

Claimant states that Iraq held him hostage from August 2, 1990, until December 9, 1990, a total of 130 days. He alleges that he was the Detachment Commander of the

Marine Security Guard Battalian at the U.S. Embassy in Kuwait when Iraq invaded the country on August 2, 1990.<sup>11</sup> That morning, Claimant was at his villa near the Embassy with his wife and daughters when he received a phone call from the Embassy notifying him of the invasion. Claimant was told to report to the Embassy, which he did, and his family joined him there later that afternoon.

Claimant states that he and his family remained at the Embassy until August 23, 1990, when the Iraqis "allowed [them] to evacuate the Embassy in a convoy of diplomatic vehicles bound for Baghdad, where [they] were to receive exit visas before continuing on to Jordan." Claimant joined this convoy, but when it arrived in Baghdad, they "learned that the Iraqi regime had reneged on its promise to allow [them] to proceed to Jordan[,]" and that they "would be forced to remain in Baghdad" until the United States closed its Embassy in Kuwait and its diplomats there were evacuated. A couple of days later, however, the Iraqi government "authoriz[ed] the departure of the women and children who had evacuated the Kuwait Embassy, but require[ed] that all of the adult males remain in Baghdad." Claimant's wife and daughters thus set off in another convoy to the Turkish border, and Claimant remained confined to the U.S. Embassy in Baghdad for the next couple of weeks. He then moved to one, and later another, State Department-issued residence outside of the Embassy compound, where he remained for an additional three months.

On December 6, 1990, the Iraqi government released all foreign nationals remaining in Iraq and Kuwait, 12 and on December 9, 1990, Claimant boarded a flight to

Frankfurt, Germany, where he remained for one night before continuing on to the United States.

# Supporting Evidence

Claimant has supported his claim with, among other things, two sworn declarations, dated March 11, 2016, and December 5, 2017, in which he describes his ordeal in Kuwait and Iraq; a copy of his Permanent Change of Station Orders, dated September 7, 1989, containing his orders to report to the U.S. Ambassador in Kuwait; a copy of a U.S. Marine Corp Report of Casualty, indicating that Claimant "was part of [the] Kuwait Embassy Military Element surrounded by hostile Iraqi forces[,]" and noting that Claimant was "in a missing status from 2 Aug 90 until 10 Dec 90[]"; a copy of an unclassified U.S. State Department cable noting that Claimant and his family were evacuated from Kuwait on August 23, 1990, "in personal autos"; a copy of Claimant's American Embassy, Baghdad identification card (expiring December 31, 1990); a copy of a Meritorious Honor Award from the U.S. Department of State to Claimant (and others from the American Embassy in Kuwait) for their actions "occasioned by the Iraqi invasion of Kuwait on August 2, 1990[]"; and a contemporaneous newspaper article that mentions Claimant by name and describes his continuing hostage ordeal after his family returned home.

Claimant has also submitted sworn declarations from two other individuals employed at the U.S. Embassy in Kuwait City futher supporting Claimant's presence during the dates alleged and the details of his captivity. For each individual, Claimant has provided a declaration from late 2017, and another which was submitted as part of the *Vine* litigation.<sup>13</sup> Claimant has also provided, for each declarant, a copy of his then-

current U.S. passport; both passports contain, *inter alia*, an Iraqi exit stamp dated December 9, 1990, and one of them contains a Kuwaiti entry stamp dated July 15, 1990. Further, attached to one of the declarations is a contemporaneous newspaper photograph said to depict Claimant and the declarant stepping off the plane together in the United States after their evacuation from Baghdad.

Claimant has also submitted a number of documents that provide background about the broader geopolitical situation during the First Gulf War in 1990-91, including some that relate specifically to the circumstances faced by U.S. nationals in Iraq and Kuwait at the time. These documents include statements from U.S. and Iraqi officials, resolutions of the United Nations Security Council, newspaper articles, a report from Amnesty International on human rights violations committed by Iraq in 1990, unclassified cables and a memorandum from the U.S. Department of State, and affidavits submitted in two lawsuits brought by other U.S. nationals who were also in Kuwait or Iraq during the First Gulf War.

Claimant has also provided a list containing flight designations and the departure dates of flights that were used to evacuate U.S. nationals and their family members from Iraq and Kuwait. That list was appended to a December 18, 1990 memorandum that was sent to the U.S. Secretary of State by Elizabeth Tamposi, who was then the Assistant Secretary of State for Consular Affairs. The list includes the flight Claimant alleges he boarded in Iraq, and verifies the date of departure, as well as its transit through Frankfurt, Germany.

Additionally, the Commission takes notice of Federal News Service transcriptions of press briefings by U.S. government officials, news articles, and publically available unclassified State Department documents that provide further information about Iraq's

treatment of U.S. diplomatic personnel accredited to the U.S. Embassy in Kuwait and their dependents after the August 2, 1990 invasion.

# Legal Standard

To make out a substantive claim under Category A of the 2014 Referral, a claimant must show that (1) Iraq was engaged in an armed conflict and (2) during that conflict, Iraq took the claimant hostage. <sup>14</sup> The Commission has previously held that, to establish a hostage-taking claim under international law in this program, a claimant must show that Iraq (a) seized or detained the claimant and (b) threatened the claimant with death, injury or continued detention (c) in order to compel a third party, such as the United States government, to do or abstain from doing any act as an explicit or implicit condition for the claimant's release. <sup>15</sup> A claimant can establish the first element of this standard by showing that the Iraqi government confined the claimant to a particular location or locations within Iraq or Kuwait, or prohibited the claimant from leaving Iraq and/or Kuwait. <sup>16</sup> The legal standard we apply in this program applies equally to diplomatic personnel and their families. <sup>17</sup>

#### Application of Standard to this Claim

(1) Armed Conflict: Claimant alleges that Iraq took him hostage in Kuwait on August 2, 1990, and held him hostage for 130 days, until December 9, 1990, when Iraqi officials allowed him to leave Iraq. In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission held that during this entire

period, Iraq was engaged in an armed conflict with Kuwait.<sup>18</sup> Thus, Claimant satisfies this element of the standard.

(2) <u>Hostage-taking</u>: To satisfy the hostage-taking requirement of Category A of the 2014 Referral, Claimant must show that Iraq (a) seized or detained him and (b) threatened him with death, injury or continued detention (c) in order to compel a third party, such as the United States government, to do or abstain from doing any act as an explicit or implicit condition for his release. Claimant satisfies this standard for the 130-day period from August 2, 1990, to December 9, 1990.

(a) <u>Detention/deprivation of freedom</u>: For purposes of analyzing Claimant's allegations of having been detained, his time in Kuwait and Iraq following the Iraqi invasion can be divided into three periods: (i) between the Iraqi invasion on August 2, 1990, and the State Department's August 7, 1990 announcement recognizing that U.S. diplomats in Kuwait were in the same position as "private American citizens"; (ii) between that August 7, 1990 announcement and December 6, 1990—*i.e.*, the period during which Iraq expressly prevented diplomats and staff members of the U.S. Embassy in Kuwait from leaving Kuwait and Iraq; and (iii) from the December 6th announcement authorizing all remaining foreign nationals in Kuwait and Iraq to leave until Claimant's departure on December 9, 1990.<sup>19</sup>

From August 2, 1990, until August 7, 1990, Iraq prevented Claimant from leaving Kuwait. During this period, Iraq made no formal distinction between diplomatic personnel such as Claimant and other U.S. nationals, who, as we have previously recognized, were threatened with immediate seizure and forcible detention.<sup>20</sup> Although

some foreign nationals did manage to leave Kuwait and/or Iraq during this period, Claimant could not reasonably be expected to have escaped.<sup>21</sup> Iraqi authorities were forcibly detaining foreign nationals (including U.S. nationals) in Kuwait, relocating many to Baghdad against their will.<sup>22</sup> Claimant understandably had, as the United Nations Compensation Commission has put it, a "manifestly well-founded fear" of being killed or forcibly detained if he had left the embassy.<sup>23</sup> The Commission has previously recognized that for the purposes of the legal standard applicable here, putting Claimant in this situation in effect amounts to detention.<sup>24</sup> Iraq thus detained Claimant from August 2, 1990, to August 7, 1990.

Between August 7, 1990, and December 6, 1990, Iraqi authorities adopted various policies that prevented Claimant and other U.S. diplomats and embassy staff accredited to the Kuwait Embassy from leaving Kuwait or Iraq.<sup>25</sup> As the Commission has previously recognized, Iraq did not extend assurances that the U.S. government believed to be sufficiently credible to allow Kuwait Embassy staff members and their dependents to depart until August 22, 1990.<sup>26</sup> Iraqi authorities subsequently reneged on those commitments on or around August 24, 1990, before adopting a policy that prohibited the departure of Kuwait Embassy staff and their dependents from Iraq and Kuwait as long as the U.S. Embassy in Kuwait remained open.<sup>27</sup> While the U.S. was able to negotiate the release of some dependents on or around August 25, 1990, Iraq refused to release any of the Kuwait Embassy staff members who were confined in the Baghdad or Kuwait

embassies until announcing the release of all foreign nationals on December 6, 1990.<sup>28</sup> Thus, for Claimant, the policy of prohibiting Kuwait Embassy staff members from leaving Iraq and Kuwait lasted until December 6, 1990, when the Iraqi government announced that all remaining foreign nationals in Kuwait and Iraq could leave.<sup>29</sup>

Although Claimant may have been legally permitted to leave Iraq on December 6, 1990, his detention did not end on that date. As the Commission has previously recognized, a claimant's detention ends only on the date that he is released from the control of the person or entity that detained him.<sup>30</sup> Any attempt "[by the perpetrator] to restrict [the] movements" of a claimant establishes control,<sup>31</sup> whereas a claimant who has a reasonable opportunity to leave the site of his or her captivity is deemed no longer to be under the perpetrator's control.<sup>32</sup>

Under this standard, Claimant remained under Iraq's control until December 9, 1990. The Commission has previously held that Iraq imposed conditions on air travel that limited the ability of foreign nationals, including U.S. nationals, to leave Iraq and/or Kuwait in December 1990.<sup>33</sup> Indeed, the available evidence indicates that Claimant left Iraq at the first reasonable opportunity after the December 6th announcement, on a U.S. government-chartered flight that left Iraq on December 9, 1990. Because there is no evidence that he remained voluntarily in Iraq at any time during this period, we conclude that he was under Iraq's control and thus continued to be detained from December 6, 1990, to December 9, 1990.

In sum, Iraq detained Claimant from August 2, 1990, until December 9, 1990.

(b) Threat: The Iraqi government threatened Kuwait Embassy staff members, diplomats, and dependents with continued detention. This included Claimant. Iraqi authorities made clear that Embassy staff members, diplomats, and dependents would not be permitted to leave, notwithstanding Iraq's sporadic and unreliable statements to the contrary during Claimant's period of detention.<sup>34</sup>

In short, the Iraqi government made an unequivocal threat to continue to detain Kuwait Embassy staff members in Kuwait and Iraq. Claimant was a U.S. Marine employed at the U.S. Embassy in Kuwait at the time. Claimant has thus established that Iraq threatened to continue to detain him.

(c) Third party coercion: The reason Iraq detained Claimant and threatened him with continued detention was to compel the United States government to act in a certain way as an explicit and/or implicit condition for his release. Iraqi authorities informed the United States that before it would release detained diplomats, embassy personnel, and their dependents, it wanted the United States to close its embassy in Kuwait.<sup>35</sup> Indeed, at the time, the U.S. government itself understood Iraq's actions to be hostage-taking.<sup>36</sup>

In sum, this claim meets the standard for hostage-taking within the meaning of the 2014 Referral. Iraq held Claimant hostage in violation of international law for a period of 130 days, and Claimant is thus entitled to compensation.

## COMPENSATION

Having concluded that the present claim is compensable, the Commission must next determine the appropriate amount of compensation.

In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission held that successful claimants should be awarded compensation in the amount of \$150,000 plus an additional \$5,000 for each day the claimant was in captivity.<sup>37</sup> Therefore, for the 130 days Iraq held Claimant hostage, he is entitled to an award of \$800,000, which is \$150,000 plus (130 x \$5,000). This amount constitutes the entirety of the compensation to which Claimant is entitled under the Claims Settlement Agreement.

The Commission hereby enters the following award, which will be certified to the Secretary of the Treasury for payment under sections 7 and 8 of the ICSA.<sup>38</sup>
