## PROPOSED DECISION

Claimant Estate brings this claim against the Republic of Iraq ("Iraq") alleging that Iraq held the decedent, William John Steinhoff, hostage in violation of international law in August 1990. Because the Estate has established that Iraq held Mr. Steinhoff hostage for four days, it is entitled to an award of \$170,000.

### BACKGROUND AND BASIS OF THE PRESENT CLAIM

Claimant Estate alleges that Mr. Steinhoff was living in Kuwait when Iraq invaded the country on August 2, 1990. It asserts that, beginning with the invasion and for approximately three days thereafter, Mr. Steinhoff was confined to an undisclosed location in Kuwait. Claimant Estate alleges that Mr. Steinhoff eventually escaped from Kuwait on August 5, 1990, by driving across the Kuwaiti desert to the Saudi border, and that he stayed

in Saudi Arabia for a week before flying home to the United States. Mr. Steinhoff died in September 2016.

Although neither Mr. Steinhoff nor Claimant Estate was among them, many of the U.S. nationals in Iraq and Kuwait at the time of the 1990-91 Iraqi occupation of Kuwait sued Iraq (and others) in federal court for, among other things, hostage-taking.<sup>1</sup> Those cases were pending when, in September 2010, the United States and Iraq concluded an *en bloc* (lump-sum) settlement agreement.<sup>2</sup> The Agreement, which entered into force in May 2011, covered a number of personal injury claims of U.S. nationals arising from acts of the former Iraqi regime occurring prior to October 7, 2004, including claims of personal injury caused by hostage-taking.<sup>3</sup> Exercising its authority to distribute money from the settlement funds, the U.S. Department of State provided compensation to numerous individuals whose claims were covered by the Agreement, including some whom Iraq had allegedly taken hostage or unlawfully detained following Iraq's 1990 invasion of Kuwait.

Under the International Claims Settlement Act of 1949 ("ICSA"), the Secretary of State has statutory authority to refer "a category of claims against a foreign government" to this Commission.<sup>4</sup> The Secretary has delegated that authority to the State Department's Legal Adviser, who, by letter dated October 7, 2014, referred three categories of claims to this Commission for adjudication and certification.<sup>5</sup> This was the State Department's second referral of claims to the Commission under the Claims Settlement Agreement, the

first having been by letter dated November 14, 2012 ("2012 Referral" or "November 2012 Referral"). <sup>6</sup>

One category of claims from the 2014 Referral is applicable here. That category,

known as Category A, consists of

claims by U.S. nationals for hostage-taking<sup>1</sup> by Iraq<sup>2</sup> in violation of international law prior to October 7, 2004, provided that the claimant was not a plaintiff in pending litigation against Iraq for hostage taking<sup>3</sup> at the time of the entry into force of the Claims Settlement Agreement and has not received compensation under the Claims Settlement Agreement from the U.S. Department of State. . . .

On October 23, 2014, the Commission published notice in the *Federal Register* announcing the commencement of the second Iraq Claims Program pursuant to the ICSA and the 2014 Referral.<sup>7</sup>

On October 23, 2015, the Commission received from Claimant Estate a completed Statement of Claim seeking compensation under Category A of the 2014 Referral, together with exhibits supporting the elements of its claim.

#### DISCUSSION

## **Standing**

As an initial matter, the Commission has reviewed the Domiciliary Letters, issued on March 16, 2017, by the Circuit Court of Racine County, Wisconsin, appointing Karen Bauman administrator of Mr. Steinhoff's estate. Based on this review, the Commission finds that the ESTATE OF WILLIAM JOHN STEINHOFF, DECEASED; KAREN BAUMAN, ADMINISTRATOR, is the proper claimant in this claim.

### Jurisdiction

This Commission's authority to hear claims is limited to the category of claims referred to it by the United States Department of State. The Commission's jurisdiction under the "Category A" paragraph of the 2014 Referral is limited to claims for hostagetaking of (1) "U.S. nationals," provided that the claimant (2) was not a plaintiff in any litigation against Iraq for hostage taking pending on May 22, 2011 (the "Pending Litigation"), and (3) has not received compensation under the Claims Settlement Agreement from the Department of State. 2014 Referral at ¶ 3.

### *Nationality*

This claims program is limited to claims of "U.S. nationals." Here, that means a claimant must have been a national of the United States when the claim arose and continuously thereafter until May 22, 2011, the date the Agreement entered into force. Claimant Estate satisfies the nationality requirement. It has provided a copy of Mr. Steinhoff's U.S. birth certificate, which shows that he was a U.S. national at the time of the alleged hostage-taking (August 1990). It has also provided a copy of Mr. Steinhoff's cancelled U.S. passport valid from 1995 to 2005, as well as a copy of his Report of Death of a U.S. Citizen or Non-Citizen National Abroad, evidencing his death in September 2016, which establishes that he remained a U.S. national through the effective date of the Claims Settlement Agreement.

## No Pending Litigation

Additionally, Category A states that the claimant must not have been a plaintiff in any of the so-called Pending Litigation cases at the time of the entry into force of the Claims Settlement Agreement. Footnote 3 of the 2014 Referral specifically lists the Pending Litigation cases for purposes of the Referral. Claimant Estate, through its administrator, has averred under oath in a January 2018 declaration, and the pleadings in the cases cited in footnote 3 confirm, that neither Mr. Steinhoff nor his estate was a plaintiff in any of those Pending Litigation cases. The Commission thus finds that Claimant Estate has also satisfied this element of its claim.

# No Compensation under the Claims Settlement Agreement from the Department of State

Claimant Estate also satisfies the final jurisdictional requirement. Karen Bauman, the administrator of Mr. Steinhoff's estate, has stated that Mr. Steinhoff never "receive[d] any compensation under the [Claims Settlement Agreement] from the Department of State." Further, we have no evidence that the State Department has provided Mr. Steinhoff or his estate any compensation under the Claims Settlement Agreement. Therefore, Claimant Estate meets this element of its claim.

In summary, this claim is within the Commission's jurisdiction pursuant to the 2014 Referral and is entitled to adjudication on the merits.

#### Merits

### Factual Allegations

Claimant Estate asserts that Iraq held Mr. Steinhoff hostage from August 2, 1990, until August 5, 1990, a total of four days. It states that he was living in Kuwait working as a private contractor when Iraq invaded Kuwait on August 2, 1990. In a declaration submitted by Mr. Steinhoff's supervisor in support of this claim, the supervisor asserts that he spoke with Mr. Steinhoff by phone the morning of the invasion, although he did not speak with him again until both had returned to the United States. He does, note, however, that on August 5, 1990, he "learned of an order instructing Iraqi troops to arrest American citizens[,]" and he subsequently asked "a group of third party nationals to visit Bill's residence on the morning of August 6th." They reported that "Bill was neither at his home nor anywhere to be found."

According to a declaration submitted by Mr. Steinhoff's sister, Karen Bauman, Mr. Steinhoff told Ms. Bauman upon his return to the United States that "he and a friend had managed to escape by car into Saudi Arabia on or about August 5, and stayed in Riyadh

for over a week" before returning to the United States. Mr. Steinhoff's former supervisor confirms this, noting that Mr. Steinhoff later told him that he had fled his home, driven across the desert, and crossed the border into Saudi Arabia on August 5, 1990. While, in the Statement of Claim completed before his death, Mr. Steinhoff alleged that he escaped to Saudi Arabia on August 8, 1990, Claimant Estate's counsel subsequently amended the claim to assert a departure date of August 5.

## Supporting Evidence

Claimant Estate has supported its claim with, among other things, a sworn statement from Karen Bauman, dated January 31, 2018, noting her brother's presence in Kuwait at the time of the invasion and describing his escape into Saudi Arabia as he explained it to her after his return to the United States; several news articles, including an article from the *Burlington Standard Press*, said to be from August 22, 1990, that describes Mr. Steinhoff as "one of the lucky Americans who was able to get out of Kuwait before invading Iraqi troops began rounding up Western citizens"; <sup>11</sup> a sworn statement from Mr. Steinhoff's then-supervisor, dated December 22, 2017, also noting Mr. Steinhoff's presence in Kuwait at the time of the invasion and detailing his recollection of Mr. Steinhoff's experience after they reunited in the United States on August 16, 1990, including Mr. Steinhoff's statement to him at the time that he fled Kuwait on August 5, 1990; and a copy of the supervisor's then-valid U.S. passport, which contains *inter alia*, a Kuwaiti entry stamp dated June 5, 1990, a Saudi entry visa dated August 12, 1990, a Saudi entry ytamp with the entry date of the 12th visible (month and year not visible), a Saudi

exit stamp dated August 15, 1990, <sup>12</sup> and a U.S. entry stamp from Chicago, Illinois, dated August 16, 1990.

Claimant Estate has also submitted a number of documents that provide background about the broader geopolitical situation during the First Gulf War in 1990-91, including some that relate specifically to the circumstances faced by U.S. nationals in Iraq and Kuwait at the time. These documents include statements from U.S. and Iraqi officials, resolutions of the United Nations Security Council, newspaper articles, a report from Amnesty International on human rights violations committed by Iraq in 1990, unclassified cables and a memorandum from the U.S. Department of State, and affidavits submitted in a lawsuit brought by other U.S. nationals who were also in Kuwait or Iraq during the First Gulf War.

## Legal Standard

To make out a substantive claim under Category A of the 2014 Referral, a claimant must show that (1) Iraq was engaged in an armed conflict and (2) during that conflict, Iraq took the claimant hostage. <sup>13</sup> The Commission has previously held that, to establish a hostage-taking claim, a claimant must show that Iraq (a) seized or detained the claimant and (b) threatened the claimant with death, injury or continued detention (c) in order to compel a third party, such as the United States government, to do or abstain from doing any act as an explicit or implicit condition for the claimant's release. <sup>14</sup> A claimant can establish the first element of this standard by showing that the Iraqi government confined

the claimant (or, in this case, the Claimant Estate's decedent) to a particular location or locations within Iraq or Kuwait, or prohibited the claimant from leaving Iraq and/or Kuwait. 15

## Application of Standard to this Claim

(1) Armed Conflict: Claimant alleges that Iraq took him hostage in Kuwait on August 2, 1990, and held him hostage for four days, until August 5, 1990, when he escaped to Saudi Arabia. In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission held that during this entire period, Iraq was engaged in an armed conflict with Kuwait.<sup>16</sup> Thus, Claimant satisfies this element of the standard.

(2) <u>Hostage-taking</u>: To satisfy the hostage-taking requirement of Category A of the 2014 Referral, Claimant Estate must show that Iraq (a) seized or detained the decedent and (b) threatened him with death, injury or continued detention (c) in order to compel a third party, such as the United States government, to do or abstain from doing any act as an explicit or implicit condition for his release. Claimant satisfies this standard for the four-day period from August 2, 1990, to August 5, 1990.

(a) <u>Detention/deprivation of freedom</u>: From August 2, 1990, until Claimant escaped to Saudi Arabia on August 5, 1990, Iraq confined Claimant to Kuwait by threatening all U.S. nationals with immediate seizure and forcible detention. <sup>17</sup> Although some foreign nationals did manage to leave Kuwait and/or Iraq during this period, Claimant could not reasonably be expected to have escaped. <sup>18</sup> Iraqi authorities were forcibly detaining foreign nationals (including U.S. nationals) in Kuwait, relocating many to

Baghdad against their will.<sup>19</sup> Claimant understandably had, as the United Nations Compensation Commission has put it, a "manifestly well-founded fear" of being killed or forcibly detained if he had made any attempt to leave the country.<sup>20</sup> The Commission has previously recognized that for the purposes of the legal standard applicable here, putting Claimant in this situation in effect amounts to detention.<sup>21</sup> Iraq thus detained Claimant from August 2, 1990, to August 5, 1990.

(b) Threat: In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission determined that the Iraqi government threatened U.S. nationals in Kuwait and Iraq numerous times with continued detention.<sup>22</sup> Both Iraqi President Saddam Hussein and the Speaker of Iraq's National Assembly Saadi Mahdi made clear that American nationals (as well as those from numerous other countries) would not have been permitted to leave Kuwait and/or Iraq at the time Claimant escaped to Saudi Arabia.<sup>23</sup> Claimant Estate has thus established that Iraq threatened to continue to detain Mr. Steinhoff.

(c) <u>Third party coercion:</u> The Commission has previously held that Iraq detained all U.S. nationals in Kuwait or Iraq at the time and threatened them with continued detention in order to compel the United States government to act in certain ways as an explicit and/or implicit condition for their release.<sup>24</sup> Iraq itself stated that it sought three things from the United States government before it would release the detained U.S. nationals; it wanted the United States (i) not to attack Iraq, (ii) to withdraw its troops from

Saudi Arabia; and/or (iii) to end the economic embargo imposed on Iraq.<sup>25</sup> Indeed, at the time, the U.S. government itself understood Iraq's actions to be hostage-taking.<sup>26</sup>

In sum, this claim meets the standard for hostage-taking within the meaning of the 2014 Referral. Iraq held Mr. Steinhoff hostage in violation of international law for a period of four days, and his Estate is thus entitled to compensation.

### **COMPENSATION**

Having concluded that the present claim is compensable, the Commission must next determine the appropriate amount of compensation.

In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission held that successful claimants should be awarded compensation in the amount of \$150,000 plus an additional \$5,000 for each day the claimant was in captivity.<sup>27</sup> Therefore, for the four days Iraq held Mr. Steinhoff hostage, his Estate is entitled to an award of \$170,000, which is \$150,000 plus (4 x \$5,000). This amount constitutes the entirety of the compensation to which Claimant Estate is entitled under the Claims Settlement Agreement.

The Commission hereby enters the following award, which will be certified to the Secretary of the Treasury for payment under sections 7 and 8 of the ICSA.<sup>28</sup>
