This matter having been opened to the Court by Paula T. Dow, Attorney General of New Jersey, by Eleanor Heck, Deputy Attorney General, as attorney for plaintiff, the Commissioner of Banking and Insurance, Liquidator of MIIX Insurance Company (the "Liquidator"), on application for an Order that extends the date by which all claims against MIIX Insurance Company must be asserted by one year -- from April 9, 2010 to April 11, 2011 -- with proper notice having been given to all interested parties; and the Court having considered the Liquidator's application as well as any opposition thereto; and for good cause shown,

IT IS on this 7<sup>th</sup> day of April, 2010;

ORDERED that the Liquidator's motion be and hereby is granted; and it is further

ORDERED that the bar date for the assertion of claims against MIIX is extended for one year, and that all claims against MIIX (with the exception of "Excluded Claims" as defined herein) must be asserted no later than April 11, 2011, or such claims will be forever barred against MIIX; and it is further


ORDERED that the bar date for the assertion of "Excluded Claims" against MIIX remains April 9, 2009; and it is further

ORDERED that "Excluded Claims" means:

- a) insurance coverage claims of MIIX policyholders with respect to their contract rights arising out of the terms and conditions of the insurance policies held by them; and
- b) claims of current and former employees for compensation;

and it is further

ORDERED that a copy of this Order be served on all interested parties within 30 days of the entry of this order.
