Background and Purpose

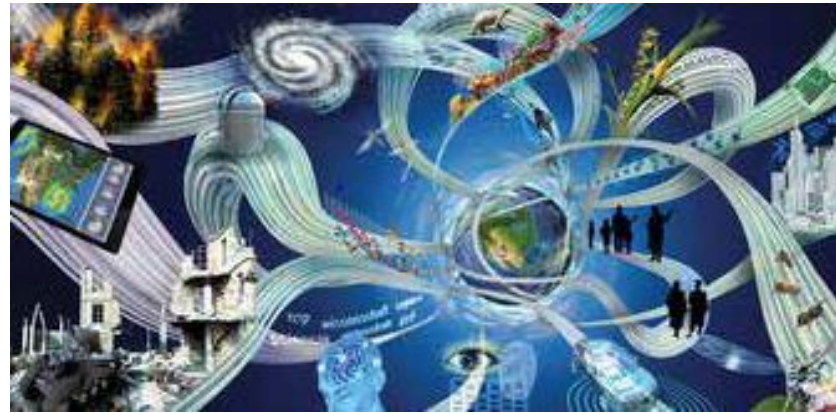

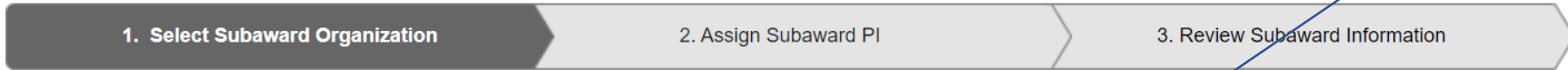

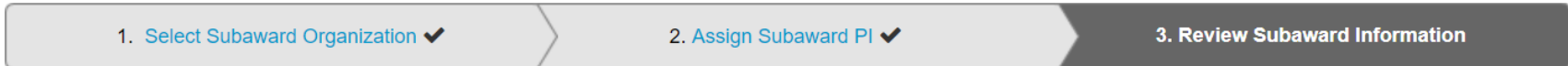
