ADOPTING A MITIGATED NEGATIVE DECLARATION

SKYVIEW TERRACE ASSOCIATES'  
SKYVIEW TERRACE MOBILE HOME PARK  
PLACER COUNTY

WHEREAS, the Regional Board proposes to adopt Waste Discharge Requirements for the disposal of wastewater to land in Placer County; and

WHEREAS, the Regional Board is the lead agency for this project under the California Environmental Quality Act and has conducted an Initial Study in accordance with Title 14, California Code of Regulations, Section 15063, entitled *Guidelines for the Implementation of the California Environmental Quality Act*; and

WHEREAS, mitigation measures identified in the Mitigated Negative Declaration will reduce potentially significant impacts to a less than significant impacts; and

WHEREAS, copies of the Initial Environmental Study and proposed Mitigated Negative Declaration were transmitted to or made available to all agencies and persons known to be interested in these matters; and

WHEREAS, the Regional Board received no comments regarding the proposed project, Initial Environmental Study, or proposed Mitigated Negative Declaration. The Regional Board received comments from the Discharger on the tentative Waste Discharge Requirements. These comments have been considered and addressed; and

WHEREAS, the mitigation measures will be included in the proposed Waste Discharge Requirements; and

WHEREAS, the Regional Board considered all testimony and evidence at a public hearing held on 19 July 2002 in Sacramento, California and good cause was found to approve the Initial Study and adopt a Negative Declaration;
