**Discharger and Tentative Order Information**

The City of Yuba City (Discharger) is the owner and operator of the Wastewater Treatment Facility (Facility), located at 302 Burns Drive Yuba City, CA 95991. The Discharger provides sewerage service for the City of Yuba City and serves a population of approximately 53,000. In addition, the Facility accepts septage from unsewered portions of Sutter and Yuba Counties. The design average dry weather flow capacity of the Facility is 10.5 MGD. The Facility provides treatment to municipal and industrial wastewater and discharges secondary treated effluent, primarily to the Feather River via a side-bank discharge at Discharge Point 003 or a yet to be constructed multiport diffuser at Discharge Point 004. The existing multiport diffuser at Discharge Point 001 is rarely used due to a discharge prohibition requiring the diffuser be submerged 0.8 feet so adequate dilution can be achieved. The Facility discharges chlorinated, secondary treated effluent to disposal ponds, Discharge Point 002, within the levee on the eastern side of the Feather River while conducting maintenance at one of the other discharge points.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2019-0017-01, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 8 February 2019 and amended on 7 June 2019. An Order is proposed to renew the NPDES permit. The tentative Order includes more stringent effluent limits for copper and new effluent limitations for cyanide, bis(2-ethylhexyl) phthalate, and chronic toxicity. A compliance schedule and interim effluent chronic toxicity limitations are included in the tentative Order to bring the discharge in compliance with the new effluent limits. The tentative Order retains the ammonia effluent limitations from Order R5-2019-0017-01 and requires the Discharger to conduct an ammonia assessment to evaluate the Facility's discharge of ammonia. The tentative Order also includes additional groundwater monitoring, reporting, and studies along with increased disposal pond monitoring and reporting.

### **Nature and Purpose of Hearing**

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Order. This proceeding will be a formal adjudicatory proceeding. ### **Prehearing Submission of Written Comments and Evidence**

The **Discharger** is a party to this proceeding. As a party, the Discharger must submit written evidence or comments, if any, for the Board to consider no later than 5:00 p.m. on **26 July 2024** to the Central Valley Water Board email at [RB5S-NPDES-Comments@waterboards.ca.gov](mailto:RB5S-NPDES-Comments@waterboards.ca.gov).

**Interested persons** include any non-party that is interested in the outcome of the hearing. Interested persons wishing to comment, in writing, on the tentative Order shall submit comments no later than 5:00 p.m. on **26 July 2024** to the Central Valley Water Board email at [RB5S-NPDES-Comments@waterboards.ca.gov](mailto:RB5S-NPDES-Comments@waterboards.ca.gov).

Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

### **Requesting Party Status**

Persons who wish to participate in the hearing as a party must submit a request in writing no later than 5:00 p.m. on **26 July 2024** to the Central Valley Water Board email at [RB5S-NPDES-Comments@waterboards.ca.gov](mailto:RB5S-NPDES-Comments@waterboards.ca.gov). The request must include facts demonstrating how the person will be substantially affected by the proceeding.

The Board Chair will not designate a person as a party if the Board Chair determines the designation will impair the interests of justice and the orderly and prompt conduct of the proceeding. The Board Chair, when granting a request for party status, may impose restrictions on the requestor's hearing participation, including limiting or excluding the use of cross-examination and other procedures to promote the orderly and prompt conduct of the proceeding.

### **Visual Presentations**

Hearing participants may use PowerPoint or other visual presentations at the hearing, but the presentation content shall not exceed the scope of previously submitted written material. Presentations, if any, must be provided to the below Central Valley Water Board Contact by 12:00 p.m. on **15 October 2024**.

### **Hearing Procedure and Time Limits**

The hearing on the tentative Order will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** will be advised in advance of the hearing of the total amount of time allocated for the presentation and closing statement. The Discharger is invited to contact staff in advance of the hearing to discuss how much time it believes is necessary.

**Interested persons** may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.

### **Hearing Accommodations**

The hearing facilities will be accessible to persons with disabilities.
