### **PUBLIC NOTICE: PROPOSED CLEANUP PROGRAM SITE CASE CLOSURE**

**PUBLIC COMMENT PERIOD:** August 9, 2024 through October 8, 2024

#### **VALLEY TRUCK AND TRACTOR - ROBBINS (T10000019857) 17698 HIGHWAY 113, ROBBINS, SUTTER COUNTY**

In 1988, one 500-gallon gasoline UST was removed from this property. In 1989, one 500-gallon waste oil UST was closed in place and remains on the property. In 2021, Valley Truck and Tractor, as part of the sale of the property, conducted a Phase I/II environmental site assessment. BB&A Environmental (BB&A), the professional consultant for Valley Truck and Tractor, determined the former USTs had leaked gasoline and diesel fuel. August 9, 2024 through October 8, 2024

BB&A completed additional testing of soil and groundwater beneath the property. Based on those tests, BB&A found that only groundwater was currently contaminated by the gasoline and diesel fuel leaked from the former USTs. BB&A tested groundwater and found out how far diesel fuel and the gasoline additive methyl tertiary butyl ether (MTBE) had traveled in groundwater. BB&A also found that the levels of diesel fuel and MTBE in groundwater were declining. Cleanup of the diesel fuel and MTBE was not needed. Diesel fuel and gasoline contamination leaked to soil and groundwater had been cleaned up by natural processes, and contaminant levels are below human health and environmental risk levels.

BB&A evaluated site data, determined the case meets the criteria for closure, and requested No Further Action Required. Central Valley Water Board staff agrees the case meets the criteria for closure. As part of the case closure process, Staff is providing the public with the opportunity to comment on the proposed closure of this case. This notice is being given to the owners and residents around the subject property, other interested groups, and the public. If you want to comment on the proposed closure of this case, please contact the Central Valley Water Board by using the contact information provided below before the end of the comment period. A site map of the property showing how far MTBE and diesel fuel traveled in groundwater is provided at the end of this memo.
